1. Question: Is the Town requiring an Environmental Pollution Insurance (page 64)?

Answer: Confirming that the Town does require environmental pollution insurance as stated on page 64.

2. **Question:** Bid item #8 indicates (9) "Furnish and Install Ditch Bottom Inlet Type C" however the plans account for (11) not (9). Please clarify the correct quantity.

Answer: Bid Item #8 should include (11) "Furnish and Install Ditch Bottom Inlet Type C".

3. **Question:** Bid item #10 indicates (1) "Furnish and Install Ditch Bottom Inlet Type F" work element #4 however we cannot find this item on the plans. Please indicate where this item is.

Answer: There is no "Type F Inlet" proposed as part of work element #4. Therefore, Bid Item #10 should be excluded from the Bid Schedule. Please utilize newly attached bid schedule on page 2 of this addendum for work element 1,3,4,5.

4. **Question:** Plan page CP-102 work element #3 shows a Type D Inlet #5 with PRB (baffle) on west invert however this item is not listed on the bid items. Please confirm if this item is to be included and where.

Answer: Please see detailed response in addendum 2, question 4, issued on April 16, 2019.

5. **Question:** Please provide soil report for the project.

Answer: There is no soil report available for this project.

6. **Question:** For Work Element #1, 3, 4, 5, bid item #15 indicates 333 s/y of "Pavement Restoration", since this item is for driveway / road restoration is it possible to keep the areas with lime rock in place and complete all the asphalt patching at one time?

Answer: If base course is to be exposed to general traffic prior to final asphalt surface being applied, the cover material shall comply with section 300-2.2 of the standard specifications.
