## 7. Council Member Comments

Vice Mayor Jablonski thanked the Sunshine Ranches Homeowner's Association and the Rolling Oaks Civic Association for the holiday programs they held. He thanked Town Financial Administrator Sherwood, along with his staff, for the receipt of the CAFR (Comprehensive Annual Financial Report) award. Vice Mayor Jablonski advised the public of upcoming repaving roadwork on I-75. He mentioned the Holiday Lights Contest was a big success. Vice Mayor Jablonski stated he was working on republishing a guide on a streamlined Level One Fill permit process with Town Attorney Poliakoff. He reminded the public to please be considerate of their surroundings when shooting fireworks on New Year's Eve because the animals get very spooked and could hurt themselves. He congratulated Selena Hodgers for receiving her Doctorate degree in nursing. Last, Vice Mayor Jablonski spoke about considering Code Enforcement becoming more proactive since anonymous complaints are no longer legal. He would like the Town Council to think about his suggestion and bring back for discussion later.

Council Member Kuczenski echoed Vice Mayor Jablonski's concern's regarding the anonymous code reporting legislation. He congratulated Selena Hodgers for obtaining her Doctorate degree as well. Council Member Kuczenski provided an update on the Southwest Ranches Founders Park wall. He also spoke about a glacier off the coast of Antarctica that will break off in five years, which concerned him, because the ice mass will dissipate into North America's oceans and it could put South Florida underwater. He stressed to the Town Council and the public, that the future of the Town could be at stake regarding flooding. He spoke about adding Hunter Lane to the government infrastructure plan to get funding to fix the road. He talked about a light pole that was installed by Florida, Power & Light (FPL) that obstructs a horse path. He mentioned it to Town

Administrator Berns, and the pole was relocated in less than ten (10) days. Last, he spoke about legislation that was pending in Tallahassee that would allow a business to sue a municipality for damages if the municipality acts or amends an ordinance or charter that will cause at least 15% reduction of revenue or profit. He is very concerned and would like the Town Council to draft a Resolution that would oppose the legislation. Mayor Breitkreuz felt it was a great recommendation.

Council Member Allbritton thanked his fellow Council Members and the Town Staff for all he has learned since being elected and he is looking forward to the upcoming year. He is also looking forward to the start of the Public Safety and Traffic Committee and resident input. Council Member Allbritton wished everyone a very happy holiday.

Council Member Hartmann spoke about the Aster Knight Parks Foundation Chili Fest and Car Show. He felt as though it was the largest turnout the event had ever had. He talked about the Rolling Oaks Civic Association (ROCA) holiday event with Santa Claus and how nice the event was. Next he spoke about the Sunshine Ranches holiday party and how wonderful that event was as well. Council Member Hartmann spoke about the Holiday Lights Contest and urged the residents to participate in the 2022 contest. Council Member Hartmann also echoed Vice Mayor Jablonski's sentiments regarding the change in the anonymous code violation reporting. He spoke about federal money for transportation and infrastructure and how the funds get applied. Last, Council Member Hartmann congratulated Selena Hodgers on receiving her Doctorate degree and he wished everyone a happy holiday.

Mayor Breitkreuz spoke about all the wonderful events that had been mentioned previously by the Town Council. He stated how happy it made him to see all the families out and about enjoying the Town events. He congratulated Selena Hodgers on her Doctorate Degree as well. He advised the Town received its recertification for the National Wildlife Federation and he congratulated Parks, Recreation and Open Space Manager December Lauretano-Haines. Mayor Breitkreuz thanks Vice Mayor Jablonski and Council Member Allbritton for representing the Town Council at a Broward County event. Mayor Breitkreuz wished everyone a happy holiday and recounted a story regarding the Town's financial history and what a wonderful job Town Financial Administrator Sherwood had done to restore the Town's financial health. Mayor Breitkreuz then announced Town Financial Administrator Sherwood's retirement. He thanked Town Financial Administrator Sherwood for all he had done for the Town.
