WELCOME



Our new vendor for household garbage, recycle and bulk.

Waste Management (now known as "WM") will become the environmental services provider for Southwest Ranches beginning October 1st.

Your collection days for Garbage WILL NOT change. Your collections day for Recycling and Bulk Trash MAY change.

Beginning in mid-September, you will receive a new, 96-gallon green cart for garbage along with an informational packet in the mail. **Do not use this cart until October 1st when WM begins its automated service.**

Please refer to the informational packet and included magnet to know your Recycling Collection Day (which will be your second garbage collection day of the week) along with your every other week Bulk Collection Day and bulk trash guidelines.

Beginning Saturday, October 1st, your garbage should be bagged and placed inside your new green cart. Garbage outside your cart or in another container WILL NOT be collected. Recycling should be loose (not bagged) and placed in your regular recycling container.

There is much to cover this month,

but first a heartfelt thank you to two equestrian families that responded to my request for halters for Davie Police to use when they respond to loose-horse calls. Nancy Unger Fink from Condee Farm on Thoroughbred Lane and Lorena Kaelber from LK Equestrians at Hancock Road and East Palomino donated two halters each for the police to use when they round up loose horses. Thank you again!

At the July 28 meeting, the Town Council awarded the Solid Waste, Recyclables, and Bulk Waste Collection and Disposal Franchise Agreement, to Waste Management Inc. (WM). Ccollection services will begin on October 1, 2022.

The selection process began with the Council holding a Saturday workshop last spring to collect feedback on resident expectations for a new trash, recycling, and bulk collection contract. The attendees made it clear that the frequency of pickup, as it stands today, for all three services is most important. There was consensus to move from manual pickup using garbage pails to automated pickup using 96-gallon solid waste carts (same style as our present recycling carts), if there was benefit over our present garbage pail method. The attendees made it clear that the hauler must be held accountable for bulk pile cleanup after collection and swift repair to any lawn damage.

With this feedback the Town, according to its procurement code laws, developed a request for proposals (RFP) and held a proposal mandatory meeting in April, with nine haulers in attendance. Two pricing scenarios were requested in the RFP responses. The scoring formulas for service and pricing were also provided in the RFP. When switch to automated pickup was examined, it was suggested that the industry was moving from manual pickup to automated for a few reasons: convenient and easy method for residents to dispose of trash; wheeled containers are easier, more maneuverable, and safer for residents because there is no carrying or lifting of heavy trash cans; the capacity of most cans provided in these programs



is equal to three or four regular trash cans; the containers keep wildlife and pets out of trash given the tight lids; and collection costs will be higher than automated collection based on slower route service time, additional labor and vehicle costs. Thus, manual pickup was not considered in the bidding scenarios. Both scenarios used automated cart collection, the difference was frequency of solid waste and recycling collection as it is today in the first scenario, as compared to the costs of once-a-week for solid waste and every other week for recycling, so approximately ½ the collection service. Bulk would stay the same. Four proposals were received by the May deadline. Five selection committee members, made up of staff and external experts, (it's illegal for any Council Members to be involved in procurement selection process) evaluated and scored the proposals. The experts evaluated the pricing. Three evaluation criteria were used: hauler's experience, qualifications, and prior performance, next their equipment, personnel, technical approach, and implementation plan and finally the price.

A quick note on chasing the lowest price. The Town's last two contracts were with the lowest bidder. The first was a startup company, who offered the lowest price, that the Town took a risk on and speaking as a resident the service was terrible for most of the contract duration.

One of the partners sold their routes to WM, the other went out of business and they are still in court. Concerning the current provider, again the lowest cost bidder, speaking as a resident, service has been worse. As a Council Member, the number one complaint I get, is on these services. When I bring brought complaints back to the vendor, before the pandemic, their response was, they cannot get drivers. During the pandemic, it was the pandemic, and now, again they cannot get drivers. My thought is that they underbid our fixed price contract to get the work, fuel has skyrocketed, inflation is taking its toll on them, and after the pandemic they cannot find drivers at a rate they can pay and stay in business.

This time, given the selection criteria used and price being 35% of the weighting, we expect a different outcome. The service aspect weighting shows WM with a score of fifty-seven out of sixty-five and the lowest price bidder scored a thirty-three on service, the lowest score of the four bidders.

Concerning the two pricing scenarios mentioned above, with the first being our current service and the second scenario supplying half the number of pickups, except bulk which would remain the same at every other week, the price difference is quite marginal. The average for all the companies between the two

scenarios is a difference of \$6.56 per month. The lowest difference was \$4.18 for the lowest cost bidder, WM is \$7.11, and the highest price bidder is \$13.75 per month difference. The reason the margin is so narrow between the two scenarios is the fees paid to dump the trucks (tipping fees) at the solid waste facility or transfer station do not change. People will put out the same amount of trash regardless of the number of pickups. The number of carts supplied doesn't change; the number of stops on the route is the same, the number of pickups to service the Town is cut in half, so labor cost is half and fuel is half, however, the largest cost is tipping fees, which won't change between the two scenarios. So, with respect for our resident priorities noted above and the marginal difference in price between the two scenarios, our current frequency of pickups will remain the same and WM has committed to do their best to keep the same pick-up days we currently have.

The weighted scoring for price gave the lowest priced provider thirty-five points, the highest cost vendor scored twenty-two points, and WM thirty points. WM was selected because, in this competitive RFP, they score significantly higher than the others in service and second in price receiving 87-points total. The highest bidder of the four came in over \$50 a month higher than WM, while the lowest bidder priced its bid \$11.72 lower than WM.

I have been cautious about providing monthly cost per household figures because the final costs for your solid waste fee also includes bulk, which is dependent on the size of your property, and the Council has not had our budget workshop or budget hearings, so the solid waste fees associated with this new contract have not been agreed by the Council.

The Town Administration team is working in partnership with WM on the transition and communications plan that will be used to implement the new services and inform our neighbors and local businesses on what to expect and when things such as when new carts will be delivered to each home. Information will be provided in this issue of the Rancher, on the Town website and along with the new carts when they are delivered. For future reference, please keep this issue of the Rancher and the documentation and refrigerator magnet provided with the new carts.

Finally, my term ends in November, and I am seeking re-election. It's been an honor and pleasure to serve you. I am always here to help! If I can assist with any questions or Town issue, or you would just like to have a chat, please call me.

Meeting:

- **Adopted Resolution 2022-072** approving the preliminary fire assessment rate for Fiscal Year 2023.
- **Adopted Resolution 2022-073** approving the initial solid waste assessment rate for Fiscal Year 2023.

Brief legislation from the August 11, 2022 Town Council Regular Meeting:

- **Adopted Resolution 2022-013** creating a new Rural Residential Zoning District with minimum plot size requirement of 2.5 net acres (RR-A).
- **Adopted Resolution 2022-074** approving the third amendment to the settlement agreement between Broward County and the settling municipalities pertaining to solid waste service.

Howdy Folks,

As we enter September, we find ourselves in the middle of the 2022 Hurricane season. Review your hurricane checklist, or make plans for leaving early if a major storm heads our way. That being said, the Town has CodeRED, which is an internet based manner of communication to alert residents of time-sensitive information, emergencies, or urgent notifications. To receive these messages, you have to register to the CodeRED system. Upon entering your information, you will be provided with information such as evacuation notices, missing persons, inclement weather advisories, and more. If you plan to leave, as from personal experience do not wait until the last minute. When Hurricane Irma

came through, I decided to leave once Irma was a Category 3. Unfortunately, when we arrived on I-75 north of Wildwood, the highway was clogged with so much traffic that I was able to stop and frequently walk on to I-75. My suggestion is to plan early and stick to your plan.

September will also bring the Town's budget hearings. While we have an advantage of rising home values, and a very likely reduction in the Ad Valorem part of the Town's budget, the increases of public safety and solid waste will likely prevent a large reduction of your out of pocket end of year Town-related taxes. On the bright side, despite the increases with these contracts, your Ad Valorem taxes will not increase. I will continue to fight for a less expensive government for our Town.

Next, the Comprehensive Plan Advisory Board has been reviewing and updating the text of the Comprehensive Plan. During the July meeting, everyone learned that awhile back, under a prior Council, a broad amendment to the Town Code

eliminated the approved use of a Grooms' Quarters. Now, for some folks unaware of equestrian terminology, a Grooms' Quarters is living quarters for persons responsible for grooming and caring for horses boarded at the stable, and they are typically attached to the barn. Members of the Board expressed trepidation that the future use of a Grooms' Quarters was eliminated. I suggested during my Council Member comments that we need to re-enact the language to ensure that this use is continually protected. Basically, I believe that if we continue to chip away at the edges of what is essential to promote our equestrian community, it will not be long before we have as many horses as Plantation. (Plantation used to be an equestrian community before pavement and cement took over.) I wish to thank you for the honor of holding this office. As a Council Member, I work to help the entire Town. If you have a concern or complaint, drop a call to me. I may not answer immediately, but I strive to return my calls in 24-48 hours.

What will WM do if I have an oversize bulk pile?

WM will advise the homeowner of the overage. If the resident agrees then there are no issues, and the homeowner will be billed accordingly.

If the resident disagrees WM contacts Town staff. Town staff will meet on-site with WM and verify the size of the pile. If there is a disagreement, the pile size will be recalculated. If Town staff agrees on the overage, both WM and Town staff will coordinate with the homeowner.

If the homeowner does not want to pay the overage, the pile will not be collected at that time and the resident will be responsible for removing the pile from the right-of-way.

There is also a potential for the homeowner to only remove the overage amount and coordinate with WM to have the pile serviced at a later time.

If the resident fails to remove any or all the excess material, WM is ultimately responsible for picking up the pile and will do so based on the contract language.

If the homeowner fails to pay the overage invoice, the case will be forwarded to the Special Magistrate for consideration at a Town Code Hearing.

If my bulk pile is over the limit, how much will I be charged per cubic yard?

If your bulk pile is more than 12 cubic yards you will be charged \$35.90 per cubic yard.

What should residents do if they want another recycle cart?

Contact WM (954) 974-7500. An additional recycle cart is \$95.00.

What should residents do if they would like an additional 96-gallon garbage container?

Call Town Hall (954) 434-0008. Each additional 96-gallon solid waste container is \$100.00. There will also be a recurring annual fee of \$300.12 per each additional container to collect and dispose of the additional waste.

I would like a special bulk pick-up. Who do I call?

WM (954) 974-7500.

Who do I call about an illegal dump?

Contact Town Hall and call Davie Police Department (954) 693-8326 to file a Police Report.

Who do I call if there has been damage to my property? Example: fence or mailbox?

Call WM (954) 974-7500.

Will WM pick up black garbage bags outside of my 96-gallon garbage container?

No, all bags must fit inside the 96-gallon garbage container.

Will WM pick up black bags filled with vegetation?

Yes. Place the black bags filled with vegetation on the bulk pile.

STORMWATER MASTER PLAN WORKSHOP

First Public Involvement Workshop

The Town of Southwest Ranches is getting ready to prepare its Stormwater Master Plan and we want to hear from you!

Project Overview

The Town of Southwest Ranches is preparing a comprehensive Town-wide Stormwater Master Plan (SWMP) with the purpose of identifying opportunities to protect surface water quality and to reduce flooding throughout the Town's jurisdictional boundaries. The SWMP will include a Capital Improvement Plan (CIP) that addresses priority stormwater improvement projects throughout the Town. These proposed projects will be based on public input, observed flooding, roadway conditions, traffic volumes, and hydrologic and hydraulic analysis. The SWMP will also include the development of an Operation and Maintenance program with an annual budget to improve the condition and performance of both the Town's new and existing stormwater infrastructure.

The projects that will be identified in the SWMP will include capital improvement projects, localized drainage improvements, and the implementation of the recommended Operation and Maintenance program. Those efforts will enhance and improve the Town's stormwater infrastructure and flood resiliency.

The Town is ready to prepare a SWMP to examine the performance of the existing drainage system, the

effectiveness of the current

Operation and Maintenance program and identify viable capital improvement projects. The prioritized projects will aim to improve stormwater management and water quality throughout the Town. The SWMP will also review and address impacts associated with sea level rise, resiliency, and changes in the construction industry that should be reviewed and incorporated into the budgets for the stormwater program.

What to Expect

The first public involvement workshop will be held at Town Hall to obtain input from residents. The Town's Consultant will hold a presentation and be available to answer questions from the public. We encourage residents to not only provide their feedback, but to participate in this discussion.

AROUND THE TOWN

White-lined Sphinx Moth



"Know your native pollinators" is a series of articles that will help you identify and appreciate Florida's varied pollinators, including bees, wasps, butterflies, moths, beetles, flies, birds, and bats.

CLASSIFICATION

- Order: Lepidoptera
- Family: Sphingidae
- Species: *Hyles lineata*

FORAGING PREFERENCES

White-lined sphinx moths will forage on a wide variety of flowers. Their long tongues make them well-adapted to sip nectar from long-necked flowers, and they are common visitors of night-blooming flowers.

- Morning glory (*Ipomoea* spp.)
- Blazing star (*Liatris* spp.)
- Sages (*Salvia* spp.)
- Columbine (*Aquilegia* spp.)
- Coral honeysuckle (*Lonicera sempervirens*)
- Wild plumbago (*Plumbago zeylanica*)
- Thistle (*Cirsium* spp.)

DID YOU KNOW?

The common name "Sphinx moth" was given to this group because of their caterpillar's resting position. It sits with the front part of its body raised in the air, much like the Great Sphinx of Egypt.

ABOUT

White-lined sphinx moths can be found throughout the world, but are especially common in North America. They live in habitats ranging from desert to tropics, and feed on nectar from a variety of long-necked flowers.

Like most moths in this family, White-lined sphinx moths are fast fliers, clocking in at around 25 mph. They have triangular wings and thick bodies that taper to a point, much like a small jet. In addition to fast flight, these insects can hover in mid-air, and are frequently confused for hummingbirds when sipping nectar from flowers. Their powerful wings beat so quickly, they make a distinct humming sound. But don't let their bold features fool you. Despite their fast flight, exceedingly long tongues and sharply pointed bodies, these friendly insects cannot bite or sting.

ADULTS

White-lined sphinx moths have many common names including hummingbird moth, hawk moth, or just sphinx moth. Their large forewings feature a thick white stripe running from body to wingtip, while the smaller hind wings are bright pink.

Adults may be active any time of the day or night, but are most frequently spotted at dusk. At first glance, it's easy to mistake these large, hovering insects for hummingbirds. But if you look closely, you'll see the moth's long proboscis extended into the flower probing for nectar. Like hummingbirds, these sphinx moths will dart from flower to flower so quickly that they may not even take the time to roll their long tongue back up under their head between flower visits.

Adults will feed on a wide variety of flowers in their search for energy-rich nectar. They're long tongues are especially well-suited to feed from long, tubular flowers.

LARVAE

Caterpillars have a small horn on the last segment of their body, distinctive to the Sphingidae family. An adult moth can lay hundreds of eggs, and the developing larvae will feed on a wide variety of plants, trees, and shrubs. Although they are rarely considered garden pests, evening primrose (*Oenothera* spp.) is a particular favorite for this group.

When it's had enough to eat, the caterpillar will crawl from its food source and burrow into the soil to pupate. Most will overwinter there until they emerge as adults the following spring. Throughout most of North America, White-lined sphinx moths produce two generations a year. In warmer climates (like Florida), they may have more.

Through the National Wildlife Federation's Mayors' Monarch Pledge, our Town is committing to create habitat for the monarch butterfly and pollinators, and to educate residents about how we can make a difference at home and in our community.





Addressing Flooding in the Ranches

It's been an honor to serve the Town of Southwest Ranches. In my first term, I have successfully passed five pieces of legislation and have brought back millions of dollars to address our community's needs. Shortly after I was elected, we were hit by Tropical Storm ETA, which caused serious flooding

and trapped many in their homes. In response, I filed an Inland and Coastal Flood Control Funding Assessment bill, which I am proud to say became part of the Statewide Flooding Sea Level Resilience package and was signed into law by the Governor in 2021. That same year, I also secured funding for the South Broward Drainage District to purchase high capacity mobile storm water pumps. I secured \$355,000 for the Country Estates Drainage and Water Quality Improvement Project to construct a stormwater drainage collection system along SW 54th Place that ultimately ties into the South Broward Drainage District canal and floodgate that connects to the C-11 Canal. I also secured funding for a stormwater pump station in western Pembroke Pines for seepage management of water migrating from the Everglades Conservation Area 3A. This helps the Ranches and surrounding municipalities that are in the South Broward Drainage District.

The Central and Southern Flood Control Project is a regional flood protection system of more than 1,000 miles of canals, levees and water control structures throughout central and south Florida. The drainage systems for the Ranches and surrounding municipalities in South Florida are connected to this regional system. This system provides flood protection, prevents salt water intrusion to the fresh water aquifer, and protects our eco system. This system has proven to be very effective over the years, but it is 72 years old and is an aging system. In the summer of 2022, I began working with Broward County on a plan to upgrade and modernize the 18 flood control gates along the east coast of South Florida that are an integral part of this system. Most of the flood waters that are collected in the central and western parts of the county eventually flow to either the ocean or to the Everglades (through the C-11 Canal along Griffin Road). Due to sea level rise, these 18 gates that let out water from inland Broward County are compromised. This has the potential to impact 11 million residential homes and businesses, our aquifer, 1/3 of Florida's economy, and the Everglades. This issue is not new, it just has not been addressed in a meaningful way. Representative Demi Busatta Cabrera (R-Miami-Dade), Senator Ana Maria Rodriguez (R- Miami), and I passed bi-partisan HB 513, Comprehensive Review Study of the Central and Southern Florida Project, to evaluate and update this critical infrastructure that provides drainage and flood protection for the Ranches and Broward County, and we secured \$2 million for the study. I want to thank the Mayor and Town Council for their support on this legislation and for bringing forward and advocating for Southwest Ranches Appropriation projects. They went to Tallahassee and advocated for this legislation, and participated in the bi-partisan press conference with various elected officials from South Florida. We will need to continue to mitigate issues arising from climate change.

In 2022, I secured \$1,681,894 in appropriation funding for the Town:

\$793,166 for the Green Meadows Drainage Improvements along SW 164th Terrace project to help remove flood waters from the

roadways along SW 164th Terrace and Stirling Road.

\$479,306 for the SW 63rd Street and SW 185th Way Drainage Improvement project to help remove flood waters from those roads.

\$409,422 for the SW 54th Place Drainage Extension to Ivanhoe Canal project to ensure that SW 54th Place and Dykes Road are better protected from storm events.

The Speaker has recently made additional dollars available through local support grant requests, and I have submitted additional drainage improvement project funding requests: \$300,000 for construction of a stormwater conveyance system on SW 185th Way and SW 57th Court right of way, and \$150,000 for construction at the intersection of Luray Road and Holatee Trail in the Sunshine Ranches neighborhood. There is a limited pot of money for 959 grant requests filed state-wide. I look forward to resubmitting in the 2023 session any project that is not funded in this grant request round.

Most water projects include the installation of underground piping, draining inlets and a headwall. Each water project provides critical drainage capacity for storm-water runoff, thereby reducing roadway flooding (both volume and duration), and the frequency of property damage and personal injury to residents, motorists and pedestrians. These projects are part of the Town's overall resiliency efforts to create a healthy community while improving water quality. Note that funded projects are not completed so continue to be aware of flooding.

It is an honor to serve you, and my office and I are here to assist you with any issues or concerns you may have.

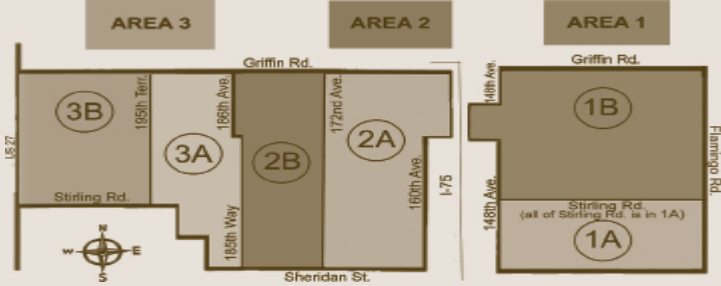
