## **Background**

On May 3, 2012, The Town of Southwest Ranches adopted Resolution No. 2012-046 entering into a five-year agreement with the Town of Davie for the delivery of emergency medical, fire protection, and fire prevention services.

On November 19, 2013, The Town of Southwest Ranches adopted Resolution No. 2014-010, entering into a five-year agreement with the Town of Davie for the delivery of police services.

On June 8, 2017, the Town of Southwest Ranches adopted Resolution No. 2017-046 entering

into a five-year agreement with the Town of Davie combining both the Emergency Medical, Fire Protection, and Fire Prevention services agreement and the Police Services agreement. This agreement expires on September 30, 2022.

Both parties are desirous of continuing this Agreement and amending the Agreement. Therefore, this Agreement has been agreed to be extended to September 30, 2023, with a contract increase of 6% for the first six months (October 1, 2022, to March 31, 2023) with an additional contract increase of 1.5% for the remaining six months (April 1, 2023 – September 30, 2023).

## Fiscal Impact/Analysis

The Town of Southwest Ranches may request a transition period after September 30, 2023. If requested, the contract price shall increase an additional 6% and shall remain in place throughout the transition process, which said transition process shall not be greater than twelve months.

In the event that both parties fail to reach a long-term agreement, prior to September 30, 2023, then the Town of Southwest Ranches shall remit the total balance of \$300,000.00, within thirty days of the contract expiration to the Town of Davie. Should the Town of Southwest Ranches request the Town of Davie to provide services during a transition period, TSWR shall remit the total balance within thirty days of the transition termination date.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA APPROVING THE SECOND AMENDMENT TO THE AGREEMENT BETWEEN THE TOWN OF DAVIE AND THE TOWN OF SOUTHWEST RANCHES FOR DELIVERY OF PUBLIC SAFETY SERVICES, INCLUDING EMERGENCY MEDICAL, FIRE PROTECTION, FIRE & LIFE SAFETY, AND POLICE SERVICES; AUTHORIZING EXECUTION; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** on June 8, 2017 the Town of Southwest Ranches ("Ranches") and the Town of Davie ("Davie") entered into an Agreement to provide for the delivery of emergency medical, fire protection, fire & life safety, fire prevention, and police services; and

**WHEREAS**, on April 18, 2018 Ranches and Davie entered into the First Amendment to the Agreement; and

WHEREAS, the term of the Agreement expires on September 30, 2022; and

**WHEREAS,** both parties are desirous of continuing this Agreement for an additional year while they work in good faith to establish a longer term agreement.

**NOW THEREFORE**, both parties agree to amend the Agreement as follows:

**NOW, THEREFORE BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida as follows:

**Section 1:** The above-referenced recitals are true and correct and are incorporated herein by reference.

**Section 2:** The Town Council hereby approves the Second Amendment to the Agreement Between The Town of Davie And The Town Of Southwest Ranches For Delivery Of Public Safety Services, Including Emergency Medical, Fire Protection, Fire & Life Safety, And Police Services, as attached hereto as Exhibit "A", which has been attached hereto and has been incorporated herein by reference.

<u>Section 3:</u> Severability. If any one or more provisions of this Resolution shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited or against public policy, or shall for any reason whatsoever be held invalid, then such provision shall be null and void and shall be separate from the remaining provisions, and shall in no way affect the validity of all other provisions of this Resolution. **Section 4: Authorization.** The Mayor, and the appropriate Town Staff are hereby authorized to execute the Second Amendment to the Agreement, and to make any nonmaterial changes necessary and proper to effectuate the intent of this Resolution.

**Section 5:** Effective Date. This Resolution shall take effect immediately upon its adoption.

## SECOND AMENDMENT TO THE AGREEMENT BETWEEN THE TOWN OF DAVIE AND THE TOWN OF SOUTHWEST RANCHES FOR DELIVERY OF PUBLIC SAFETY SERVICES, INCLUDING EMERGENCY MEDICAL, FIRE PROTECTION, FIRE & LIFE SAFETY, AND POLICE SERVICES

This Second Amendment to the Agreement made and entered into this \_\_\_\_\_\_ day of September, 2022, by and between the Town of Davie, a municipal corporation of the State of Florida (hereinafter referred to as "DAVIE"), and the Town of Southwest Ranches, a municipal corporation of the State of Florida (hereinafter referred to as "RANCHES").

WHEREAS, on June 8, 2017 DAVIE and RANCHES entered into an Agreement to provide for the delivery of emergency medical, fire protection, fire & life safety, fire prevention, and police services; and

WHEREAS, on April 18, 2018 DAVIE and RANCHES entered into the First Amendment to the Agreement; and

WHEREAS, the term of the Agreement expires on September 30, 2022; and

WHEREAS, both parties are desirous of continuing this Agreement and amending the Agreement.

NOW THEREFORE, both parties agree to amend the Agreement as follows:

## TERMS AND CONDITIONS

**3.1** This Agreement shall be extended to September 30, 2023 with a contract increase of 6% for the first six months (October 1, 2022 to March 31, 2023) with an additional contract increase of 1.5% for the remaining six months (April 1, 2023 – September 30, 2023). Should RANCHES request a transition period after September 30, 2023, the contract price shall increase an additional 6% and shall remain in place throughout the transition period, RANCHES shall continue to set aside the fifty thousand dollars (\$50,000) for a fire rescue vehicle or apparatus as outlined in 4.2. Said fifty thousand dollars (\$50,000) shall be prorated on a monthly basis and upon termination of the transition process shall be incorporated into the total balance due per Section 4.2.

**4.2** In addition to the aforementioned consideration payment, RANCHES shall continue to set aside Fifty Thousand Dollars (\$50,000) to be applied to the future purchase of a fire rescue vehicle or other necessary fire apparatus, as deemed necessary by DAVIE to provide services to RANCHES in the event DAVIE and RANCHES come to a long-term agreement. In the event DAVIE and RANCHES fail to reach a long term agreement, prior to September 30, 2023, then RANCHES shall remit the total balance of \$300,000.00, within thirty days of the contract expiration to DAVIE. In the event RANCHES requests DAVIE to provide services during a

transition period, RANCHES shall remit the total balance within thirty days of the transition termination date.

**5.2** The consideration delineated herein has been determined based on present calls for service. In the event the RANCHES' annual call volume for emergency medical, fire protection, and fire & life safety significantly increases to a level that would require DAVIE to add and/or assign additional personnel to maintain the average response times delineated in Section 5.6, below, or should the level necessitate an increase in staffing, as reasonably determined by the two administrators, or enhanced or new programs be desired, such consideration may be increased to compensate DAVIE for the additional staffing. For purposes of this section, the term "significant increase" shall be an increase of greater than twenty-five (25) percent more than the current numbers for a consecutive ninety (90) day period to warrant further discussion.

**27.1** In the event of the termination or expiration of this Interlocal Agreement, DAVIE and RANCHES shall cooperate in good faith in order to effectuate a smooth and harmonious transition from DAVIE and to maintain during such period of transition the same high quality of police protection and fire rescue services otherwise afforded to the residents of the RANCHES pursuant to the terms hereof.

**31.11 Notices:** Whenever either party desires to give notice to the other, such notice must be in writing and sent by United States mail, return receipt requested, courier, evidenced by a delivery receipt or by any overnight express delivery service addressed to the party for whom it is intended at the place last specified; and the place for giving of notice shall remain such until it shall have been changed by written notice in compliance with the provisions of this paragraph. For the present, the parties designate the following as the respective places for giving of notice. Notice shall be effective upon delivery.

## **Background**

The Town was successful in obtaining \$409,422 in funding for critical infrastructure along SW 54<sup>th</sup> Place from Dykes Road to the Ivanhoe Canal from the State budget. The Town must enter into an agreement with FDEP to begin the Drainage Improvements that must be completed before June 2025.

The Town of Southwest Ranches identified this drainage project in the Capital Improvement Element, which is shown on the Grantee's Tertiary Drainage Plan (TDP). The TDP has been approved and prioritized by both the Town Council and the Drainage and Infrastructure

Advisory Board. This project is also supported by the South Broward Drainage District.

The project will remove flood waters from roadways in the heavily travelled area of Southwest Ranches. It will provide critical drainage capacity for storm-water runoff, thereby reducing roadway flooding, property damage, and personal injury to motorists and pedestrians. The project includes furnishing of all labor, materials, tools, equipment, machinery, expertise, services, and all else necessary for proper construction and completion of the project consisting of excavation, construction of storm drainage pipe, construction of concrete catch basins and inlets with grates, grading, filling and street repair and repaving, and installation of swales and grass sodding.

Surveying and engineering services are required to begin these improvements. The Town has continuing contracts for surveying and engineering services with Craven Thompson and Associates. The Town received a proposal from Craven Thompson and Associates for surveying and engineering for the project in the amount of \$64,400.

## **Fiscal Impact/Analysis**

This project will impact the FY 2022-2023 Budget. Funds will need to be made available in the Municipal Transportation Fund account #101-5100-541-63260 (Infrastructure - Drainage). The total project cost is anticipated to be \$509,422, of which \$409,422 will be funded by FDEP, and the remaining balance of \$100,000 will be funded by the Town (Budgeted).

**WHEREAS**, the Town desires to complete a drainage improvement project relating to SW 54<sup>th</sup> Place right-of-way from Dykes Road to the Ivanhoe Canal; and

**WHEREAS**, the Town's Drainage and Infrastructure Advisory Board has ranked and prioritized this project; and

**WHEREAS,** the State Legislature has appropriated Four Hundred Nine Thousand Four Hundred Twenty-Two Dollars and Zero Cents (\$409,422.00) to assist the Town in completing this project; and

**WHEREAS**, the total project cost is estimated to be Five Hundred Nine Thousand Four Hundred Twenty-Two Dollars and Zero Cents (\$509,422.00); and

**WHEREAS**, funds have been included in FY 2022-2023 Proposed Budget in the Municipal Transportation Fund account #101-5100-541-63260 (Infrastructure - Drainage); and

**WHEREAS**, the project includes excavation, construction of concrete drainage structures and inlets with grates, swale grading, asphalt restoration, and installation of grass sod; and

WHEREAS, these improvements must be completed by April 2025; and

**WHEREAS,** surveying and engineering services are needed to complete the construction; and

**WHEREAS,** the Town has continuing contracts for Surveying and Engineering Services with Craven Thompson and Associates; and

**WHEREAS,** the Town received a proposal from Craven Thompson and Associates, for surveying, design and construction observation for the improvements in the amount of Sixty-Four Thousand Four Hundred Dollars and Zero Cents (\$64,400.00); and

**WHEREAS,** the Town Council believes that the Purchase Order is in the best interest of the health, safety, and welfare of its residents.

# NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA:

**Section 1.** The recitals above are true and correct and are incorporated herein by reference.

**Section 2.** The Town Council hereby approves a Purchase Order with Craven Thompson and Associates in the amount of Sixty-Four Thousand Four Hundred Dollars and Zero Cents (\$64,400.00) for surveying, design and construction observation relating to the SW 54<sup>th</sup> Place Drainage Improvement Project from Dykes Road to the Ivanhoe Canal, in substantially the same form as that attached hereto as Exhibit "A".

## **Background**

The Green Meadows Neighborhood is prone to flooding. The Town was successful in obtaining \$793,166 in funding for critical infrastructure in the Green Meadows neighborhood from the State budget. Pursuant to the grant agreement with the Florida Department of Environmental Protection, the Drainage Improvements must be completed before June 2025.

The Town of Southwest Ranches identified this drainage project in the Capital Improvement Element, which is shown on the Grantee's Tertiary Drainage Plan (TDP). The TDP has been approved and prioritized by both the Town Council and the Drainage and Infrastructure Advisory Board. This project is also supported by the South Broward Drainage District.

The project will remove flood waters from roadways in the heavily travelled area of Southwest Ranches. It will provide critical drainage capacity for storm-water runoff, thereby reducing roadway flooding, property damage, and personal injury to motorists and pedestrians. The project includes furnishing of all labor, materials, tools, equipment, machinery, expertise, services, and all else necessary for proper construction and completion of the project consisting of excavation, construction of storm drainage pipe, construction of concrete catch basins and inlets with grates, grading, filling and street repair and repaving, and installation of swales and grass sodding.

Surveying services are required to begin these improvements. The Town has a continuing contract for Surveying Services with Craven Thompson and Associates. The Town received a proposal from Craven Thompson and Associates for surveying for the project in the amount of \$33,900.

## Fiscal Impact/Analysis

This project will impact the FY 2022-2023 Budget. Funds will need to be made available in the Municipal Transportation Fund account #101-5100-541-63260 (Infrastructure - Drainage). The total project cost is anticipated to be \$893,166, of which \$793,166 will be funded by FDEP and a \$100,000 match by the Town (Budgeted). The anticipated breakdown of costs is below:

**WHEREAS**, the Town desires to complete a drainage improvement project in the Green Meadows neighborhood; and

**WHEREAS**, the Town's Drainage and Infrastructure Advisory Board has ranked and prioritized this project; and

**WHEREAS,** the State Legislature has appropriated Seven Hundred Ninety-Three Thousand One Hundred Sixty-Six Dollars and Zero Cents (\$793,166.00) to assist the Town in completing this project; and

**WHEREAS**, the total project cost is estimated to be Eight Hundred Ninety-Three Thousand One Hundred Sixty-Six Dollars and Zero Cents (\$893,166.00); and

**WHEREAS**, this project is specifically named in the FY 2022-2023 Town Budget; and

**WHEREAS**, the project includes excavation, construction of concrete drainage structures and inlets with grates, swale grading, asphalt restoration, and installation of grass sod; and

**WHEREAS**, pursuant to the grant agreement, these improvements must be completed by June 2025; and

WHEREAS, surveying services are needed to complete the construction; and

**WHEREAS,** the Town has a continuing contract for Surveying Services with Craven Thompson and Associates; and

**WHEREAS,** the Town received a proposal from Craven Thompson and Associates, for surveying for the improvements in the amount of Thirty-Three Thousand Nine Hundred Dollars and Zero Cents (\$33,900.00); and

WHEREAS, the Town Council believes that the Purchase Order is in the best interest of the health, safety, and welfare of its residents.

## NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN **OF SOUTHWEST RANCHES, FLORIDA:**

**Section 1.** The recitals above are true and correct and are incorporated herein by reference.

**Section 2.** The Town Council hereby approves a Purchase Order with Craven Thompson and Associates in the amount of Thirty-Three Thousand Nine Hundred Dollars and Zero Cents (\$33,900.00) for surveying services relating to the Green Meadows Drainage Improvement Project, in substantially the same form as that attached hereto as Exhibit "A".

Section 3. The Town Council hereby authorizes the Town Administrator to execute the Purchase Order in substantially the same form as that attached hereto as Exhibit "A" and to make such modifications, additions and/or deletions which they deem necessary to effectuate the intent of this Resolution.

LIABILITY-COPYRIGHT/PATENT/TRADEMARK If an article sold and delivered to Town hereunder shall be protected by any applicable patent, trademark or copyright, the vendor agrees to indemnify and save harmless Town, from and against any all suits, claims, judgments and costs instituted or recovered against it by any person whomever on account of the use or sale of such articles by Town in violation or right under such patent or copyright.

#### MATERIAL SAFETY DATA SHEETS

The vendor must supply proper Material Safety Data Sheets in compliance with OSHA's Hazard Communications Standard to Town at the time of purchase.

#### MODIFICATIONS

This purchase order form and any other document pertaining to this transaction, which has been acknowledged in writing by the Town Administrator is a complete and exclusive statement of this order. Accordingly, no modification or amendment shall be binding upon the Town unless signed by the Town Administrator. The Town Attorney has approved these standard terms and conditions as to form and correctness. Accordingly, no modification of these terms and conditions shall be binding upon Town unless they are endorsed and approved by the Town Attorney. In the event of a conflict between these terms and conditions and any other document pertaining to the transaction covered by this order, except a formal contract, these terms and conditions shallprevail.

## NONDISCRIMINATION AND NON-CONFLICT STATEMENT

Vendor agrees that no person on the grounds of handicap, age, race, color, religion, sex or national origin, shall be excluded from participation in, or be denied benefits of, or be otherwise subjected to discrimination in the performance of the agreement, or in the employment practices of Vendor. #### PAYMENT CHANGES

Payments will be made only to the company and address as set forth on order unless the Seller has requested a change thereto on official company letterhead, signed by an authorized officer of the company accompanied by a signed current IRS form W-9.

No endorsement by the Town of the product and/or service will be used by Seller in any way, manner or form in product literature or advertising.

## PUBLIC RECORDS; RIGHT TO AUDIT RECORDS

Town shall have the right to audit books, records, and accounts of Vendor and its subcontractors that are related to this Purchase Order. Vendor and its subcontractors shall keep such books, records and accounts as may be necessary in order to record complete and correct entries related to the project. All books, records, and accounts of Vendor an subcontractors shall be kept in written form, or in a form capable of conversion into written form within a reasonable time, and upon request to do so, vendor or subcontractor, as applicable, shall make same available at no cost to Town in written form. Such books and records shall be maintained by the Seller for a period of three (3) years from the date of final payment hereunder unless a shorter period is authorized in writing by the Town

Written documents prepared by either the Seller or Town in furtherance of this order shall constitute a public record in accordance with Chapter 119, Florida Statutes.

The Town is subject to Chapter 119, Florida Statutes, "Public Records Law." No claim of confidentiality or proprietary information in all or any portion of a response will be honored unless a specific exemption from the Public Law exists and is cited in the response. An incorrectly claimed exemption does not disqualify the firm, only the exemption claimed. Seller acknowledges the public shall have access at all reasonable times, to all documents and information pertaining to Town's contracts, subject to the provisions of Chapter 119, Florida Statutes, and agrees to allow access by the Town and the public to all documents subject to disclosures under applicable law.

To the extent that Seller has been provided access to or has received security sensitive information, as defined by Florida Statutes, Section 119.071 and/or has executed a Confidential Information Acknowledgement, Seller shall keep and maintain the security sensitive information as confidential and exempt from public disclosures as required by Florida Statutes.

Seller agrees to keep and maintain public records required by the Town to perform the service in Seller's possession or control in connection with Seller's performance hereunder, and upon the request from the Town's custodian of public records, to provide the Town with a copy of the requested records or allow the records to be inspected or copied within a reasonable amount of time at a cost that does not exceed the cost provided in Chapter 119 or as otherwise provided by law. Seller shall ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the Contract if the Seller does not transfer the records to the Town

Upon completion of this Agreement, Seller agrees, at no cost to Town, to transfer to the Town all public records in possession of the Seller or keep and maintain public records required by the Town to perform the service. If the Seller transfers all public records to the Town upon completion of this Agreement, the Seller shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Seller keeps and maintains public records upon completion of this Agreement, the Seller shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to the Town, upon request from the Town's custodian of public records, in a format that is compatible with the information technology system of the Town.

Seller's failure or refusal to comply with the provisions of this section shall result in the immediate termination for cause of this Agreement by Town.

#### QUANTITIES

Quantities specified in the order cannot be changed without Town approval. Goods shipped in excess of quantity designated may be returned at the Seller's expense.

#### REMEDIES

Town shall have all rights and remedies afforded under the U.C.C. and Florida law in contract and in tort, including but not limited to rejection of goods, rescission, right of act-off, refund, incidental, consequential and compensatory damages and reasonable attorney's fees.

#### RESPONSIBILITY

Responsibility will not be accepted for any goods delivered or services performed unless covered by a duly sign and authorized Town order, issued by Town Administrator.

#### REPRESENTATIVE

All parties to this order agree that the representatives named herein are, in fact, bona fide and possess full and complete authority to bind said parties.

#### SEVERABILITY

If any provision of the Purchase Order is declared illegal, void or unenforceable, the remaining provisions shall not be affected but shall remain in force and in effect.

#### SUB-CONTRACTING

Vendor shall not sub-contract the Purchase Order to any other vendor without the expressed written consent of Town.

All prices included in the Purchase Order are exclusive of any Federal, State or local taxes. Town is exempt from sales tax and federal excise taxes. Sellers doing business with the Town, which are not otherwise exempt, shall not be exempt from paying sales tax to their suppliers for materials to fulfill contractual obligations with the Town, nor shall any Seller be authorized to use the Town tax exemption in securing such materials.

TERMINATION Town may terminate this agreement, in part or in whole, for its convenience or the failure of the vendor to fulfill contractual obligations. Town shall terminate by delivering to the vendor a written Notice of Termination specifying the nature, extent and effective date of the termination. Upon receipt of the notice, the vendor shall:

1. Immediately discontinue all services affected (unless the notice directs otherwise). Deliver to Town all information, papers, reports and other materials accumulated or generated in performing the contract, whether completed or in progress. If the termination is for the convenience of Town, Town shall only be liable for payment for services rendered before the effective date of the termination. If the termination is due to the failure of the vendor to fulfill its obligations under the contract, Town may:

- Require the vendor to deliver any work described in the Notice of Termination
- 2. Take over and prosecute the same to completion by contract of otherwise and the vendor shall be liable for any additional cost incurred by Town.
- Withhold any payments to the vendor for purpose of set-off or partial payment, as the case may be, of amounts owed by Town to the vendor.

In the event of termination for cause, Town shall be liable to the vendor for reasonable costs incurred by the vendor before the effective date of the termination. Seller will be liable for excess costs of re-procurement. Unless prohibited by applicable law,

Town is not required to engage in competitive re-procurement, nor is Town required to obtain the lowest price.

#### UNIFORM COMMERCIAL CODE

Florida law, including without limitation the Uniform Commercial Code as applicable (including but not limited to Chapters 671 and 672, Florida Statutes), shall apply to and supplement the terms and conditions of this order.

ANTI-DISCRIMINATION Seller shall not discriminate against any person in its operations, activities or delivery of services. Seller shall affirmatively comply with all applicable provisions of federal, state and local equal employment laws and shall not engage in or commit any discriminatory practice against any person based on race, age, religion, color, gender, sexual orientation, national origin, marital status, physical or mental disability, political affiliation or any other factor which cannot be lawfully sued as a basis for service deliver.

#### WARRANTY

Vendor warrants to Town that all items delivered and all services rendered shall conform to the specifications, drawings, bid and/or other descriptions furnished and/or incorporated by reference, and will be fit for the particular purpose purchased, of merchandisable quality, good workmanship, and free from defects. Vendor extends to Town all warranties allowed under the U.C.C.

Vendor shall provide copies of warranties to Town with invoice. Return of merchandise not meeting warranties shall be at vendor's expense.

The firm of Craven Thompson & Associates, Inc. is pleased to provide the following revised proposal for professional surveying services, for the above referenced project. Our scope is as follows:

## I. SURVEYING SERVICES

## 1.1 <u>Topographic Survey</u> (CTA Task No. 11050)

Prepare a topographic survey of portions of the following multiple roadways within the Town. The survey will include locations within the full right-of-way of the roads listed below. The total project length, including all adjacent side street sections, covers approximately 7,000 lineal feet. The project limits are shown on the attached *Exhibit 'A'*.

# **Background**

The Green Meadows Neighborhood is prone to flooding. The Town was successful in obtaining \$793,166 in funding for critical infrastructure in the Green Meadows neighborhood from the State budget. Pursuant to the grant agreement with the Florida Department of Environmental Protection, the Drainage Improvements must be completed before June 2025.

The Town of Southwest Ranches identified this drainage project in the Capital Improvement Element, which is shown on the Grantee's Tertiary Drainage Plan (TDP). The TDP has been approved and prioritized by both the Town Council and the Drainage and Infrastructure Advisory Board. This project is also supported by the South Broward Drainage District.

The project will remove flood waters from roadways in the heavily travelled area of Southwest Ranches. It will provide critical drainage capacity for storm-water runoff, thereby reducing roadway flooding, property damage, and personal injury to motorists and pedestrians. The project includes furnishing of all labor, materials, tools, equipment, machinery, expertise, services, and all else necessary for proper construction and completion of the project consisting of excavation, construction of storm drainage pipe, construction of concrete catch basins and inlets with grates, grading, filling and street repair and repaving, and installation of swales and grass sodding.

Engineering services are required to begin these improvements. The Town has a continuing contract for engineering services with Kimley Horn and Associates, Inc. The Town received a proposal from Kimley Horn and Associates, Inc. for engineering services for the project in the amount of \$68,205.

# Fiscal Impact/Analysis

This project will impact the FY 2022-2023 Budget. Funds will need to be made available in the Municipal Transportation Fund account #101-5100-541-63260 (Infrastructure - Drainage). The total project cost is anticipated to be \$893,166, of which \$793,166 will be funded by FDEP, and the remaining balance of \$100,000 will be funded by the Town (Budgeted). The anticipated breakdown of costs is below:

#### DEFAULT

If vendor fails to perform or comply with any p[provision of the Purchase Order or terms or conditions of any documents referenced and made a part hereof, Town may terminate the contract, in whole or in part, and may consider such failure or noncompliance a breach of contract. Town expressly retains all rights and remedies provided by law in caser of such breach, and no action by Town shall constitute a waiver of any such rights or remedies. Failure to notify the Town concerning this type of delivery will result in the billing to Seller of any add-on redelivery, storage or handling charges.

Vendor shall indemnify, defend, save and hold harmless CITY, its officers, agents and employees from all suits, claims, actions or damages of any nature, including any attorney's fees, paralegal expenses, and court costs incurred at either the trial or appellate levels brought because of, arising out of, or due to breach of the agreement by Vendor, its subcontractors, suppliers, agents, or employees or due to any negligent act or occurrence or any omission or commission of Vendor, its subcontractors, suppliers, agents or employees. NOTHING HEREIN SHALL BE DEEMED TO WAIVE THE TOWN'S SOVEREIGN IMMUNITY.

#### INDEPENDENT CONTRACTOR

Kimley-Horn and Associates, Inc., (hereinafter referred to as "Consultant", "We" or "Kimley-Horn"), in connection with the Town of Southwest Ranches' "Continuing Contract for Professional Engineering Services; RLI 19-005" is pleased to submit this proposal to the Town of Southwest Ranches, (hereinafter referred to as "Client" or "Town") to provide professional civil engineering services and limited construction phase services associated with the construction of the Green Meadows South Drainage Improvements Project.

# **Project Understanding**

The Town is experiencing flooding along the following road corridors:

- SW 162<sup>nd</sup> Avenue From 5700 Block (SBDD Canal) to Stirling Road
- SW Green Meadows Drive From 5700 Block (SBDD Canal) to Stirling Road
- SW 164<sup>th</sup> Terrace From 5700 Block (SBDD Canal) to Stirling Road
- SW 166<sup>th</sup> Avenue From 5800 Block (SBDD Canal) to SW 62<sup>nd</sup> Street
- Stirling Road From SW 162<sup>nd</sup> Avenue to SW 166<sup>th</sup> Avenue

As such, the Town would like for Kimley-Horn to prepare a design and deliver construction plans to improve stormwater management and provide stormwater quality within the project limits. The professional services associated with this project includes design, permitting, bid document development, bidding assistance, and limited construction phase services. The proposed drainage improvements will consist of roadside swales, manholes, catch basins, and piping.

# **Project Assumptions**

• The Town will provide a topographic survey of the area in CAD Format. The topographic information will be per NAVD 88 datum. Any additional survey needed to complete the design and permitting will be provided by the Town.

- Geotechnical information is not required for the proposed improvements but if one is needed it will be provided by the Town.
- This scope of services does not include the development of technical specifications. Design requirements will be reflected on the construction plans as notes and details according to Town of Southwest Ranches' requirements and design standards. Contract documents to be provided by the Town.
- Review or modification of existing roadway pavement markings is not included in this scope of work.
- Maintenance of Traffic (MOT) and dewatering, if required, will be provided by the Contractor or others.

# **Scope of Services**

Kimley-Horn will provide the services specifically set forth below.

# TASK 1: PROJECT KICK-OFF AND SCHEMATIC DESIGN

Kimley-Horn will perform an initial site visit to observe existing conditions and truth the survey provided by the Town. Kimley-Horn will attend one (1) kick-off meeting with the Town to discuss the project, desired design elements, and to review the project schedule.

As part of this Task, Kimley-Horn will request existing utility as-built information from the major utility providers within the project area including water, sewer, drainage, electrical, cable, gas, and fiber optics. Once received, the existing utilities will be reviewed and depicted on the survey provided by the Town. Existing irrigation system information will not be obtained as part of this Task.

Kimley-Horn will coordinate and meet with South Broward Drainage District and any governmental agencies having jurisdiction to discuss permitting requirements and design criteria for new or modified work to be performed within the right-of-way, this shall include confirming the ability for a new outfall.

Kimley-Horn will prepare a schematic plan in plan view only which will be presented to the Town for review and approval. Kimley-Horn will also provide a schematic level cost estimate per the proposed improvements.

# TASK 2: DESIGN DEVELOPMENT PLANS

Utilizing the survey and schematic design plan developed in Task 1, Kimley-Horn shall prepare preliminary 60% design plans for the construction of drainage improvements within the Project Area. These Design Development Plans shall show the geometric layout on top of the base survey data. The basis for design will be the Town of Southwest Ranches, South Broward Drainage District and Florida Department of Transportation (the "FDOT") Standard Indexes/Details where applicable. The following plan sheets may be included in the Design Development Plans:

- Key Sheet Project title, vicinity map, engineer of record, and other appropriate information.
- Plan and Profile Sheets (in a 24" x 36" format) Containing the geometric, horizontal and vertical alignment for the roadways within the project area. These sheets shall also contain

the horizontal, vertical, and geometric alignments for modifications/additions to the existing drainage system.

- Miscellaneous Drainage Details These sheets would provide drainage details that may or may not be included in the FDOT Standard Indexes or South Broward Drainage District Details.
- Typical Signing and Pavement Marking Details Signing and pavement markings shall be detailed for use in the project.

The effort for this task includes one (1) submittal at 60% to the Town for review. The effort for this task includes addressing one (1) round of ordinary and reasonable comments at the submittal stage. Subsequent modifications resulting from significant project changes directed by the Town shall be considered an Additional Service.

Kimley-Horn will also provide an updated Opinion of Probable Construction Costs at the 60% submittal for the proposed improvements.

# TASK 3: DRAINAGE DESIGN AND PERMITTING

# 3.1 Hydraulic Analysis

The hydraulic analysis shall be completed for the Project Area based upon the survey information obtained from the Town. During the analysis, the volume of stormwater runoff shall be calculated from the design storm and the capacity of the existing stormwater collection system to include the outfall connections shall be evaluated. The results of the above noted calculations along with the incorporation of budget constraints will be the basis for design of the stormwater system.

### 3.2 Permitting

Kimley-Horn will prepare permit applications with supporting documentation to the following jurisdictional regulatory agencies. Kimley-Horn will address comments for the regulatory agency submittals identified below.

- 1. South Broward Drainage District
  - a. Drainage
- 2. National Pollutant Discharge Elimination System (NPDES):
  - a. Notice of Intent
  - b. Preparation of Storm Water Pollution Prevention Plans (SWPPP) Town's Contractor shall complete the necessary application and submittal to obtain the general permit. The Town's contractor shall be responsible for obtaining, maintaining, and operating the construction site according to the EPA and NPDES guidelines.
- 3. Town of Southwest Ranches
  - a. Town Engineering/Public Works

No other agency approvals are included in this scope of services other than those identified above. Kimley-Horn does not guarantee the issuance of permits or approvals. If permits are issued for this project, the conditions and expiration dates are the sole responsibility of the Town. Kimley-Horn is not responsible for extending time limited entitlements or permits. The Town shall provide all permit fees.

# TASK 4: PUBLIC WORKSHOP

Kimley-Horn will attend one (1) public workshop with the Town residents to review the scope of the Green Meadows South Drainage Improvements. Kimley-Horn will prepare the project materials for the workshop, and the Town will present the material. The Town will schedule and advertise the public meeting.

## **TASK 5: FINAL CONTRACT DOCUMENTS**

Once the Town and the above listed permitting agencies have approved the 60% construction documents, these will be used as the basis for preparing the final contract documents. Contract or "Front End" documents will be provided by the Town and reviewed by Kimley-Horn for conformance with the design plans.

During this task, Kimley-Horn will perform the following:

- Revise the drawings listed in Task 2 per the Town and permitting agency comments.
- Determine anticipated construction time for contract purposes.
- Update the engineer's opinion of probable construction costs.
- Prepare a bid form that will list the separate pay items, estimated quantities, and units.
- Provide the Town with a project description to be included in the Town's Front End documents.

# TASK 6: BIDDING ASSISTANCE

It is our understanding that the Town will use a competitive bidding process to hire a contractor to construct the improvements. The Consultant shall consult with and advise the Town and act as its representative for the proposed improvements during the bidding process. This task is limited to attendance at a pre-bid meeting and issuance of addenda in response to contractor questions. Once bids are received, the Consultant shall review the bids and prepare a bid tabulation sheet for use in making the recommended award.

# TASK 7: LIMITED CONSTRUCTION PHASE SERVICES

This task is to provide Limited Construction Phase Services by Kimley-Horn during construction of the Project. This scope of services is based on the project achieving substantial completion within 180 calendar days, plus 30 days to final completion. There are six separate limited construction phase services sub tasks regarding the Project. The tasks are as follows:

**Meetings:** Kimley-Horn shall attend one (1) pre-construction meeting and bi-monthly progress meetings with the Construction Manager and their Contractor(s) to assess the project schedule and Contractor progress for the duration of the construction process. This task includes twelve (12) progress meetings. Meeting minutes will be provided by Kimley-Horn.

**Resident Project Representation:** A Resident Project Representative ("RPR") shall be furnished by Kimley-Horn and shall act as directed by Kimley-Horn in order to assist Kimley-Horn in observing performance of the work of the Contractor(s).

The RPR shall visit the site while the Contractor is working for up to a total of sixteen (16) site visits during construction to observe the progress and quality of the executed work of the Contractor(s) and to determine if such work is proceeding in accordance with the contract documents for the construction of the improvements (the "Contract Documents"). The RPR will be onsite for up to 2 hours for each site visit. The RPR shall not be responsible for the means, methods, techniques, sequences, or procedures of construction selected by Contractor(s) or the safety precautions and programs incident to the work of Contractor(s). The RPR's efforts will be directed toward providing the Town with a greater degree of confidence that the completed work of Contractor(s) to perform to the Contract Documents. The RPR shall not be responsible for the failure of Contractor(s) to perform the work in accordance with the Contract Documents. During such visits and on the basis of on-site observations, Kimley-Horn shall keep the Town informed of the progress of the work, shall endeavor to protect the Town to the Contract Documents. Kimley-Horn shall perform the observations in accordance with the standard of care of the profession at the time of service.

**Shop Drawing Review:** Kimley-Horn shall review and approve (or take other appropriate action in respect of) Shop Drawings (as that term is defined in the General Conditions of each construction contract) and samples and other data that each Contractor is required to submit, but only for conformance with the design concept of the Project and compliance with the information given in the Contract Documents. Such review and approval, or other action, shall not extend to means, methods, sequences, techniques or procedures of construction, or safety precautions and programs incident hereto. Such recommendations of payment shall constitute a representation to the Town based on such observations and review that the work has progressed to the point indicated and that, to the best of Kimley-Horn's knowledge, information, and belief, the quality of work is in accordance with the Contract Documents (subject to any qualifications stated in Kimley-Horn's recommendations), and that payment of the amount recommended is due to Contractor(s).

By recommending any payment, Kimley-Horn shall not thereby be deemed to have represented that observations made by Kimley-Horn to check Contractor's work as it is performed and furnished have been exhaustive, extended to every aspect of Contractor's work in progress, or involved detailed inspections of the Work beyond the responsibilities specifically assigned to Kimley-Horn in this Agreement. Neither Kimley-Horn's review of Contractor's work for the purposes of recommending payments nor Kimley-Horn's recommendation of any payment including final payment will impose on Kimley-Horn responsibility to supervise, direct, or control Contractor's work in progress or for the means, methods, techniques, equipment choice and usage, sequences, or procedures of construction of safety precautions or programs incident thereto, nor Contractor's compliance with Laws and Regulations applicable to Contractor's furnishing and performing the Work.

**Project Close Out:** Kimley-Horn shall review the Project with the Town to determine if the Project is substantially complete and conduct a final review to determine if the work has been completed in accordance with the Contract Documents. Kimley-Horn shall not be responsible for the acts or omissions of any Contractor or subcontractor, any of the Contractor(s)' or subcontractor(s)' agents or employees, or any other persons (except the Kimley-Horn's own employees and agents) at the site or otherwise performing any of the Contractor(s)' work.
