Notice is hereby given that the Town of Southwest Ranches will hold an election on Tuesday, November 8, 2022, for the purpose of electing the Council Member District 1. All qualified electors residing in the Town shall be entitled to and permitted to vote in such election. The polls will be open from 7:00 a.m. until 7:00 p.m. Please refer to your voter registration card to determine your voting precinct and polling location. Florida law requires voters to show identification with your picture and signature or you will be required to complete an affirmation in order to vote. FILLING COUNCIL VACANCIES

In the case of the Mayor, the Vice Mayor would become the Acting Mayor until the next regularly scheduled election.
