Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Breitkreuz at 7:22 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance. Mayor Breitkreuz spoke about the loss of Sandra Luongo and a moment of silence was held in her memory.

Dr. Barbara Sharief addressed the Town Council, and announced she is running for District 35 State Senate and provided

3. Public Comment

The following members of the public addressed the Town Council: Newell Hollingsworth, Walt Butler, Gay Chaples, Laura Mastrarrigo and Lorena Kaelber.

4. Board Reports

Gay Chaples, Chair of the Historical Society advised Town Council they have nominated the Dykes Family for this year's Broward County Pioneer award. The Historical Society requested a camera to continue recording for the Historical Society and Ms. Chaples asked Josh Dykes to be a member and put the word out they need new members.

George Morris, Chair of the Comprehensive Plan Advisory Board, provided an update of the July 21st, 2022 board meeting. He also presented Board Liaison Emily Aceti with a goodbye gift and thanked her for all she did for the Board.

George Morris, Chair of the Drainage and Infrastructure Advisory Board, advised they did not meet in the month of July.

5. Council Member Comments

Mayor Breitkreuz thanked Community Services Manager Emily Aceti for all her hard work and dedication to the Town.

Council Member Hartmann echoed Mayor Breitkreuz appreciation and gratitude to Emily Aceti. He also spoke of her dedication as the Liaison to the Comprehensive Plan Advisory Board. He spoke about General Services Manager Sandra Luongo and their history together as coworkers and friends and how much she will be missed.

Vice Mayor Jablonski provided an update on upcoming events such as the Rural Public Arts and Design Board's annual photo contest and the photo submissions which were due on September 5th, the Florida DMV Flow-Mobile on August 24th and the Broward County Property Appraiser Outreach on August 2nd. He wished all the best to Emily Aceti and spoke about how missed Sandra Luongo will be.

Council Member Kuczenski spoke about working on a proposed sign ordinance and how it will affect campaign signs. He spoke about the July 21st Comprehensive Plan Advisory Board meeting and how shocked he was to learn that the groom's quarters ordinance was removed from the Code of Ordinances. He would like to bring back the ordinance to allow grooms quarters. Lastly, he spoke about how slow the process to install LPR readers are and he asked the Town to contact Broward County to try to get the approvals moving.

Council Member Allbritton wished Community Services Manager and Comprehensive Plan Advisory Board Liaison Emily Aceti and her family all the best. Next he spoke about the Green Meadows Drainage Project and the grant dollars the Town received from the State of Florida to assist funding the project. Once Green Meadows' drainage has been finished, the Southwest Meadows Preserve will be next and will make the area much more friendly for events. Lastly, the residents are working very hard to revive the Green Meadows Civic Association. They have had a few meetings and Anna Koldys has agreed to volunteer as the association president until an election can be held.

6. Legal Comments

Town Attorney Poliakoff echoed the Town Council's sentiments about Sandra Luongo and congratulated Emily Aceti on her relocation. He spoke about the changeover to Waste Management and how pleased he feels the residents will be. He advised the Town is still working with MG3 to move forward on the P3 agreement. He also advised the main issue is the cost of wetland mitigation. Town Administrator Berns, Assistant Town Administrator Muniz and Town Attorney Poliakoff set up a meeting with Senator Nan Rich and the head of Broward County's Environmental Department, Lenny Vialpando to discuss the impact fee for the wetland mitigation. The Town is also working on water and sewer issues for the property. He advised the sign ordinance discussed by Council Member Kuczenski has been drafted and is waiting for comments.

7. Administration Comments

Town Administrator Berns thanked the Mayor and Town Council for the comments made about the loss of General Services Manager Sandra Luongo and advised she was his first hire and she will be missed. He also spoke about Community Services Manager Emily Aceti and what an important part of the Town's team and she will be missed in the office. He spoke about the extra fill that had been donated to the Town and the costs of spreading that fill were extremely high. He advised that George Morris provided a much lower bid amount that saved the Town money. While he was spreading the fill, the Town was advised the fill wasn't as clean as it should have been. Mr. Morris donated truckloads of pure clean fill for the Town's ballfields and Town Administrator Berns thanked Mr. Morris for all he did. Town administrator Berns advised the Town

Engineer's office is short staffed and the reviews may be a little delayed. Lastly, he advised the Town Council the Town's vendor is working with Broward County to promote the approval of the LPR's so they may be installed as soon as possible, and an update will be provided soon.
