Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Breitkreuz at 7:04 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

3. Proclamation – Archbishop Edward A. McCarthy High School

The Town presented a proclamation to celebrate Archbishop Edward A. McCarthy High School's 25th Anniversary.

4. Presentation to SWR Parks Foundation – Antonio Salcicioli

Antonio Salcicioli of the Cioli Group presented the SWR Parks Foundation with a donation in the amount of \$7137.00.

5. Coyote Nuisance Presentation & Discussion

A PowerPoint presentation followed by a discussion was held to address the continuing problems with coyote attacks throughout the Town.

6. Public Comment

The following members of the public addressed the Town Council: Parneet Singh of the Sikh Youth Association and Rose Williams.

7. Board Reports

George Morris provided update on both the Drainage and Infrastructure Board as well as the Southwest Ranches Parks Foundation.

8. Council Member Comments

Council Member Jablonski advised there will be an upcoming discussion item regarding the Fill Permit process after the Drainage and Infrastructure Advisory Board has discussed it. He then provided the public with upcoming Town events as well as Town Hall closure for the President's Day holiday. He spoke about the progress being made the Misión Vida/Weston FC Soccer Club agreement.

Regular Council Meeting January 26, 2023

Vice Mayor Allbritton spoke about the accomplishments the Town achieved in 2022 such as lowered millage rates, a balanced Town Budget, a new solid waste contractor, license plate readers to help deter speeding in the Town, three Charter Review amendments passed, raised our parks inpact fees, and the fill permit process was streamlined. The Town received 1.8 million dollars in grants from the State and Federal Government to complete projects around the Town with minimal Town match. He spoke about bringing in a 9-1-1 dispatcher from a non-regional facility to explain how intricate the 9-1-1 system is and how it's run. He advised he was going to Tallahassee for Broward Days in March to meet with the Legislators and lobby issues for the Town. Vice Mayor Allbritton spoke about sitting on the Broward Water Advisory Committee and the discussion about having every home in Broward County on sewar systems instead of septic systems. He thanked all the volunteer advisory board members as well as the Astor Knight Parks Foundation board members for dedicating their time to the Town. He spoke about the two speed trailers that have been placed in different areas around Town. He advised the residents to contact him if they have a specific location that would benefit having the speed trailer placed and he would see to it. He advised the District Three Homeowners Civic Association meeting will be held Monday, January 30, 2023. Lastly, he spoke about the residents on 62nd Street, West of 166th Avenue got together and raised the funds to have their street paved. Once that is done, they are looking for information as to how to turn the street back over to the Town.

Council Member Kuczenski spoke about the Founder's Park Wall and the work being done by the Rural Public Arts and Design Advisory Board to have additional panels painted by the hired artist. He also asked the Rural Public and Design Arts Advisory Board to design something that would identify Southwest Ranches residents that are also vendors at the Farmer's Market. He spoke about the 9-1-1 system in Broward County and assured the Town's residents they are fully protected if they call 9-1-1. He provided an update on the tickets and citations issued in the months of December and January due to the efforts of the Davie Police Department and the direction of the Town.

Council Member Hartmann congratulated the Astor Knight Parks Foundation for the success of the Southwest Ranches Country Fair. He spoke about recycling and offered the Town residents an hour-long tour at the Waste Management facility for ages 14 and older. The dates for the tour are Saturday, February 18^{th,} and Thursday March 9th, both at 10:00 a.m. and to please contact him to attend. He spoke about the Community Emergency Response Team (CERT) that is trained by Davie Police Department and urged the residents to take the class and become certified. He would also like to set up a peer organization in the Town and have Davie Police Department meet with them quarterly and provide supplies and training. Council Member Hartmann went on to talk about Broward County also providing trainings such as active shooter drills and airport incident drills. He spoke about police presence in the Town and asked Town Administrator Berns to get involved and help identify funding for additional police officers or possibly organizing a community-oriented police group, citizens patrol or police reserve. He also mentioned reaching out to Representative Debbie Wasserman Schultz to see if there are any federal funds available to help with police staffing. He spoke about the "Keep Us Rural" Workshop, the great ideas that were suggested and thanked the public for attending. Lastly, he spoke about the Advisory Boards and thanked the volunteers for their time and effort as well as their suggestions.

Regular Council Meeting

Mayor Breitkreuz congratulated Deputy Town Clerk Ruesga for obtaining her Certified Municipal Clerk Designation. He spoke about the transition from Waste Pro to Waste Management (WM) and advised the residents about the GIS page on the website that will assist the residents in finding out days their garbage, bulk trash and recycling are. Assistant Town Administrator Muñiz showed the residents how the GIS webpage worked. He talked about having activities that bring the Town residents together, specifically focusing on the youth and senior citizens. He spoke with Town Administrator Berns about hiring a part time employee as an Activities Director, under the supervision of December Lauretano-Haines to focus on that aspect for the Town. He provided direction to Town Attorney Poliakoff to draft a helicopter ordinance due to larger homes being built and possibly having helicopters landing at those residences. Lastly, Mayor Breitkreuz spoke about his meeting with Broward Sheriff's Office Gregory Tony regarding the 9-1-1 call centers.

9. Legal Comments

Town Attorney Poliakoff spoke about the loss of Susan Wynn and offered his thought and prayers to the family. He advised the Town Fireworks Bill is in Bill Drafting and once it has been assigned a Bill number, he will announce it publicly. He will work on the helicopter ordinance as directed by Mayor Breitkreuz. He spoke with Gary Resnick who handles the Town's federal issues and he suggested to Town Attorney Poliakoff to separate the Utilities ordinance and creating an ordinance just for water and sewer and one ordinance for everything else. Town Attorney Poliakoff asked for the Town's permission to separate the ordinances to which Mayor Breitkreuz agreed. He spoke about the settlement agreement with Misión Vida and the final settlement agreement should come before the Town Council's next meeting.

10. Administrations Comments

Town Administrator Berns invited the Town Council and any members of the public to come to Town Hall on Saturday January 28th from 10am to 2pm as the members of Boy Scout Troop 224 as well as members of the Parks, Recreation, Forestry and Natural Resources Advisory Board will be working on replanting the flower beds in front of Town Hall. He spoke about the speed enforcement project in slowing the traffic down within the Town and installing permanent speed signs throughout the Town. He provided photos and advised there are two companies that have been identified for the project. Town Administrator Berns suggested the Town purchase one of the permanent signs, have it installed, see how it works and evaluate the data and go from there. He then asked for the Town Council's input. Town Council agreed to the prototype and provided location suggestions as well as having Davie Police Department offer suggestions as well. Mayor Breitkreuz asked Town Administrator Berns what would be the installation challenges would be and he stated it would probably be wiring hookup issues, but the Town wouldn't fully know until the installation was completed.

6. Board Reports

Rose Allbritton and Sage Cimetta spoke on behalf of the Rural Public Arts and Design Advisory Board to request Town Council allow the advisory board to refresh the "Southwest Rancher" newsletter.

Debbie Green spoke on behalf of the Schools and Education Advisory Board (SEAB) to update the public about upcoming events such as Flamingo Flocking, the Barn Dance and Unity in Diversity 5K.

7. Council Member Comments

Council Member Jablonski updated the residents of the upcoming events happening in the Town such as, the Fun Horse Show, Flamingo Flocking, Town Hall closure for President's Day, SEAB Barn Dance, HazMat at the Barn and Unity in Diversity 5k. He then asked the Town Council to allow him extra time to speak on Item 12.

Vice Mayor Allbritton thanked the Davie Police Officers for their increased enforcement of ticketing drivers that are speeding within the Town. He also thanked General Services Manager Tom Holste for helping with the movement and placement of the speed trailers. He advised of two bills that are under consideration in Tallahassee, No Permit Carry and lowering the Save our Homes cap from 3% to 2%. He spoke of the vandalism that has been affecting the Town's parks and advised residents to report anything they may see. Lastly, he spoke about his attendance at the 2023 Mayor's Breakfast.

Council Member Kuczenski provided traffic citation statistics for the month of January throughout the Town and thanked the Davie Police Department for their dedication to the speed enforcement project. He spoke about an article in the Miami Herald regarding legislation, SB102, that provides incentives for affordable housing, and he was concerned on some of the wording in the Bill that would "preempt local municipality requirements in regard to zoning, density and height to allow for streamlined development of affordable housing in commercial and mixed-use zoned areas under certain circumstances." He was concerned this will affect the Town in the future if SB102 passes. He suggested working with the Town's lobbying team in Tallahassee to soften the wording in the bill. He presented mini placards that identify local vendors as Town residents at the SWR Farmer's Market and he thanked the Rural Public Arts and Design Advisory Board for designing them. He thanked Sage Cimetta and Rose Allbritton of the Rural Public Arts and Design Advisory Board for volunteering to work on ideas to refresh the Southwest Rancher newsletter. Lastly, he spoke about Broward Days in Tallahassee that he and the other Town Council members will be attending the week of March 21st along with Representative Robin Bartleman to discuss drainage projects throughout the Town and the Fireworks ordinance.

Council Member Hartmann spoke about the Town's trash provider Waste Management (WM) and their efforts with public outreach. He stated Waste Management was offering two tours of the recycling facility to the residents, Saturday, February 18th, and Thursday March 9th and both start at 10:00am.
