# **Background**

Warren Henry Automobiles, Inc. has filed an application to amend the restrictive use note on the face of the Regency Plat which is located at the southeast corner of Griffin Road and I-75 with the Urban Planning Division of the Broward County Resilient Environment Department. The proposed note amendment authorizes an increase of 60,000 square feet of dealership and 60,000 square feet of automotive storage to the 100,000 square feet of dealership and 165,000 square feet of automobile storage currently authorized on the face of the Plat.

The Town is concerned about the traffic impacts from the additional dealership and automobile storage area to SW 148th Avenue and its intersection with Griffin Road since 60% of SW 148th Avenue's lane miles are within the Town of Southwest Ranches. The most recent available traffic counts on SW 148th Avenue were collected south of the driveways providing access to the Plat, and therefore do not fully reflect the trips to and from the Plat to Griffin Road. Furthermore, test drive trips are also not included in the traffic counts which

could further impact traffic to the numerous residential communities south of the Plat on SW 148th Avenue.

The Town understands that the proposed plat note limits the project to a luxury dealership, which generates statistically fewer vehicle trips than traditional high volume dealerships, but seeks to ensure that all vehicle trips to and from the Plat, inclusive of those generated by the additional proposed dealership and automobile storage areas, are carefully evaluated so that SW 148th Avenue both north and south of the Plat, as well as the intersection of SW 148th Avenue and Griffin Road, operate at the adopted level of service or better.

**WHEREAS,** the Regency Plat ("Plat") is located within the Town of Davie, at the southeast corner of Griffin Road and I-75, adjacent to the Town of Southwest Ranches; and

**WHEREAS,** Warren Henry Automobiles, Inc. has filed an application to amend the restrictive use note on the face of the Plat with the Urban Planning Division of the Broward County Resilient Environment Department; and

**WHEREAS,** the proposed note amendment authorizes an increase of 60,000 square feet of dealership and 60,000 square feet of automotive storage to the 100,000 square feet of dealership and 165,000 square feet of automobile storage currently authorized on the face of the Plat; and

**WHEREAS,** sixty percent (60%) of SW 148<sup>th</sup> Avenue's lane miles are within the Town of Southwest Ranches and one hundred percent (100%) of SW 148<sup>th</sup> Avenue abuts the Town of Southwest Ranches; and

**WHEREAS,** the Town of Southwest Ranches is committed to preserving its Rural Lifestyle, which includes maintaining the adopted levels of service on roadways within its jurisdiction; and

**WHEREAS,** the Town of Southwest Ranches is concerned about the traffic impacts from the additional dealership and automobile storage area to SW 148<sup>th</sup> Avenue and its intersection with Griffin Road; and

**WHEREAS,** the most recent available traffic counts on SW 148<sup>th</sup> Avenue were collected south of the driveways providing access to the Plat, and therefore do not fully reflect the trips to and from the Plat to Griffin Road; and

**WHEREAS,** included in the trips not reflected by the traffic counts are test drive trips for the various dealerships within the Plat that are required as a condition of Town of Davie approval and/or via agreement to exist the Plat north on SW 148<sup>th</sup> Avenue to Griffin Road and return to the dealerships south on SW 148<sup>th</sup> Avenue from Griffin Road in order to minimize traffic to the numerous residential communities south of the Plat on SW 148<sup>th</sup> Avenue; and

**WHEREAS,** the Town of Southwest Ranches understands that the proposed plat note limits the project to a luxury dealership, which generates statistically fewer vehicle trips than traditional high volume dealerships, but seeks to ensure that all vehicle trips to and from the Plat, inclusive of those generated by the additional proposed dealership and automobile storage areas, are carefully evaluated so that SW 148<sup>th</sup> Avenue both north and south of the Plat, as well as the intersection of SW 148<sup>th</sup> Avenue and Griffin Road, operate at the adopted level of service or better.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:

**Section 1:** The above referenced recitals are true and correct and are incorporated herein by reference.

**Section 2:** The Town of Southwest Ranches hereby opposes the plat note request, and requests that the Broward County Urban Planning Division and the Broward County Commission not approve the plat note amendment to increase the dealership and automobile storage area until the developer causes preparation of a traffic study that demonstrates to the Town's satisfaction that all of SW 148<sup>th</sup> Avenue and its intersection with Griffin Road will function at the adopted level of service or better on weekdays and Saturdays, including trips from the additional dealership and automobile storage area.

**Section 3:** The Town Clerk is hereby directed to provide a copy of this Resolution to the entire Broward County Commission, and the Broward County Urban Planning Division.

**Section 4:** This Resolution shall take effect immediately upon its adoption.

Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Breitkreuz at 7:01 PM.

# 3. Public Comment

The following members of the public addressed the Town Council: The Sikh Youth Association, Patrick Keane, George Cailas, Kirk Hobson-Garcia.

### 4. Board Reports

There were no Board Reports.

# 5. Council Member Comments

Council Member Jablonski spoke about upcoming events in the Town such as the DMV Flow-Mobile, HazMat at the Park, the Broward County Property Appraiser, the "Unity in Diversity" 5K and the Rolling Oaks Easter Egg Hunt. The Southwest Meadows Sanctuary was awarded a \$600,000 grant with a \$150,000 Town match for the drainage canal and wetlands by the Federal Government through Debbie Wasserman Schultz. He then provided an update on his trip to Broward Days in Tallahassee. He advised the Fireworks Bill the Town was proposing to legislators in Tallahassee was rejected and the Town was advised to revamp the Bill.

Council Member Kuczenski spoke about his time in Tallahassee attending Broward Days and who he spoke with. He spoke about a news item that aired on NBC6 news regarding mail thefts in Sunshine Ranches and he wanted to assure the residents, the Town and Davie Police Department are on top of the issue. Lastly, Council Member Kuczenski announced his intent to run for reelection to the Town Council in 2024.

Vice Mayor Allbritton spoke a little bit about Nelson Diaz who is a member of the Southern Strategy Group, the Town's lobbyist group. While the Town Council was in Tallahassee for Broward Days, Nelson was working on setting up meetings with the Legislators. Vice Mayor Allbritton then spoke about his trip and what was accomplished. Next, he spoke about his attendance at the Broward Metropolitan Planning Organization (MPO) meeting and what was discussed. He advised he had not received any new locations for the speed trailers and to contact him with locations to place them. Lastly, he announced his intent to run for re-election the Town Council in 2024. Council Member Hartmann spoke about Broward County and wanting to get into the garbage/recycling business. He is concerned about where Broward County wants to put the facility.

Mayor Breitkreuz spoke about the presentation Code Enforcement Director Julio Medina gave at the previous meeting. He said it was an excellent presentation and he thanked Mr. Medina and his entire staff for all they do. He spoke about the mail thefts happening in Town and offered some suggestions to mitigate the problems on an individual level, such as retrieving the mail before dark, not mailing checks in the residential mailboxes, but bringing them to the Town and mail them in the blue mailbox in front of Town Hall. He spoke about an issue that was raised at the Country Estates Homeowners Association meeting regarding electrical boxes not being placed high enough in that area of Town and he thanked Jim Laskey for bringing awareness to the issue. He advised that he and the rest of the Town Council appreciate the feedback from residents. Lastly, he expressed his well wishes to Council Member Kuczenski and Vice Mayor Allbritton on their intent to run for re-election.

# 7. Public Comment

There was no public comment.

George Morris, Chair of the Drainage and Infrastructure Advisory Board (DIAB) spoke about the March 23<sup>rd</sup> 2023 DIAB meeting and the upcoming projects on SW 54<sup>th</sup> Place and SW 63<sup>rd</sup> Street, as well as discussions that were had about possible solutions for the fill permits. He also advised notices were mailed out and preparations were completed for that meeting as well as for the April 18<sup>th</sup> 2023 DIAB Meeting where the Board will continue the discussions on the SW 54<sup>th</sup> Place and SW 63<sup>rd</sup> Street projects. There will be an advisor at the April 18<sup>th</sup> 2023 meeting as well to speak about those upcoming projects.

# **Council Member Comments**

Council Member Jablonski spoke about upcoming events in the Town such as the DMV Flow-Mobile and HazMat at the Park. He spoke about the "Unity in Diversity" 5K and the Rolling Oaks Easter Egg Hunt that just passed and what great events they were. He reiterated what will be discussed at the upcoming DIAB meeting and everyone is invited.

Council Member Hartmann had no comments.

Council Member Kuczenski had no comments.

Vice Mayor Allbritton spoke about his seat on the Broward County Water Advisory Board and the flooding issues they have been working on. He spoke about a tool the Broward County Water Advisory Board came up with called "Document the Floods" in which residents of Broward County can upload flood photos and it assists Broward County in assessing flooding issues. He drove though his district during the rains, and he saw there wasn't any water in the streets, since the new drains were put in. He also spoke about the DIAB meeting on April 18<sup>th</sup>, 2023 and will be discussing the SW 54<sup>th</sup> Place drainage project. He stated he will personally go around and knock on the 15-16 doors to advise the residents about what will be taking place. He spoke about Florida Power and Light installing underground lines in Green Meadows and he's concerned the power boxes will be too close to the water level.

Mayor Breitkreuz spoke about the uptick in noise complaints, and he advised he would like to revisit the noise ordinance. He suggested having a workshop with resident input. He also spoke about the Town's home-based business ordinance and would like to align it with the State's home business ordinance. He reminded the residents to make sure they remove their key fobs, lock their car doors and bring in any mail by 9:00PM every night.

# 9. Legal Comments

Town Attorney Poliakoff requested a printout of the noise ordinance be provided to the Town Council so they may begin looking it over and suggest changes. He also said he would speak to Town Planner Jeff Katims, who drafts the comporting ordinances on the home-based businesses and ask him to bring it forward for a future meeting. Next, he congratulated Davie Police Office Jeff Hobales on his retirement and thanked him for his service to the Town. He congratulated Town Financial Administrator Lopez, Town Controller Rich Strum as well as the Finance Team on a job well done with the Annual Comprehensive Financial Report. Lastly, he congratulated the Sikh Society on an incredible 5k which raised \$11,000.00 for the Town Scholarship.

### **10.** Administration Comments

Town Administrator Berns spoke about the heavy rains South Florida had been experiencing and how guickly areas of the Town that had been part of drainage projects had drained and provided photos of the areas. He thanked Public Works Director/Town Engineer Rod Ley, the Public Works Team, the Drainage and Infrastructure Advisory Board as well as the Town Council for their input and hard work to help the Town's drainage issues. He congratulated Town Financial Administrator Lopez and the Finance Team for the successful Annual Comprehensive Financial Report that was presented by the Town's auditors. He advised Budget Season is underway and all the department meetings have been completed and it's up to the Finance Team to analyze the information received and schedule the one-on-one meetings with Town Council. He wished Davie Police Officer Jeff Hobales all the best on his retirement and thanked him for his service to the Town. He then welcomed Davie Police Detective Eddy Velasquez who will replace Officer Hobales as the Town's Police Detective. He advised the Town had received the speed sign that will be fixed in place, and he suggested it be placed at the North end of SW 186<sup>th</sup> Avenue close to Griffin Road which seems to be a big problem due to drivers using SW 185<sup>th</sup> Avenue and SW 186<sup>th</sup> Avenue as a cut through. He asked for the Town Council's direction on the placement. Mayor Breitkreuz felt it was a great location, he just didn't want it too close to Griffin Road.
