Debbie Green motioned to accept the minutes from February 13, 2023. Page Giaicin seconded. The motion carried.

Jennifer Montgomery motioned the twenty-four scholarship recipients receive \$1,700 each and the balance of \$5,000 sit as reserve for next year. Selena Hodgers seconded. The motion carried.

Discussion Items:

- Treasurer's Report: Debbie gave a detailed report and submitted it to the liaison. \$45,382.45 is the current balance of the scholarship fund. She reminded board members to submit receipts for reimbursement.
- There are twenty-four applicants for this year's award. Each will receive a \$1,700 check upon proof of enrollment. The rest (\$5,000) will sit as reserve. The Board and Council spent the bulk of the meeting reading each applicant's essay submission. Scholarship awards will be presented on the night of the June 22nd council meeting.
- The Board will hiatus in July. The next meeting will be on August 14th.
- Topics per next year: no more flamingo flocking, continue the barn dance and Unity in Diversity Run, think about other potential fundraising events, increase support of our community's schools.

The meeting concluded at 8:30pm.
