

**RESOLUTION NO. 2002-22**

**A RESOLUTION OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING A STUDY FROM CONSULTANT HUGHES HUGHES, INC. ON TRAFFIC CALMING DEVICES FOR SW 185 WAY / SW 186 AVENUE AND APPROVING THE IMPLEMENTATION OF TRAFFIC CALMING TECHNIQUES; AND AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND TOWN ATTORNEY TO EXECUTE SAID AGREEMENT; AND PROVIDING AN EFFECTIVE DATE THEREFOR.**

**WHEREAS,** at the Town Council meeting of July 12, 2001, the Town Council approved Agenda Item #10, Resolution 2001-78, authorizing Hughes Hall, Inc. as the Town traffic engineer, to provide traffic calming studies; and

**WHEREAS,** Molly Hughes, the representative for the consultant, Hughes Hall, Inc., has considerable experience in preparing traffic calming studies; and

**WHEREAS,** it is deemed in the best interest for the welfare and safety of the residents of the Town that these studies be conducted; and

**WHEREAS,** the studies include drawing of roadway sketches, creating workable traffic calming solutions, specific location of traffic calming devices, and estimated cost to implement; and

**WHEREAS,** the consultant, through four specific neighborhood meetings, has developed a consensus for the type of traffic calming techniques that will be both effective and acceptable for the residents.

**NOW, THEREFORE, BE IT RESOLVED,** by the Town Council of the Town of Southwest Ranches, Florida:

**Section 1:** The above referenced recitals are true and correct and are incorporated herein by reference.


**Section 2:** The Town Council approves the report and drawings submitted by Hughes Hall, Inc., to provide traffic calming techniques for 185 Way/186 Avenue.

**Section 3:** The Town Council authorizes the Town Administrator to implement the traffic calming techniques recommended.


**Section 4:** The Town Council authorizes the Town Administrator to commence additional traffic studies throughout the Town, and to bring back to the Town Council the results of the studies and potential solutions on an expedited basis.

**Section 5:** That this Resolution shall become effective immediately upon its adoption.


