RESOLUTION NO. 2002-33

A RESOLUTION OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING AN INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR TRAFFICWAY BEAUTIFICATION FOR GRIFFIN ROAD FROM SW 160 AVENUE TO SW 186 AVENUE; AUTHORIZING THE MAYOR. TOWN ADMINISTRATOR AND TOWN ATTORNEY TO EXECUTE SAID AGREEMENT; PROVIDING AN EFFECTIVE DATE THEREFOR.

- **WHEREAS,** the Town Council approved Resolution #2002-3 on October 11, 2001, which transferred all trafficways within the boundaries of the Town to the town excluding Griffin Road; and
- **WHEREAS,** Griffin Road, from SW 160 Avenue to SW 186 Avenue, is a trafficway located within the boundaries of the Town and is classified as a County Road; and
- **WHEREAS,** Broward County is responsible for the construction and maintenance of Griffin Road; and
- **WHEREAS,** it is of mutual benefit to the residents of County and Town to beautify Griffin Road; and
- **WHEREAS,** Broward County has expressed a desire to provide the installation of irrigation and landscaping on Griffin Road from SW 160 Avenue to SW 186 Avenue; and
- **WHEREAS,** the Town has expressed its desire to undertake the maintenance of the beautification of Griffin Road following the appropriate completion of installation of the irrigation and landscaping.
- **NOW, THEREFORE, BE IT RESOLVED,** by the Town Council of the Town of Southwest Ranches, Florida:
- **Section 1:** The above referenced recitals are true and correct and are incorporated herein by reference.
- <u>Section 2:</u> Authorization. The Mayor, Town Administrator and Town Attorney are hereby authorized and directed to enter into and execute an Interlocal Agreement with Broward County for Trafficway Beautification along Griffin Road from S.W. 160 Avenue to S.W. 186 Avenue, substantially in the form as that Agreement attached hereto as Exhibit "A", with such changes as may be

deemed to be necessary and proper by the Town Administrator and Town Attorney to effectuate the intent of this Resolution.

- a) County will provide the installation of irrigation and landscaping on Griffin Road from SW 160 Avenue to SW 186 Avenue.
- b) Town will undertake the maintenance of the beautification of Griffin Road following the appropriate completion of installation of irrigation and landscaping.

Section 3: That this Resolution shall become effective immediately upon its adoption.
