

**RESOLUTION NO. 2002-84**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA REVISING THE POLICY FOR UTILIZING MEMBERS OF THE TOWN COUNCIL IN AREAS OF SPECIAL INTEREST WHEN THE OPPORTUNITY PRESENTS ITSELF, AND THE NEED ARISES; AND PROVIDING AN EFFECTIVE DATE THEREFOR.**

**WHEREAS**, on February 8, 2001, the Town Council adopted Resolution 2001-25 which established the authority of the Town Administrator to request the assistance of members of the Town Council to assist the Town Administrator; and

**WHEREAS**, the public interest would be best served by having the Town Council members who possess special knowledge or skills in areas of his/her expertise or interest to assist the Town Administrator; and

**WHEREAS**, due to the change in individual Town Council members, the policy adopted on February 8, 2001 needs to be revised to address the changes in knowledge, skills and interests of the Town Council.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida.

**Section 1:** The above referenced recitals are true and correct and are incorporated herein by reference.

**Section 2:** The Town Administrator shall have the authority to request the assistance of the members of the Town Council, who possesses special knowledge or skills in areas of his/her expertise or interest, to assist the Town Administrator in addressing the pending need or issue.

**Section 3:** The Town Administrator requests the following assistance:

Mayor, Mecca Fink – Public Safety –Law Enforcement and Fire/Rescue

Council Member, Forest Blanton – Education; Communication;  
Comprehensive Plan Code Implementation


Council Member Freddy Fisikelli – Public Works – Drainage and Fill;  
Environmental Issues; Griffin Road Expansion Project

Council Member Aster Knight – Parks; Planning and Zoning


Council Member Don Maines – Public Works – Roadways and Trails;  
Transportation – Traffic Calming, Mass Transit, I-75
