

RESOLUTION NO. 2004- 103

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, SETTING THE PROPOSED MILLAGE RATE PURSUANT TO SECTION 200.065(2)(b), FLORIDA STATUTES, AND REVISING THE DATE, TIME AND PLACE AT WHICH PUBLIC HEARINGS WILL BE HELD TO CONSIDER THE PROPOSED MILLAGE RATE AND THE TENTATIVE BUDGET; AND DIRECTING THAT A CERTIFIED COPY OF THIS RESOLUTION BE SENT TO THE BROWARD COUNTY PROPERTY APPRAISER AND TAX COLLECTOR; AND PROVIDING AND EFFECTIVE DATE.

WHEREAS, Section 200.065, Florida Statutes, provides that a taxing authority shall advise the Property Appraiser and Tax Collector of its proposed millage rate, its current year rolled-back rate and of the date, time and place at which a public hearing will be held to consider the proposed millage rate and the tentative budget; and

WHEREAS, pursuant to Section 200.065(2)(b), Florida Statutes, the taxing authority must advise the Property Appraiser of said proposed millage rate and of the date, time and place at which a public hearing will be held to consider the proposed millage rate and the tentative budget for the preparation of the Notice of Proposed Property Taxes (TRIM Notice).

WHEREAS, the Resolution adopted on July 8, 2004 was found to include a scheduling error and the Town wishes to revise and to re-notice the public hearing dates.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida, as follows:

Section 1. The proposed property tax millage rate of the Town of Southwest Ranches for fiscal year 2004/2005 shall not exceed 3.000 mils. The rollback rate is 2.6477.

Section 2. The date, time and place of the public hearings to consider the above proposed millage rate and tentative budget shall be as follows:
