RESOLUTION NO. 2005 – 036

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF **APPROVING** FLORIDA AN SOUTHWEST RANCHES, AGREEMENT WITH EARTH ADVISORS, INC. TO PERFORM THE SERVICES DELINEATED IN THE OCTOBER 14, 2004 MITIGATION AND PARTNERSHIP AGREEMENT BETWEEN THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT ("SFWMD") AND THE TOWN; PROVIDING THAT THE TOWN'S COSTS ASSOCIATED WITH THIS AGREEMENT SHALL NOT EXCEED THE AMOUNT OF THE SFWMD CONTRIBUTION AND ANY ASSOCIATED COST RECOVERY FEES THAT MAY BE OBTAINED BY THE TOWN; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR, AND TOWN ATTORNEY TO ENTER INTO THE AGREEMENT; AND **PROVIDING AN EFFECTIVE DATE.**

WHEREAS, in furtherance of helping to preserve the Everglades, the federal government has adopted the Everglades Restoration Act; and

WHEREAS, part of the Act requires a buffer area to be established to assist in proper drainage and to maintain water quality; and

WHEREAS, part of the designated buffer area resides in the Town; and

WHEREAS, several properties within the designated buffer area have been found to be in violation of certain environmental requirements; and

WHEREAS, in order to bring these properties into compliance, the affected property owners must create wetland mitigation areas; and

WHEREAS, several of the Town's parks require the construction of wetland areas; and

WHEREAS, in an attempt to have no financial impact on the Town, the Town has sought creative ways to fund the design and engineering of the Town's wetland areas; and

WHEREAS, since the South Florida Water Management District ("SFWMD") has been mandated to bring the violating properties into compliance, it has offered to enter into a Mitigation Partnership Program with the Town that would offer violating property owners an opportunity to work with the Town to create wetland mitigation areas and in exchange the SFWMD would provide the Town with \$214,700 to fund the design and engineering of the designated wetland areas; and

WHEREAS, in furtherance of its June 22, 2004, procurement, the Town desires Earth Advisor's, Inc. to perform the work associated with its Mitigation Partnership Agreement; and

WHEREAS, the costs for Earth Advisors' services shall not exceed the amount of the SFWMD contribution and any associated cost recovery fees that may be obtained by the Town for management of the construction of the wetlands.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

Section 1. The above referenced recitals are true and correct and are incorporated herein by reference.

Section 2. In furtherance of Resolution 2005-003, the Town Council hereby approves the Agreement between the Town of Southwest Ranches and Earth Advisors, Inc., in substantially the same form as that attached hereto as Exhibit "A", to perform the services delineated in the Town's October 14, 2004 Mitigation Partnership Agreement with the South Florida Water Management District.

Section 3. The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney to enter into an Agreement in substantially the same form as that attached hereto as Exhibit "A" and to make such modifications, additions and/or deletion which they deem necessary and proper to effectuate the intent of this Resolution.

Section 4. That this Resolution shall become effective immediately upon it adoption.
