## **RESOLUTION NO. 2005 - 080**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA APPROVING SELECTION OF DIG IT TRACTOR SERVICES, INC. FOR TRAFFIC CALMING DEVICES ON 172 AVENUE; APPROVING AN AGREEMENT WITH DIG IT TRACTOR SERVICES, INC. FOR SAID SERVICES; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND TOWN ATTORNEY TO ENTER INTO AGREEMENT NOT TO EXCEED \$35,000; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Town has conducted a traffic engineering study on 172 Avenue, and the results have revealed that traffic calming is merited; and

**WHEREAS,** the safety and welfare of the residents of 172 Avenue is of great importance to the Town Council; and

**WHEREAS**, the Town Council has approved the installation of traffic calming devices on 172 Avenue; and

**WHEREAS,** the Town duly advertised and received three (3) proposals for the project; and

**WHEREAS**, the Town Administrator recommends that the contract be awarded to Dig It Tractor Services, Inc.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:

- **Section 1.** The above referenced recitals are true and correct and are incorporated herein by reference.
- **Section 2.** The Town Council hereby approves the recommendation of the Town Administrator and selects, Dig It Tractor Services, Inc. to provide traffic calming devices on 172 Avenue for an amount not to exceed \$35,000.
- **Section 3.** The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney to enter into an Agreement containing substantially the same terms as that attached hereto as Exhibit "A" and to make such modifications, additions and/or deletions which they deem necessary and proper to effectuate the intent of this Resolution.

**Section 4.** This Resolution shall become effective immediately upon its adoption.
