A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA APPROVING AN EXPANDED AGREEMENT WITH BECKER & POLIAKOFF, P.A. TO PROVIDE LEGISLATIVE AND LOBBYING SERVICES FOR THE TOWN OF SOUTHWEST RANCHES; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR, AND TOWN ATTORNEY TO ENTER INTO THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Legislative and County initiatives can have a significant economic impact upon a municipality, ranging from growth management to appropriations; and

WHEREAS, in order to promote and protect its interests, the Town Council finds it to be in the Town's best interest to engage the services of government relations professionals, individuals who can monitor the legislative process and advocate the Town's legislative priorities; and

WHEREAS, the Law Firm which the Town has engaged to provide its general legal services has a team of dedicated government relations attorneys who are experienced advocates in the field and can provide the Town with the services it requires.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

Section 1. The above referenced recitals are true and correct and are incorporated herein by reference.

Section 2. The Town Council hereby approves an Expanded Agreement between the Town of Southwest Ranches and Becker & Poliakoff, P.A., to perform legislative and lobbying services for the Town at a flat rate of \$35,000 per year, in accordance with the attached proposal of September 7, 2005, submitted by Bernie Friedman, Chair, Becker & Poliakoff, P.A. Government Practice Group.

Section 3. The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney to enter into an Agreement and to make such modifications, additions and/or deletions which they deem necessary and proper to effectuate the intent of this Resolution.

Section 4. That this Resolution shall become effective immediately upon it adoption.

Dear John:

Over the last several years our Firm has successfully provided excellent oncall State Legislative and Executive Branch professional government relations services to the Town of Southwest Ranches. During this time we have worked diligently on issues related to various Local Bills, De-Annexation - Annexation Bills, Florida Recreation Development Assistance Program budget appropriations, and most recently, issues related to roads and road closures.

As the number and complexity of local government issues in Tallahassee has grown, more and more municipalities are utilizing the services of professional government relations consultants. In Broward County alone, most local governments have several on-call professionals. Some of the smallest municipalities have invested the most and other cities, like those adjoining Southwest Ranches, have up to ten registered lobbyists. Issues related to growth management, affordable housing, control over local roads, open space, water management/storm water, eminent domain, rural lifestyle, and hundreds of other municipal issues are debated each year in Tallahassee. Tallahassee Committee Meetings and Hearings begin later this month and represent the start up for the 2006 State legislative Session. 1. <u>The Becker-Poliakoff Team</u>

2. Past Successes for Southwest Ranches

Most recently during the 2005 Legislative Session, the Becker & Poliakoff, P.A. team overwhelmingly defeated a last minute attempt to enact language that would have disallowed a municipality to close roads within it own boundaries. During the final week of Session the onerous language was Amended onto SB 1184 by the Pembroke Pines lobbyists. This was a significant Bill relating to Transportation Access sponsored by Sen. Mike Fasano. The Amendment was adopted while the Bill was on Second Reading on the Senate Chamber floor. Our team was able to successfully lobby Sen. Fasano to remove the language from his Bill, which the Senate would have passed without opposition when it was brought up on it 3rd Reading. Our team also blocked attempts to Amend this damaging language onto HB 351, the House companion to SB 1184. We quickly organized a coalition of friendly Legislators, led by Rep. Susan Goldstein, to fight for SW Ranches. Pembroke Pines worked the Delegation hard and had a team of over 10 regislative process to deal with this local issue.

Our team also worked hard to educate Legislators on the importance of the FRDAP program. The Town of Southwest Ranches' proposal for Meadows Sanctuary was ranked well, but needed the Legislature to allocate funding. In the end we successfully got \$200,000 allocated. We worked hard all Session during the intense budget negotiations to ensure that enough money was in the overall FRDAP line item to fund the Meadows Sanctuary.

> In 2004, the Becker & Poliakoff, P.A. team worked on the passage of the proposed Deannexation/Annexation language developed between the City of Cooper City and the Town of Southwest Ranches, then under the assigned bill numbers of HB 1415 and SB 3170. With all the internal Delegation issues resolved, the Becker & Poliakoff, P.A. team was successful in passing HB 1415, while employing the same strategy that was attempted during the previous Session.

> Also during the 2004 Session, the team worked to secure funding for the Sunshine Ranches Equestrian Park Phase III project, which at #70 on the list was ranked lower than it was during the previous year. Our team advocated for an amount of overall FRDAP funding that would include the Equestrian Park project at its established ranking. The legislature allocated \$21,000,000 to the FRDAP program, \$200,000 of which was awarded to the Sunshine Ranches Equestrian Park project. Without our advocacy and getting more money into the total pot, this project would never have been funded.

During the 2003 Session, the Becker & Poliakoff, P.A. lobbying team worked to pass HB 1547 and SB 2918 relating to proposed language for a De-annexation/Annexation of lands between the City Cooper City and the Town of Southwest Ranches. Rep. Gottlieb and Sen. Geller sponsored the Bills. As was the usual process for Local Bills, each Local Bill was supposed to move through the Committee process in the House and be passed by the House Chamber. The Senate Chamber would pass the Bills by a waiver of the Senate Rules. Our efforts resulted in the passage of HB 1547 by the House as planned. Unfortunately, an internal Broward delegation fight erupted, which resulted in all Local Bills failing to pass. Due to our hard work, everyone assured us that the Bills would pass in 2004; which they did.

The Becker & Poliakoff team also worked to secure funding for the Sunshine Ranches Equestrian Park Phase III project during the 2003 Session. We worked hard to get money allocated, but this was a particularly onerous budget year and many projects did not get funded. Once again, we set the stage for funding in 2004, and were successful that year.

3. <u>Provided below are a list of Becker & Poliakoff's other local government clients</u> including summaries of our legislative successes and contact information for reference purposes.

The Becker & Poliakoff Lobbying Team has successfully provided services similar to those requested by Southwest Ranches to an impressive array of local governments and private sector organizations. interests and articulating the position of Town officials during the drafting and deliberation process; 3) supporting Town officials in the preparation and presentation of their legislative agenda(s), proposal(s), amendment(s), and proviso language; 4) assisting Town officials develop legislative strategy in order to advance the Town's goals or amend or defeat proposals adverse to them as well as providing pro-active recommendations for future actions; 5) reviewing the plans of other entities to identify issues that the Town can support or may need to oppose; 6) scheduling meetings and visits with legislators, administration officials, and staff in order to strengthen relationships and thereby facilitate the Town's requests; 7) furnishing an analysis on an ongoing of the political context in which decisions affecting the Town will be made; 8) working with County officials to identify and pursue government grants and other funds to assist the Town meet its fiscal challenges.

Becker and Poliakoff, P.A. has represented the City of Opa-Locka for six years and the contract is renewed on an annual basis.

Beginning in January of 1999, the firm developed and coordinated a legislative agenda with the City of Opa-Locka including meetings with Commissioners and City staff, legislators, committee staff, and the Executive. The Firm distributed the legislative agenda then provided the appropriate follow-up with legislative leaders and allies on key committees during the session including close coordination with in the Executive Branch. In our first year, we had excellent success including significant funding for various City priorities and most significantly, Opa-Locka was named as a Front Porch Community. This designation as a Front Porch Community gives the City priority in state funding for a variety of initiatives and technical assistance from state agencies to help the City implement their programs wisely and efficiently. The Front Porch Initiative required a tremendous lobbying effort from the Firm and included several meetings with the Governor and his staff and even a tour of the affected areas in Opa-Locka by State staff. In addition, the firm played a key role in submitting the Front Porch application to the state.

The City of Opa-Locka works closely with the Miami Dade County Legislative Delegation year round including providing a comprehensive legislative plan and funding request long before the beginning of the session, which enabled the Delegation to assist the City more effectively in achieving its legislative goals. In 2004, the City requested funding for eleven water related projects. The City will receive \$450,000 of the lump sum

> provided to the South Florida Water Management District to fund the water requests. Additionally, the team was able to have a portion of 42 Avenue in Opa Locka designated Sidney Alterman Way, one of the City's primary priority for the session. Regarding the Water Project Local Match Special Exemption, the Becker & Poliakoff, P.A. governmental team conceptualized and, in turn, instituted proviso language within the 2005-2006 Legislative budget that creates a special exemption for cities declared in a financial state of emergency. Such cities are provided an exemption from the required 25 percent local match for wastewater projects, and the 50 percent match for storm water and surface water restoration projects.

In 2004, the team assisted with the passage of HB 1415, the local bill on the de-annexation of land from Cooper City to the Town which was passed in the final week of session.

Contract in place since 2001. Becker & Poliakoff, P.A. has worked closely with the City and its key staff members over the last three years to: 1) raise the City's visibility among local legislators and key members of the legislative leadership; 2) identify and examine legislation that is of concern to the City and develop strategies on how to combat or rework them into language more suitable to our needs; 3) advocate legislation and funding to support the City's legislative priorities and projects.

We have worked hard to obtain "Active Representation" from our legislators for our legislative priorities. Active representation is important to ensure legislators are attuned to our issues and interests and have a personal desire to act on our behalf. We have been successful in many instances in gaining active representation or a legislative "champion" by providing feedback and information to the member, in conjunction with having personal interaction with them. Together we have worked hard to communicate with our legislative delegation so they are confident and comfortable with our issues including a solid knowledge base that includes and supports the City's views. Together, we have provided them with the information critical to aiding the City's position on legislation. We have been candid in letting them know how they are doing, right or wrong and forthcoming in giving them recognition for supporting the City's view on certain bills or opposing certain bills. Legislators appreciate getting feedback and information on where the City stands on various issues and it provides them with the tools necessary to better represent the City's interests. Additionally, we have worked hard to develop personal relationships between City officials and legislators by including legislators in various City events and having them participate in City functions and meet City staff. Moreover, our carefully planned visits to Tallahassee by City officials to meet with members of the legislature demonstrated the City's commitment to positive and mutually beneficial working relationships with legislators.

Examples of Legislative Priorities Achieved Over the Last Three Years:

•When the initial ranking list came out for the Florida Recreation Development Assistance Program (FRDAP) funding, we recognized that the Westgate Park project had a fairly high ranking to receive \$200,000. However, unlike the library money, there was not agreed upon amount for the budget allocation between the two houses. Ultimately, our lobbying efforts, in cooperation with those representing other potentially funded municipalities, solidified a funding amount that covered the Westgate Park project.

•After a great deal of effort, discussion and dissension by many City officials and lobbyists, Broward's local bills including the City's local bills for annexation (HB 1931, HB 1935, HB 1937) passed during the final week of Session. Unfortunately, despite an overwhelming campaign to secure the Governor's approval, the annexation bills were vetoed by Governor Bush in 2004.

•In previous years, Ms. Jackson worked throughout the Summer with the Broward County Legislative Delegation's re-constituted Annexation Sub-Committee which held a series of hearings around the County and attempted to put together one comprehensive Annexation Bill. Lauderdale Lakes was a good neighbor to the adjoining landowners and tried to accommodate their desires and aspirations. We spent a significant amount of time and energy to try to develop a comprehensive bill, both at the County and in Tallahassee. In the end, the effort to pass a single Bill failed.

Regarding Lauderdale Lakes' Appropriation priorities, despite several Special Sessions dealing with budget cuts, the Legislature fully funded Lauderdale Lakes' FRDP grant applications totaling \$200,000 for various parks and recreational projects. Lauderdale Lakes also received \$40,000 funding for emergency management services. However, the governor vetoed the line item. Overall, budget issues were highly contentious and we were fortunate that our priorities were funded.

> The Firm was retained by Florida Memorial College prior to the 2000 legislative session and has worked with them since that time to protect funding of education programs, financial aid and other operational dollars. The primary legislative concern for state colleges and universities is funding. They are dependent upon primarily state funds to operate and be successful. During the last session, there was an attempt to significantly reduce State funding for Access, Recruitment and Retention at the Independent Historically Black Colleges (including Florida Memorial, Edward Waters and Bethune Cookman). Through careful monitoring of the appropriations process, communication with our key allies on the Appropriations committee, and timely (and well orchestrated) communication between University officials and legislators, we were able to prevent the loss of more than \$8 million for the three colleges. Florida Memorial would have lost \$2.3 million or 8% of its total budget. Ms. Jackson worked closely with the Governor's staff on all HBCU budget issues.

Due to the outstanding results for Florida Memorial College, Ms. Jackson now represents Bethune Cookman College and Edward Waters College. Each school received no budget cuts and obtained \$4.1 and \$3.6 million in funding for 2002 and 2003. In addition, Ms. Jackson spearheaded the funding effort for Florida A&M where they received more than \$10 million in new funding. Ms. Jackson also worked with the Governor's staff to secure two additional grants for all of the Historically Black Colleges totaling more than \$1.2 million. In fact, funding for Historically Black Colleges has increased more than 50% since Ms. Jackson began representing them in Tallahassee.

> Successful in fending off a bill that would have provided for the creation of juvenile drug courts and turned funding decisions for MMAP's Teen Court program over to the Chief Judge of each county. This legislation was strongly opposed on behalf of MMAP. In fact, MMAP's executive Director, Vincent Brown traveled to Tallahassee and met with the chair of the author of the legislation, Rep. Gus Barreiro. While Rep. Barreiro agreed to include language in the bill to attempt to remedy MMAP's concern, the bill never garnered a Senate companion and was opposed by other advocacy groups. During the 2004 session, the Becker & Poliakoff, P.A. lobbying team helped pass two important annexation bills for the City. HB 1409, which provides for the annexation of the unincorporated area known as Pompano Highlands into the City limits of either the City of Pompano Beach or the City of Deerfield Beach. Through the use of Chapter 171 annexation, a referendum will enable the registered voters of that area to decide which City they would prefer to be annexed into.

Our team also passed HB 1417 during the 2004 Legislative Session. This bill also uses the provisions of Chapter 171 annexation; however, in contrast to the previous bill, a referendum will not be necessary and 533 acres of land will be annexed into the City of Pompano Beach. The City will see an addition of over 7,500 citizens and 3,300 housing units with the annexation of this area. Over the last few years, the MDX lobbying team has been able to accomplish most of its stated legislative priorities for the agency including passage of a major transportation bill including favorable language relating to Public/Private Partnerships, the Strategic Intermodal System and the Metropolitan Planning Organizations. Additional the Prompt Pay and Bond Form provisions were defeated.

Enterprise Zone (SB 1358) – Passed by Legislature and Signed by Governor Succeeded in passing bill to provide tax breaks and other incentives to encourage business development in depressed areas. Miami Dade County requested a certain community be designated as an Enterprise Zone. It had been attempted several times before but providing state funding to specific areas is always a difficult task to achieve because of competing legislators' interests. However, through our strong relationships with legislative leaders, we were able to help pass the legislation. In fact, in last week of

session our lobbyists were successful in getting this item on Consent Calendar which waived the rules and thereby ensured its ultimate passage.

Community Action Agency Youth Leadership Development: Secured \$90,000 in final legislative budget for a program that targets at-risk youth throughout Miami-Dade County. This project exposes many youths to structured activities designed to counter the negative influences they encounter in their environments, which place them at risk. Unfortunately, like many other similar programs, this was vetoed by the Governor.

In 2005, as a part of a group, the Becker & Poliakoff team successfully passed legislation that provided a funding source for teen courts. The language was passed by the legislature as a section of the 2005 Article V revision bill. The legislation establishes a funding source for teen courts through assessment of an up to \$3 additional court cost against each person who pleads guilty or nolo contendere to, or is convicted of, violation of criminal law, ordinance, or traffic offense in county. Through meetings held with various committee chairpersons and leadership, the Becker & Poliakoff team was instrumental in the effort to have the legislation heard by the legislature, and ultimately amended onto the 2005 Article V Revision bill.

Represented Hollywood since 1991 as the Prime Contractor. Contract is renewed annually.

The Becker & Poliakoff, P.A. lobbying team has a proven track record of representing the City of Hollywood in its State lobbying efforts. project, but the Governor line item vetoed the money.

Some notable successes for the City of Hollywood at the State level include:

a) The City of Hollywood was concerned about a bill submitted to the Broward City Legislative Delegation by the City of Dania Beach to annex land that was contiguous to both cities. Hollywood argued that the annexation was premature and without the consent of the residents. After numerous meetings with City officials, residents and legislators, the Broward County Legislative Delegation agreed with the City of Hollywood and postponed action of the annexation until a thorough study can be completed after this year's legislative session. This was a great victory for the City of Hollywood's long-time struggle to protect its tax base and strengthen its neighborhoods.

b) The City identified beach erosion and Renourishment as its number one priority legislative issue. The Firm worked closely with other coastal communities and the League of Cities to help draft House Bill 3427 and Senate Bill 856 to establish the Ecosystem Management and Restoration Trust Fund and provide for permanent, long term funding through a trust fund to fully implement the beach management plan. After numerous fits and starts and opposition to the permanent funding, the bill passed and Hollywood received \$5 million for beach Renourishment from a dedicated, permanent funding source that cannot be taken away. Needless to say, the City was thrilled to have their number one priority bill pass with real and significant funding. In following years, the City has continued to lead efforts to provide funding for the Broward County Beach Restoration project through the Florida Department of Environmental Protection. Follow up and advocacy with the state agencies is a critical component to successfully implementing legislative actions.

c) The City identified a problem with their ability to implement its Water Re-Use program due to the lack of legislative authority and complicated regulatory process municipalities were facing when attempting to operate such a worthwhile program. The Firm stepped in and drafted legislative language to solve the problem and had the bill introduced in the House and Senate. The next step was to build support for its passage by

having key members of the Legislature understand the problem and its potential legislative solution. The Firm was instrumental in having the House of Representatives' Select Committee on Water Policy visit the City of Hollywood's water re-use facility and hear from City officials about the need for this legislation. Ultimately, the Alternative Water Supplies legislation passed the Legislature and has significantly improved the City's ability to implement its reclaimed water program and thus saving the City thousands of dollars.

4. **Pro-Active Approach to Lobbying**

The lobbying methodology of the Team is based on its extensive and successful lobbying experience of the Firm and its individual team members. That experience is especially focused on representing municipalities and other governmental entities in Tallahassee. Town officials, staff, and others who support the Town's legislative program will be encouraged to become involved in the lobbying process as well as. An effective lobbying methodology includes the following interrelated components:

<u>Preparation.</u> We will work closely with Town leaders to develop a legislative priority program that reflects the needs of the Town. We coordinate legislative workshops to help identify and develop their priorities. We will work with the Town to convert the legislative priorities into a specific list of action items with an appropriate public affairs strategy based on many factors, such as the committee assignments of key legislative allies and the priorities of the legislative leadership. Preparation will also include guidance on the drafting of legislation, budget requests, presentation materials, amendments, proviso language, etc. We also set up one on one meetings with every member of the legislative delegation to get their input and buy-in into the Town's agenda. Our lobbyists have pre-existing excellent relationships with every member.

Intelligence and Communication. Effective lobbying teams gathers competitive intelligence using three key principles: legal knowledge, experience and access. The Becker & Poliakoff, P.A. team utilizes each to benefit their clients. 5. <u>Summary and Proposed Fees for Services</u>

We would respectfully request a monthly fee of \$2,916.66 or \$35,000 on an annual basis. This is discounted significantly as a professional courtesy in recognition of our Firm's work for the Town. We would suggest starting work in September, as Committees will be hearing Bills later this month and Amendments could be filed.
