WHEREAS, on March 15, 2006, at 3:30 PM, the Town opened the one (1) response that it received from Government Services Group; and

WHEREAS, the bid proposal received from Government Services Group, was for \$48,900.00; and

WHEREAS, the Town's Selection and Negotiation Committee has concluded that Government Services Group is a responsive bidder; and

WHEREAS, the Town is desirous of entering into an agreement with Government Services Group for a Fire/Rescue and Law Enforcement Feasibility and Funding Options Study,

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

Section 1: The above referenced recitals are true and correct and are incorporated herein by reference.

Section 2: The Town Council of the Town of Southwest Ranches hereby awards the Town's procurement for a Fire/Rescue and Law Enforcement Feasibility and Funding Options Study to Government Services Group.

Section 3: The Town Council hereby approves the Agreement, attached hereto as Exhibit "A", between the Town of Southwest Ranches and Government Services Group, for a Fire/Rescue and Law Enforcement Feasibility and Funding Options Study, for an amount not to exceed \$48,900.00.

Section 4: The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney to enter into an Agreement in substantially the same form as that attached hereto as Exhibit "A" and to make such modifications, additions and/or deletions which they deem necessary to effectuate the intent of this Resolution.

Section 5: This Resolution shall become effective immediately upon its adoption.

FIRE/RESCUE AND LAW ENFORCEMENT FEASIBILITY AND FUNDING OPTIONS STUDY AGREEMENT

THIS IS AN AGREEMENT made and entered into by and between the Town of Southwest Ranches, municipal corporation of the State of Florida, hereinafter referred to as "Town" and Government Services Group, Inc., hereinafter referred to as "Consultant"

WHEREAS, on February 26, 2006, the Town, in compliance with the Town's procurement procedures, published a Request for Proposal ("RFP") seeking a Fire/Rescue and Law Enforcement Feasibility and Funding Options Study; and

WHEREAS, on March 15, 2006, at 3:30 PM, the Town opened the one (1) response that it received from Government Services Group; and

WHEREAS, the bid proposal received from Government Services Group, was for \$48,900.00; and

WHEREAS, the Town's Selection and Negotiation Committee has concluded that Government Services Group is a responsive bidder; and

WHEREAS, the Town is desirous of entering into an agreement with Government Services Group for a Fire/Rescue and Law Enforcement Feasibility and Funding Options Study,

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

Section 1: Scope of Services

Upon execution of this Agreement, the Consultant shall immediately commence to identify, analyze, review and recommend to the Town, through coordination with the Town Administrator, the Fire/Rescue and Law Enforcement Feasibility and Funding Options Study services, per Exhibit "A" Scope of Services.

Section 2: Compensation

2.1 Compensation is to be based upon a proposed fee of Forty Eight Thousand Nine Hundred Dollars (\$48,900). Invoices will be submitted on a weekly basis and payment will be made within 10 working days.

2.2 Reimbursable Expenses-

Town and Consultant agree that Consultant's out of pocket expenses, approved by the Town Administrator or designee will be reimbursed at cost.

Section 3: Term

Town and Consultant agree that the Term of this Agreement shall commence upon the execution of this Agreement by both parties and will end no later than July 30, 2006, unless terminated earlier pursuant to Section 5 hereof. Based upon the mutual agreement of both parties, the Term of this Agreement may be extended.

Section 4: Termination

Either party may terminate this Agreement without cause by written notice, sent by U.S. Certified Mail, Return Receipt Requested, to the other party at the address set forth in Section 6 hereof, effective fifteen (15) days after the delivery of said notice. Said compensation as determined herein shall be prorated accordingly, and shall be paid within thirty (30) days of termination.

Section 5: Notices

All written correspondences shall be addressed as follows, unless a party otherwise gives notice to the other party of such other address:

Section 6: **Relationship**

The consultant shall perform all of the services enumerated in this Agreement solely as an independent contractor, and not as an employee of the Town. The Consultant, as directed by the Town Administrator, shall be responsible for directing its efforts as to the manner and means of accomplishing the work to be performed hereunder by Consultant, pursuant to good and workmanlike practices. The priority, order, performance of services or safety practices shall not effect Consultant's status as an independent contractor and shall not relieve Consultant of the obligations assumed under this Agreement.

Section 7: Subcontracting

All substantive work to be performed pursuant to the terms of this Agreement shall be performed by Consultant, and no work shall be subcontracted to other parties or firms by Consultant without the prior consent of the Town.

Section 8: **Ownership Rights**

All work performed and materials created under this Agreement shall be considered work product and shall be the exclusive intellectual property of the Town.

Section 9: Entire Agreement

This Agreement incorporates and includes all prior negotiations and understandings applicable to the matters contained herein. The parties agree that this Agreement constitutes the entire understanding and Agreement between the parties and supersedes previous agreements and representations whether written or oral.

Section 10: Construction

This Agreement has been a joint effort of the parties, and the resulting documents shall not, solely as a matter of judicial construction, be construed more severely against one of the parties than the other. The headings used in this Agreement are for convenience only and shall not be considered as part of this Agreement in any respect nor shall they in any way affect the substance of any provisions contained in this Agreement.

Section 11: Further Assurances

Town and Consultant agree to execute, acknowledge, and deliver, and cause to be done, executed, acknowledged, and delivered, all such further documents and perform such acts as shall be requested of it to carry out this Agreement and give effect hereto solely consistent with applicable Federal, State and local laws, rules or regulations. Accordingly, without, in any manner, limiting the specific rights and obligations set forth in this Agreement, the parties declare their intention to cooperate with each other in effecting the terms of this Agreement.

Section 12: Counterparts

This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original but all of which shall constitute the same Agreement.

Section 13: No Amendment or Waiver

This Agreement may not be changed, altered, or modified except by an instrument in writing signed by all parties from whom enforcement of such change would be sought.

Section 14: Severability

In the event any term or provision of this Agreement shall be determined by appropriate judicial authority to be illegal or otherwise invalid, such provision shall be given its nearest legal meaning or be construed to be in full force and effect.

Section 15: No guarantee

Both parties agree that signing of this Agreement does not guarantee funding of a specific grant, however, the Consultant shall provide the highest degree of professional media and public relations.

Section 16: Applicable Law and Venue

This Agreement shall be interpreted and construed in accordance with and governed by the laws of the State of Florida. Venue for litigation concerning this Agreement shall be in Broward County, Florida.

Section 17: Enforcement; Costs

The Town and Consultant are the beneficiaries of this Agreement and as such, may enforce this Agreement by action at law or in equity. The prevailing party in any such action shall be entitled to reasonable attorneys' fees and costs at all tribunal levels. IN WITNESS WHEREOF, this Agreement is accepted and executed on the 6^{th} day of April, 2006.

(GSG) related to the Fire/Rescue and Law Enforcement Feasibility and Funding Options Study. The revised scope of services is based on our discussions with the Public Safety Selection and Negotiation Committee (Committee) at the meeting on March 28, 2006.

- Task 1:Project initiation and data gatheringThe Project Team will meet with Town officials in a
kick off meeting to finalize the scope of services and obtain all data and information
necessary to complete the scope of services. Such data may include annual budgets,
existing agreements, tax roll and assessment roll information, fire rescue incident data, law

2.3 Based upon the defined level of service, the Project Team will develop the cost of the Town providing the law enforcement services to serve as a baseline for proposals from other providers or to provide an additional option to the Town for service delivery.

2.4 Finally, the Project Team will provide comparative cost estimates of other law enforcement service providers including the Broward Sheriff's Office and the Town of Davie and City of Pembroke Pines (if deemed legally applicable by the Town attorney).

Task 3:Fire Rescue Services The Project Team will conduct several tasks specifically related to fire
rescue services as follows:

3.1 First, the Project Team will identify the benchmarks that will be used to define the Town's current and/or proposed level of fire rescue services such as calls for service, response times, costs per capita and other pertinent criteria.

3.2 Based upon the defined level of service, the Project Team will develop the cost of the Town providing the fire rescue services to serve as a baseline for proposals from other providers or to provide an additional option to the Town for service delivery.

3.2 Next, the Project Team will provide comparative cost estimates of other fire rescue service providers including the Broward County Sheriff's Office Fire Rescue Department, the Town of Davie, the City of Pembroke Pines and the Southwest Ranches Volunteer Fire Department. These costs estimates will be combined to provide seven service delivery and cost scenarios as follows:

- Town of Davie provides fire rescue services in entire Town
- Town of Davie provides fire rescue services on east side of Town and City of Pembroke Pines provides fire rescue services on the west side of Town
- Town of Davie provides fire rescue services on east side of Town and Broward County Fire Rescue provides fire rescue services on the west side of Town with additional unit in Weston
- Broward County Fire Rescue provides fire rescue services in entire Town

- Town of Davie provides fire rescue services on east side of Town and Broward County Fire Rescue provides fire rescue services on the west side of Town with additional unit in SW Ranches
- SW Ranches provides fire rescue services in entire Town with fully paid staff

- Task 4:Provide analysis of funding optionsThe Project Team will provide a written analysis of

The Project Team will research applicable case law, statutory requirements and any other pertinent criteria to identify all feasible sources of alternative funding to support the fire rescue and law enforcement services. To the extent that revenue sources are available, the Project Team will provide a strategy or examples of legally defensible methodologies for implementing such funding.

- Task 5:Update current special assessment study for fire servicesThe Project Team will update the
current special assessment study for fire services. The Project Team will provide
methodology and implementation criteria for selected funding options for rescue and law
enforcement services. The schedule of tasks associated with the fire services study are as
follows:
 - Review the Town's existing legal documents documenting the current assessment methodology, assessment roll summary information, fire call data, agreements, reports and other data pertaining to the provision of fire rescue services.
 - Identify the full cost of the fire rescue service delivery using the Town's most current financial information and allocate the costs between fire and emergency medical services in conformance with the most recent case law. Identify the alternative sources of revenue to fund the service delivery costs and determine the net service delivery revenue requirements.
 - Determine the total fire rescue assessment revenue requirements to ensure the Town recovers the costs of: (a) net fire rescue service delivery revenue requirements, (b) implementing the program, and (c) collecting the assessments.
 - Using the existing assessment roll summary, updated fire rescue incident data and revenue requirements, revise the apportionment methodology and apply to the assessment roll database to test the data validity and legal sufficiency. Revise the apportionment methodology as necessary.
 - Calculate proforma schedule of rates based on the apportionment methodology and revenue requirements for the Fiscal Year 2006-07 assessment program.
 - Prepare and present an assessment memorandum, which documents proposed apportionment methodology and proforma assessment rates.
- Task 6:Coordination and Reporting The Project Team will summarize and present the report,

Dear Mr. Russo,

This correspondence is written to provide the Town of Southwest Ranches (Town) with a second revised scope of services from Government Services Group, Inc. (GSG) related to the Fire/Rescue and Law Enforcement Feasibility and Funding Options Study Agreement dated March 30, 2006. The revised scope of services is based on our discussions with Mayor Fink and yourself on March 20, 2007, and March 22, 2007.

As we discussed, GSG has agreed to revise the current scope of services in order to finalize the fire/rescue and law enforcement studies. First, we will summarize the project to date:

The previously revised scope of services dated March 30, 2006, included the following six tasks:

- The development of the cost of the Town providing fire/rescue and law enforcement services;
- The provisions of technical expertise and input during up to five service delivery meetings with providers;
- The provisions of technical expertise and input during up to two service delivery negotiation meetings with providers;
- The provisions of a written analysis of alternative funding options available to the Town;
- An update of the Town's current special assessment study for fire services; and
- The final presentation to Town Council.

In September 2006, GSG was instructed by the Town to pursue the analysis of the fire/rescue services only. The analysis of law enforcement services was not possible without further information.

On January 27, 2007, GSG provided the Town with notice that the study would be suspended due to the lack of information necessary to complete the study – including Town of Davie calls for service for one year and proposed costs to provide current and proposed services.

On March 2, 2007, GSG received some PowerPoint slides from Chief DePetrillo, Town of Davie, with proposed cost information for the Town, but no written description, agreement/detail, or call information was provided. This information is still outstanding in order to include Davie's analysis as a potential service provider.

Per our discussions, GSG would like to propose the following revised scope of services which reflects not only the work efforts performed to date by GSG, but also the work efforts requested by the Town:

Work Efforts to Date:

Task 1. Project Initiation and Data Gathering

The project team has met with Town officials at the kick off meeting as well as two other occasions, to finalize the scope of services and to obtain all data and information necessary to complete the scope of services. Such data includes annual budgets, existing agreements, tax roll and assessment roll information, fire/rescue incident data, law enforcement dispatch data, legal documents and other pertinent data and information related to fire/rescue and law enforcement services.

To date, GSG has spent considerable time analyzing fire/rescue operations, including personnel and apparatus costs; reviewing calls from service by miscellaneous service providers; and determining the Town's service delivery needs for its current and desired level of fire/rescue services.

Proposed Revised Scope of Services:

Task 2. Fire/Rescue Feasibility Study

The Project Team will conduct several tasks specifically related to fire/rescue services as follows:

- The Project Team will identify the benchmarks that will be used to define the Town's current and/or proposed level of fire/rescue services such as calls for service, response times, costs per capita and other pertinent criteria.
- Based upon the defined level of service, the Project Team will develop the cost of the Town providing the fire/rescue services to serve as a baseline for proposals from other providers or to provide an additional option to the Town for service delivery.
- The Project Team will provide comparative cost estimates of other fire/rescue service providers including the Broward County Sheriff's Office Fire/rescue Department and the Town of Davie.

NOTE: This analysis will be completed once all data and information necessary is received from the Town of Davie.

• In addition, GSG will include the new request that the Plantation Volunteer Model be discussed but not analyzed from a cost standpoint.

NOTE: This analysis will be completed once all data and information necessary is received from the City of Plantation.

• The analysis will be amended to include the recent acquisition of two engines and the construction of the Town's new public safety facility.

NOTE: This analysis will be completed once all data and information necessary is received from the Town of Southwest Ranches, including apparatus and facility information.

Task 3. Law Enforcement Feasibility Study

Analysis of the cost for the Town to provide law enforcement services as compared to the Town's current level of services contracted by the BCSO. This analysis will be completed once all data and information necessary is received.

The Project Team will conduct several tasks specifically related to law enforcement services as follows:

- The Project Team will identify the benchmarks that will be used to define the Town's current and/or proposed level of law enforcement services such as calls for service, response times, costs per capita, officers per square mile and other pertinent criteria.
- The Project Team will survey similarly populated cities to provide comparative analysis of law enforcement services using the identified benchmarks.
- Based upon the defined level of service, the Project Team will develop the cost of the Town
 providing the law enforcement services to serve as a baseline for proposals from other providers
 or to provide an additional option to the Town for service delivery.
- Finally, the Project Team will utilize the benchmarks discussed previously to compare cost estimates for law enforcement services to be provided by the Broward Sheriff's Office.

NOTE: This analysis will be completed once all data and information necessary is received.

Task 4. Update Town's Current Special Assessment

The Project Team will update the current special assessment study for fire services. The Project Team will provide methodology and implementation criteria for selected funding options for rescue and law enforcement services. The schedule of tasks associated with the fire services study is as follows:

- Review the Town's existing legal documents documenting the current assessment methodology, assessment roll summary information, fire call data, agreements, reports and other data pertaining to the provision of fire/rescue services.
- Identify the full cost of the fire/rescue service delivery using the Town's most current financial information and allocate the costs between fire and emergency medical services in conformance with the most recent case law. Identify the alternative sources of revenue to fund the service delivery costs and determine the net service delivery revenue requirements.
- Determine the total fire/rescue assessment revenue requirements to ensure the Town recovers the costs of: (a) net fire/rescue service delivery revenue requirements, (b) implementing the program, and (c) collecting the assessments.
- Using the existing assessment roll summary, updated fire/rescue incident data and revenue requirements, revise the apportionment methodology and apply to the assessment roll database to test the data validity and legal sufficiency. Revise the apportionment methodology as necessary.

- Calculate proforma schedule of rates based on the apportionment methodology and revenue requirements for the Fiscal Year 2007-08 assessment program.
- Prepare and present an assessment memorandum, which documents proposed apportionment methodology and proforma assessment rates.

Task 5. Coordination and Reporting

The Project Team will summarize and present the report, findings and analysis to the Town Council in a public meeting. The Project Team will provide a presentation to the Town Council and prepare a minimum of ten (10) final reports detailing our analysis.
