

RESOLUTION NO. 2006 - 086

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, AUTHORIZING THE TOWN ADMINISTRATOR TO SUBMIT NOMINATIONS TO THE FLORIDA LEAGUE OF CITIES' ANNUAL FLORIDA CITIES OF EXCELLENCE AWARDS PROGRAM; AUTHORIZING NOMINATIONS TO BE SUBMITTED FOR THREE OF THE TEN CATEGORIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida League of Cities offers an awards program limited to city, town or village governments that are members of the Florida League of Cities; and

WHEREAS, the awards program is titled "Florida Cities of Excellence Awards Program;" and

WHEREAS, the program's goal is to focus public attention on the countless beneficial contributions of municipalities, which improve the quality of life in Florida; and

WHEREAS, the program offers awards in ten (10) categories from which to submit nominations; and

WHEREAS, the Town Administrator recommends that the Town Council submit nominations for three of the ten categories.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

Section 1: The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the Town Council.

Section 2: The Town Council hereby approves the following nominations:



Section 4: Effective Date. This Resolution shall be effective immediately upon its adoption.


