RESOLUTION 2006 - 102

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA APPROVING AND ADOPTING THE MILLAGE RATE FOR TAXATION OF REAL PROPORTY LYING WITHIN THE BOUNDARIES OF THE TOWN OF SOUTHWEST RANCHES FOR FISCAL YEAR 2006-2007, COMMENCING OCTOBER 1, 2006 AND ENDING SEPTEMBER 30, 2007; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

WHEREAS, the Town of Southwest Ranches, Florida is a municipality located in Broward County, Florida; and

WHEREAS, pursuant to Section 200.065 (4) (E)(1), Florida Statutes, the Town Council is obliged to adopt its tentative millage rate prior to adoption of its tentative budget; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Broward County has been certified by the County Property Appraiser to the Town of Southwest Ranches as \$1,217,279,247.

NOW, THEREFORE BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida as follows:

Section 1: The above referenced recitals are true and correct and are incorporated herein by reference.

Section 2: The Town Council, following a review of the Staff Report, testimony from Town Staff, and from other interested parties, at a duly noticed public hearing held on September 28, 2005, hereby approves and adopts the Fiscal Year 2006-2007 tentative operating millage rate for Town of Southwest Ranches of 3.0000 mills, which is greater than the rolled-back rate of 2.5663 mills by 16.90%.

Section 3: Severability. If any one or more provisions of this Resolution shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited or against public policy, or shall for any reason whatsoever be held invalid, then such provision shall be null and void and shall be separate from the remaining provisions, and shall in no way affect the validity of all other provisions of this Resolution.

Section 4: This Resolution shall take effect immediately upon its adoption.
