# RESOLUTION NO. 2007 – 096

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING THE THIRD AMENDMENT TO THE AGREEMENT WITH MICHELE MELLGREN & ASSOCIATES, INC.; AMENDING THE AGREEMENT TO EXTEND THE AGREEMENT FOR AN ADDITIONAL YEAR, UNTIL SEPTEMBER 30, 2008; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND TOWN ATTORNEY TO ENTER INTO THE THIRD AMENDMENT TO THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

- **WHEREAS,** on March 8, 2001 the Town Council authorized the issuance of a Request for Proposal for Development Management and Zoning Code Services; and
- **WHEREAS,** on April 12, 2001, pursuant to Resolution 2001-45, the Town Council selected Michele Mellgren and Associates, Inc.; and
- **WHEREAS,** on September 10, 2003, the Town Council approved the First Amendment to its Agreement with Michele Mellgren and Associates, Inc., extending the term of the Agreement for an additional two years; and
- **WHEREAS,** on November 11, 2004, the Town Council retained independent Town Engineering and Infrastructure Management Services; and
- **WHEREAS,** on December 9, 2004, pursuant to Resolution No. 2005-021, the Town Council approved the Second Amendment to its Agreement with Michele Mellgren and Associates, Inc., which included several modifications and extended the term of the Agreement for an additional two years, until September 30, 2007; and
- **WHEREAS,** the Town Council and Michele Mellgren and Associates, Inc. have mutually agreed to extend the Agreement for an additional year, until September 30, 2008; and
- **WHEREAS,** the Town Council believes that this extension is in the best interest of the Town.
- **NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:
- **Section 1.** The above referenced recitals are true and correct and are incorporated herein by reference.

<u>Section 2.</u> The Town Council hereby approves the Third Amendment to the Agreement with Michele Mellgren and Associates, Inc. to extend the term of the Agreement for an additional year, until September 30, 2008.

**Section 3.** The Town Council hereby amends its Agreement with Michele Mellgren and Associates, Inc. as specifically delineated in Exhibit "A", which has been attached hereto and is incorporated herein by reference.

**Section 4.** The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney to enter into the Third Amendment to Agreement in substantially the same form as that attached hereto as Exhibit "A" and to make such modifications, additions and/or deletions which they deem necessary and proper to effectuate the intent of this Resolution.

**Section 5.** That this Resolution shall become effective immediately upon its adoption.
