

RESOLUTION NO. 2008 - 024

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA APPROVING YEAR-END BUDGET MODIFICATIONS FOR THE 2006-2007 FISCAL YEAR; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

Section 1. The above referenced recitals are true and correct and are incorporated herein by this reference.


Section 2. The Town Council hereby approves the following year-end budget modifications for the 2006-2007 fiscal year:




