RESOLUTION NO. 2008 – 047

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA PIGGY-BACKING ONTO THE EXISTING CONTRACTS ENTERED INTO BY THE CITY OF PLANTATION, FLORIDA WITH DRC, INC., CROWDER-GULF, INC., GRUBBS EMERGENCY SERVICES, INC., AND BERGERON EMERGENCY SERVICES, INC. AS SECONDARY PROVIDERS FOR DISASTER RESPONSE AND RECOVERY SERVICES; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR, AND TOWN ATTORNEY TO ENTER INTO AGREEMENTS WITH DRC, INC., CROWDER-GULF, INC., GRUBBS EMERGENCY SERVICES, INC., AND BERGERON EMERGENCY SERVICES, INC. AS A SECONDARY PROVIDER FOR DISASTER RESPONSE AND RECOVERY SERVICES; AND **PROVIDING AN EFFECTIVE DATE.**

WHEREAS, as a result of the massive, county-wide devastation resulting from the 2006 hurricanes, the Town has realized that it would be prudent to have a secondary provider available for disaster response and emergency services; and

WHEREAS, the availability of experienced Disaster Response and Recovery Services contractors may be severely limited if the Town awaits the occurrence of an actual emergency to secure such services; and

WHEREAS, the Town desires to initiate a proactive procurement of secondary providers to ensure the expedient removal of storm or disaster generated debris within the Town's jurisdiction; and

WHEREAS, the City of Plantation has recently issued a competitive procurement to find qualified vendors to provide Disaster Response and Recovery Services; and

WHEREAS, after careful review, the City of Plantation entered into Agreements with DRC, Inc., Crowder-Gulf, Inc., Grubbs Emergency Services, Inc., and Bergeron Emergency Services, Inc. to Disaster Response and Recovery Services; and

WHEREAS, the Town desires to piggy-back onto the City of Plantation's Agreements with DRC, Inc., Crowder-Gulf, Inc., Grubbs Emergency Services, Inc., and Bergeron Emergency Services, Inc. to perform Secondary Disaster Response and Recovery Services.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

Section 1: The above referenced recitals are true and correct and are incorporated herein by reference.

Section 2: The Town Council of the Town of Southwest Ranches hereby agrees to piggy-back onto the Agreements between the City of Plantation and DRC, Inc., Crowder-Gulf, Inc., Grubbs Emergency Services, Inc., and Bergeron Emergency Services, Inc. as secondary providers of Disaster Response and Recovery Services.

Section 3: The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney to enter into the Agreements in substantially the same form as those attached hereto as Exhibit "A" and to make such modifications, additions and/or deletions which they deem necessary to effectuate the intent of this Resolution.

Section 4: This Resolution shall become effective immediately upon its adoption.
