

**RESOLUTION NO. 2010 – 008**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, AUTHORIZING THE ROLLING OAKS CIVIC ASSOCIATION ("ROCA") VOLUNTEERS TO REPAIR THE ORIGINAL ENTRANCE GATE AT ROLLING OAKS PARK; PROVIDING FOR THE EXPENDITURE OF AN AMOUNT NOT TO EXCEED \$450.00 FOR MATERIALS; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Rolling Oaks Civic Association President Mark Modrich has offered to organize a group of volunteers to repair the original roofed entrance gate at the Rolling Oaks Park; and

**WHEREAS**, the original structure was permitted in 1969 and requires repair; and

**WHEREAS**, the Town of Southwest Ranches believes that it is in the best interest of the health, safety and welfare of the general public to repair the entrance gate; and

**WHEREAS**, the ROCA group has researched costs for materials to repair the structure and has provided a proposal for materials in the amount of \$388.72; and

**WHEREAS**, the Town estimates that the total costs of the materials will not exceed \$450.00; and

**WHEREAS**, the donation of labor would provide a low-cost resource for the Town to preserve the original structure; and

**WHEREAS**, all volunteers associated with the project will be required to sign the Town's Volunteer Release and Waiver; and

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:

**Section 1:** That the foregoing "Whereas" paragraphs are hereby ratified and confirmed as being true, and same are hereby made a specific part of this Resolution.

**Section 2:** The Town Council of the Town of Southwest Ranches, Florida, hereby authorizes the Rolling Oaks Civic Association volunteers to repair the original entrance gate at the Rolling Oaks Park.


**Section 3:** The Town Council hereby approves an expenditure not to exceed \$450.00 for the acquisition of materials to fix the entrance gate.


