RESOLUTION NO. 2010 - 018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING THE TOWN COUNCIL MEETING SCHEDULE FOR THE CALENDAR YEAR 2010; AND PROVIDING AN EFFECTIVE DATE.


Section 3. The Town Council has the authority to establish special meetings on the call of the Mayor or upon the call of three members of the Council.




