

RESOLUTION NO. 2011 – 029

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPOINTING A SELECTION AND NEGOTIATION COMMITTEE (SNC) IN CONJUNCTION WITH THE TOWN'S PROCUREMENT OF DRAFTING SOLID WASTE CONTRACT RFP SPECIFICATIONS (RLI 11-001); ENACTING A CONE OF SILENCE; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

WHEREAS, in furtherance of the Town's Procurement Code, the Town will soon be publishing a request for letters of Interests (RLI) seeking qualified vendors for Drafting the Solid Waste Contract Request for Proposals (RFP) Specifications; and

WHEREAS, in furtherance of the requirements established by the Florida Statutes and the Town's Procurement Code, the Town desires to establish a Selection and Negotiation Committee (SNC) to review submittals and presentations, and to shortlist and to rank the vendors, if necessary; and

WHEREAS, to ensure the integrity of the process, the Town Council desires to enact a cone of silence to prevent discussions with interested vendors outside of a noticed meeting; and

WHEREAS, this cone of silence applies to anyone serving on the SNC and to all members of the Town Council; and

WHEREAS, any vendor who violates this cone of silence shall be automatically disqualified from the procurement process; and

WHEREAS, the Town Council believes that this cone of silence is in the best interest of the health, safety, and welfare of its residents; and

WHEREAS, the Town desires that the SNC rank the vendors and make a formal recommendation to the Town Council.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

Section 1. The above-referenced recitals are true and correct and are incorporated herein by reference.

Section 2. The Town Council hereby appoints the following individuals to serve as the SNC in conjunction with the Town's procurement of drafting the Solid Waste Contract Request for Proposals (RFP) Specifications:

1. Jean Watson, Town Staff
2. Ivy Fivey, Town Staff
3. G. D. "Willie" Nabong, P.E. Town Staff
4. Marygay Chaples, Resident
5. Bob Hartmann, Resident



This cone of silence applies to anyone serving on the Selection and Negotiation Committee and to all members of the Town Council. Any vendor who has been found to violate this cone of silence shall be disqualified from the procurement process.
