RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING THE SECOND MODIFICATION TO THE AGREEMENT WITH MIGUEL LOPEZ, JR., INC. TO PROVIDE ROADWAY AND TRAFFIC SIGNAGE MAINTENANCE SERVICES TO THE TOWN; AUTHORIZING THE MAYOR, TOWN ADMINSTRATOR, AND TOWN ATTORNEY TO ENTER INTO THE SECOND AMENDMENT TO AGREEMENT AS ATTACHED HERETO AS EXHIBIT "A"; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on December 11, 2008, the Town Council adopted Resolution No. 2009-030 approving the contract with Miguel Lopez, Jr., Inc. to provide roadway and traffic signage maintenance services to the Town; and

WHEREAS, on December 22, 2011, pursuant to Resolution No. 2012-024, the Town Council approved the First Amendment to its Agreement with Miguel Lopez Jr., which extended the term of the Agreement for one hundred and twenty days (120) until April 9, 2012; and

WHEREAS, Miguel Lopez, Jr., Inc. indicated their desire to continue their services; and

WHEREAS, the Town is desirous in entering into this contract extension until October 31, 2012.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Southwest Ranches, Florida:

- **Section 1.** The above-referenced recitals are true and correct and are incorporated herein by reference.
- **Section 2.** The Town hereby approves the Second Amendment to the Agreement with Miguel Lopez, Jr., Inc., which extends the term of agreement until October 31, 2012, in substantially the same form as attached hereto as Exhibit "A".
- **Section 3.** The Town Council hereby authorizes the Mayor, Town Administrator, and Town Attorney to enter into the Second Amendment to Agreement in substantially the same form as that attached hereto as Exhibit "A" and to make such modifications, additions, and/or deletions which they seem necessary and proper to effectuate the intent of this Resolution.

Section 4. That this Resolution shall become effective immediately upon its adoption.

SECOND MODIFICATION TO AGREEMENT

THIS SECOND MODIFICATION TO AGREEMENT entered into as of this day of day of , 2012 between the Town of Southwest Ranches, a municipal corporation of the State of Florida (the "Town") and Miguel Lopez, Jr., Inc., consultant firm doing business or authorized to do business in the State of Florida, for the purpose of amending the Agreement between the Town an Miguel Lopez Jr., Inc. to provide roadway and traffic signage maintenance services, dated December 11th, 2008.

WITNESSETH:

WHEREAS, on December 11, 2008, the Town Council adopted Resolution No. 2009-030 approving the contract with Miguel Lopez, Jr., Inc. to provide roadway and traffic signage maintenance services to the Town; and

WHEREAS, on December 22, 2011, pursuant to Resolution No. 2012-024, the Town Council approved the First Amendment to its Agreement with Miguel Lopez Jr., which extended the term of the Agreement for one hundred and twenty days (120) until April 9, 2012; and

WHEREAS, Miguel Lopez, Jr., Inc. indicated their desire to continue their services; and

WHEREAS, the Town is desirous in entering into this contract extension until October 31, 2012.

NOW THEREFORE, for and in consideration of the premises and for Ten Dollars (\$10.00) and for other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, the parties hereto agree that the Original Agreement shall be amended as follows:

- 1. The foregoing recitals are true and correct.
- 2. Article 4 "Effective Date & Term", shall be amended to read as follows:

Section 4: Effective Date & Term

This Agreement shall become effective on <u>April 9, 2012</u>. the last date of execution by either of the Parties to this Agreement. The Agreement shall be effective through October 31, 2012. for three (3) years and the <u>The</u>

TOWN reserves the right to extend the Agreement for two one additional two (2) year terms, provided that both parties agree that all the terms, conditions and specifications remain the same and the extension is approved in writing by the Town Council Administrator.

3. All other terms and conditions not modified herein shall remain of full force and effect and binding on the parties.
