RESOLUTION NO. 2013 - 012

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING YEAR END BUDGET ADJUSTMENT FOR THE FISCAL YEAR 2011 / 2012 BUDGET; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 20, 2011, pursuant to Ordinance No. 2011-010, the Town Council approved and adopted the fiscal year 2011/2012 budget; and

- **WHEREAS**, the Town's Charter provides for the adjustment of approved and adopted Budget Ordinance via a Resolution; and
- **WHEREAS,** the Town of Southwest Ranches operates as a municipality within the State of Florida and is subject to the laws of the State of Florida related to Municipal Finance; and
- **WHEREAS,** one such provision of law prohibits the expenditure of funds in excess of adopted appropriations; and
- **WHEREAS**, in accordance with the External Auditor requirements, and sound budgetary process, budget adjustments are necessary in order to balance the Fiscal Year (FY) 2011/2012 Budget to comply with Florida State Statutes; and
- **WHEREAS,** The Town Council has determined that it is desirable to adjust the Fiscal Year 2011/2012 Adopted Budget to account for variances in actual expenditures and revenues in relation to the current Fiscal Year 2011 / 2012 budget,
- **NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:
- **Section 1:** Recitals. The above recitals are true and correct and are incorporated herein by reference.
- **Section 2:** Authorization. The Town Council of the Town of Southwest Ranches does hereby approve the year-end budget adjustment for Fiscal Year 2011 / 2012 as attached hereto and incorporated herein by reference as Exhibit "A".
- **Section 3:** Effective Date. This Resolution shall become effective immediately upon its adoption and retroactive for Budget Year 2011/2012.
