

**RESOLUTION NO. 2013 - 058**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA EXTENDING THE TOWN'S AGREEMENT WITH LUKES SAWGRASS LANDSCAPE, A/K/A LUKES LANDSCAPING, INC. TO PROVIDE TOWN WIDE PARK AND RIGHT-OF-WAY MAINTENANCE SERVICES; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR, AND TOWN ATTORNEY TO INITIATE THE EXTENSION; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on August 18, 2010, the Town and Lukes Sawgrass Landscape entered into an Agreement for provision of Town Wide Park And Right-Of-Way Maintenance Services for a period of thirty-six (36) months; and

**WHEREAS**, the term of the original Agreement will expire on August 25, 2013; and

**WHEREAS**, Article 3.1 of the Agreement provides for one additional two (2) year term to be approved by the TOWN at its sole discretion; and

**WHEREAS**, after careful review, the Town Council has determined that extension of the term for Park and Right-Of-Way Maintenance Services as set forth in the Agreement is in the best interest of the public; and

**WHEREAS**, the Town Council believes that continuation of delivery of Park and Right-Of-Way Maintenance Services can be best accomplished through coordination of provisions under the terms and conditions of the original Agreement; and

**WHEREAS**, the Town is desirous of extending the Agreement with Lukes Sawgrass Landscape for one additional two (2) year term;

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:

**Section 1.** The above recitals are true and correct and are incorporated herein by reference.


**Section 2.** The Town Council hereby extends the Agreement between the Town of Southwest Ranches and Lukes Sawgrass Landscape for one additional two (2) year term.

**Section 3.** The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney to initiate the extension.

**Section 4.** This Resolution shall take effect immediately upon its adoption.
