CONS Policy 1.4-j: The Town <u>specifically opposes and</u> shall actively oppose\_any development, policy or activity that may negatively impact its groundwater.

CONS Policy 1.11-d 1.4-k: The Town specifically opposes and shall actively oppose any modification of the Broward County landfill adjacent to the Town that could create or increase the discharge of hazardous substances into the groundwater.

CONS Policy 1.11-c: The Town <u>specifically opposes and</u> shall actively oppose and development, policy or activity that may negatively impact its air quality.

CONS Policy 1.11-d: The Town specifically opposes and shall actively oppose any modification of the Broward County landfill adjacent to the Town that could create or increase the discharge of particulates, odors or hazardous substances, including but not limited to the construction of an incinerator or acceptance of ash disposal.
