

**RESOLUTION NO. 2025-044**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, AGREEING TO PIGGYBACK ONTO THE CLAY COUNTY CONTRACT PRICING FOR THE PURCHASE AND INSTALLATION OF REPLACEMENT COMPONENTS AND SERVICES FOR THE SUNSHINE RANCHES EQUESTRIAN PARK PLAYGROUND FROM REP SERVICES, INC. / LANDSCAPE STRUCTURES, INC. IN AN AMOUNT NOT TO EXCEED FIFTY-SIX THOUSAND, NINETY-FIVE DOLLARS AND ZERO CENTS (\$56,095.00); AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND TOWN ATTORNEY TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the playground equipment at Sunshine Ranches Equestrian Park was acquired in 2004; and

**WHEREAS**, the life expectancy of commercial playground equipment is predictably 15-20 years, after which a new installation or major update should be completed; and

**WHEREAS**, the Town Council has appropriated the necessary funds to assist the Town in purchasing new components for the playground; and

**WHEREAS**, in accordance with its procurement procedures, the Town has elected to procure the components and related services via piggyback purchase from Rep Services, Inc. / Landscape Structures, Inc. via the Clay County contract # 2023/2024-284 in an amount not to exceed Fifty-Six Thousand, Ninety-Five Dollars and Zero Cents (\$56,095.00);

**NOW, THEREFORE BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:

**Section 1.** The above referenced recitals are true and correct and are incorporated herein by reference.

**Section 2.** The Town Council hereby agrees to piggyback onto the School Board of Miami Dade County contract # 2023/2024-284 pricing for purchase and installation of components and related services from Rep Services, Inc. / Landscape Structures, Inc. in an amount not to exceed Fifty-Six Thousand, Ninety-Five Dollars and Zero Cents (\$56,095.00) for use in the Sunshine Ranches Equestrian Park.

**Section 3.** The Town Council hereby authorizes the Mayor, Town Administrator, and Town Attorney to execute any and all documents necessary and proper to effectuate the intent of this Resolution.

**Section 4.** In accordance with the Town Charter and the budget adopted in Ordinance 2024-009, funding for this item was approved within the Capital Projects Fund expenditure account (301-5300-572-63170) for \$56,250.00.

**Section 5.** That this Resolution shall become effective immediately upon its adoption.
