Call to order at 7:05 PM. A quorum was established.

Debbie Green motioned to accept the minutes from the June 17, 2024, meeting. Francesca Case seconded, and the motion carried.

Discussion Items:

- Debbie Green gave the treasurer's report: \$47,658.00. SRHOA donated \$1,000 and Mayor Breitzkreuz donated \$500. There is only one scholarship to be paid. She will invoice FPL.
- Jennifer will speak with Kathy to help on logistics with storage at the ROCA barn. Currently, the ROCA room is organized, and items are in labelled bins.
- The idea of vending machines for profit is nice but is labor-intensive. Debra Ruesga will send a written thank Uncle Louis for his suggestion.
- The Barn Dance is March 15th. The DJ is confirmed. Page will help with Outback and Gary will also help with food and organizing the buffet/volunteers. Guests will come in table by table. He will set-up the condiment table. Appetizers will be brought around as before. We have serving trays. Page will also help with donations (Debbie will keep track with the spreadsheet). Madison will handle tickets, seating, invites, and flyers. Jennifer and Francesca will handle the auction. John Garate offered to help with clean-up. The board will decide the menu. The number of tables depends on the number of tickets sold...usually 11 inside and four outside to accommodate 100 guests. Debbie has "the book," which is our event bible. There will be a bartender and bar...we need the insurance and liability.
- January 24th is the food truck event with Hawk's Bluff at Equestrian Park from 5-8 PM. The DJ and Petting Zoo are confirmed. The PTA will handle the lights.
- Nothing is planned yet for the Flamingo Flocking, but the ladies' group will be asked to help again.
- John mentioned the Farm Bureau has scholarships. Could we look into this and its feasibility for our kids?
