LET'S KEEP SOUTHWEST RANCHES STRONG:

Why Property Taxes Matter to Us.

There's a proposal circulating in Tallahassee that sounds appealing on the surface: eliminate property taxes for homeowners across Florida. But for communities like ours in Southwest Ranches, this idea could do more harm than good – and it's time we talked about it.

Property taxes aren't just numbers on a bill. They're how we fund the services that make our Town work: fire protection, police, sanitation, stormwater management, road maintenance, parks, and emergency response. These aren't extras—they're essentials. Without property tax revenue, our local government would be forced to cut back or find other ways to pay for these services.

Some suggest raising sales taxes instead. But here's the problem: **Southwest Ranches doesn't have much retail.** We're a quiet, residential, and agricultural community. We don't have shopping centers or big box stores to generate sales tax revenue. That means we'd be left with fewer services and no real way to replace the funding we lose.

Another idea being floated is replacing property taxes with municipal fees. But here's something many folks don't realize: **ad valorem property taxes are tax-deductible on your federal income taxes. Municipal fees are not.** That means if property taxes are eliminated and replaced with fees, homeowners could lose a valuable deduction—effectively paying more out of pocket.

The Legislature plans to put this proposal on the ballot as a constitutional amendment in the 2026 general election, asking voters to decide whether to eliminate property taxes on homesteaded properties. That gives us time—but not much—to raise awareness and speak out.

The governor has suggested replacing local revenue with state funds, especially in rural counties. But that puts our future in the hands of politicians in Tallahassee, instead of the people who live here. We'd lose local control and become dependent on state decisions year after year.

Even our schools could be affected. While the current plan says school taxes would stay, education experts warn that billions in funding could still be at risk if the state doesn't follow through.

Let's be honest: the real challenges facing Florida families aren't property taxes. It's insurance costs, housing affordability, and healthcare. The average property tax bill is just a small fraction of household income, and laws such as the Save our Homes Amendment and various exemptions already protect homeowners from big increases.

This proposal might sound like a win, but it's a risky bet that could weaken the very foundation of our community. Southwest Ranches is strong because we take care of each other, and we invest in what matters. Let's keep it that way.

Talk to your neighbors. Reach out to your elected officials. Let's make sure our voices are heard—before decisions are made for us, and before this reaches the ballot box in 2026.

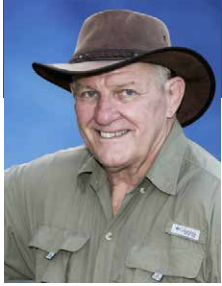

A MESSAGE FROM Council Member Jim Allbritton



GOOD DAY SOUTHWEST RANCHES

Today I am writing about the Real Estate Tax Proposals coming out of Tallahassee.

There is a current push to do away with property taxes. That may sound like a great thing (NO MORE PROPERTY TAXES), but I would urge each one of you to read very carefully; what would be implemented; to replace those taxes. There has been mention of raising the sales tax on All Goods. The current sales tax is six and a half percent to seven percent. The new sales tax being talked about would be sixteen to nineteen percent, again this is on everything you buy. This is just one of many proposals.

I would like to briefly break down the Tax bill you recently received from the county, using a hypothetical home valued with an Assessed Home value of \$370,000.

- The AD VALOREM taxes are approximately \$5,550.
- The Town receives approximately \$1,250 of this amount (3.9000 Millage Rate). This amount equates to approximately twenty-two percent.
- The other seventy-eight percent goes to the COUNTY, for schools, hospitals, water management and their general fund.
- The Town's \$1,250 pays for police and fire EMS, which accounts for over approximately sixty seven percent (67%) of the Town's general fund budget.
- The remaining pays for our parks, all Town employees and all other overall operating expenses. The NON-AD VALOREM taxes are the actual cost to the Town for these services.
- The Town Council approved a \$500,000 Subsidy from the Reserve Fund to be split 50/50 between the Fire Assessment and the Solid Waste Assessment to help keep the residents' NON-AD VALOREM taxes low.



This is a summary of where your tax dollars go. I understand how residents feel when they get their tax bill, but looking at all the services, we receive, our taxes, especially those received by the Town, are spent very discreetly. **Please READ CAREFULLY any Bill that may come from Tallahassee that threatens the very bases on which our Town is funded.**

I would like to remind all residents that the Town is working to organize a Veterans Group. If you are a Vet, or know a Vet, PLEASE reach out to me or Ms. December at Town Hall.

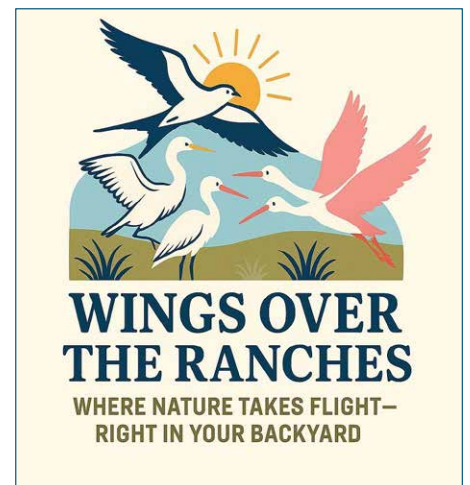

Community Recycling Update: Paper and Plastic Cups Are Now Welcome!

Good news for your community: WM now accepts paper and plastic cups in your recycling program! This exciting update is part of a national initiative with major brands and sustainability stakeholders to make to-go cups widely recyclable across the country.

Why Does This Announcement Matter to My Community?

Your community plays a vital role in making this initiative successful. That means your community's recycling information on your website directly impacts whether cups can be recycled nationwide.

By updating your community's website to reflect this change you're helping:

- Ensure consistent messaging across platforms
- Reduce confusion for residents
- Empower your community to recycle more effectively
- Support a national sustainability effort that can benefit everyone

Why Are Paper and Plastic Cups Accepted Now?

WM is expanding what we accept to better serve our communities. Here's why paper and plastic cups are now part of the recycling stream:

- Brands are switching materials: Many companies are moving away from foam and adopting recyclable paper or plastic cups.
- Re-executing on plans to invest over \$1.4 billion from 2022-2026 in new and upgraded recycling facilities with advanced sorting technology that is expected to process material, including cups, more effectively and increase the capacity available to serve our customers.
- End markets demand for these materials are growing: U.S. manufacturers want recycled paper and polypropylene (PP) materials to make new products.

What is Accepted in Recycling

WM accepts:

- Hot and cold beverage paper cups (e.g., coffee cups with sleeves and soda cups)
- Plastic cups made from polypropylene (PP) (e.g. cold drink cups for soda and iced coffee)

Not accepted:

- Foam cups (Styrofoam)
- Rigid polystyrene (#6)
- Lids, straws, and stoppers

How to prepare cups for recycling:

- Empty all liquids
- Remove straws, stoppers, and food

How do recycling centers know paper cups belong with paper not bottles and cans? Do machines really sort that out?

Many modern recycling facilities use advanced optical sorting technology to improve how materials are identified and directed. Most WM facilities use a strategically placed optical sorter just before the container line to detect fiber-based items, including paper cups, and redirect them into the paper stream.

While paper cups are technically 3D objects, their behavior during sorting depends on their physical condition:

To comply with Federal Trade Commission (FTC) guidelines and avoid greenwashing, all sustainability claims must be backed by data. For plastic cups to be labeled "widely recyclable," at least 60% of U.S. residents must have access to curbside or drop-off recycling programs. This access is currently verified through local municipal websites.¹

We're also working toward a "check locally" designation for paper cups, which requires that at least 20% of U.S. residents can recycle them.¹

Our goal is to make recycling guidance more transparent, helping customers understand where and how to recycle their cups — and ultimately supporting more sustainable everyday choices.

Ultimately, the system is designed to recover paper cups regardless of whether they follow a 2D or 3D sorting path. This ensures that cups are correctly sorted into paper bales and sent to mills for recycling.

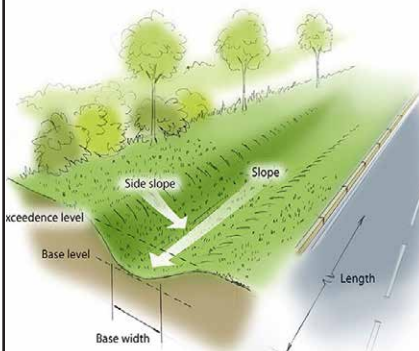

Why Swales Matter in Southwest Ranches

Dear Southwest Ranches Residents,

As part of our ongoing efforts to preserve the integrity of our community and ensure the efficiency of our public services, we'd like to remind all residents of the importance of maintaining your swale areas, especially when placing bulk trash out for collection.

- Swales play a critical role in managing stormwater runoff, preventing flooding, and protecting our environment. A well-maintained swale ensures proper drainage and helps keep our streets and properties safe during heavy rain.
- When placing bulk trash out for pickup, please place bulk items on the edge of your property, away from any drainage structures. If the area you typically use to place your bulk pile has been damaged either by the weight of the pile or the pick-up claw, please give the area a rest and move your pile to another location.
- Proper swale maintenance and responsible bulk trash placement help our crews work more efficiently and protect the natural beauty of Southwest Ranches. Your cooperation ensures that our drainage systems function properly and that our swales remain safe for equestrians and walkers.

HB 279 - The Fostering with Dignity Act

Entering foster care is often one of the most traumatic experiences a child can endure. Leaving behind familiar surroundings, family members, and possessions can cause lasting emotional distress. For many, that pain is compounded when they are forced to pack their few belongings into trash

bags, an act that can make a child feel disposable and stripped of dignity at a moment when they most need reassurance and care.

As former foster care youth and current Peer Advocate at the FLITE Center, Shanika Ramos explained, "To have to put my belongings, that I did everything I could to keep with me, in a trash bag made me feel like I was worth nothing but trash. I wasn't worth enough to be able to have suitcases and proper luggage for my belongings." Currently, many children

entering foster care face this same trauma and are forced to pack their belongings into trash bags, which can add to the emotional distress of leaving their home and reinforce feelings of worthlessness during an already traumatic time.

This is why Senate Minority Leader Lori Berman and I have filed **SB 306/HB 279**, known as the **Fostering with Dignity Act**, to ensure that every child entering Florida's foster care system is provided with appropriate luggage for their belongings. By mandating the use of proper luggage, HB 279 seeks to provide children with a small but meaningful gesture of dignity, stability, and respect.

Hummingbirds gather nectar from wildflowers with tubular flowers. Many flowers produce fruit that other birds will eat.

- Wild columbine (*Aquilegia canadensis*)
- Crossvine (*Bignonia capreolata*)
- Trumpet creeper (*Campsis radicans*)
- Standing cypress (*Ipomopsis rubra*)
- Firebush (*Hamelia patens*)
- Cardinalflower (*Lobelia cardinalis*)
- Coral honeysuckle (*Lonicera sempervirens*)
- Beardtongue (*Penstemon* spp.)

Gardening tips

- Choose a diversity of wildflowers that bloom across the seasons.
- Include species of various heights.
- Cluster wildflowers in groups of 3 or more of each species.
- Leave space in your plantings for growth and movement.
- Include native trees such as oaks, black cherry, maples and pines that provide insects. Remember: Decomposing leaf litter used as mulch is also a source for insects.
- Add a birdbath to complete your bird sanctuary.

Sparrows, warblers, finches, nuthatches, titmice, chickadees, cardinals and indigo buntings feed on seeds and fruits, as well as larger birds like thrashers, redbirds, blackbirds, bobwhites, doves, mockingbirds, catbirds and grosbeaks.

After wildflowers have bloomed, leave seedheads on the plants for birds. Other flowerheads may shatter, scattering seeds on the ground that attract smaller birds, such as finches.

- Thistle (*Cirsium* spp.)
- Mistflower (*Conoclinium coelestinum*)
- Tickseed (*Coreopsis* spp.)
- Coneflowers (*Echinacea purpurea*, *Rudbeckia* spp.)
- Sunflowers (*Helianthus* spp.)
- Wild coffee (*Psychotria nervosa*)
- Sage (*Salvia* spp.)
- Little false bluestem (*Schizachyrium scoparium*)
- Eastern gamagrass (*Tripsacum dactyloides*)
- Blueberry (*Vaccinium* spp.)
- Ironweed (*Vernonia* spp.)

Most birds feed insects to their chicks, and many insects visit wildflowers for nectar and pollen. Insect-eating birds include goldfinches, chickadees, titmice, cardinals, grosbeaks, wood warblers, blue jays, sparrows, thrashers, nuthatches, crows and mockingbirds.

Some great Florida wildflowers to plant for attracting insects are:

- Tickseed (*Coreopsis* spp.)
- Sneezeweed (*Helenium* spp.)
- Blazing star (*Liatris* spp.)
- Dotted horsemint (*Monarda punctata*)
- Beardtongue (*Penstemon* spp.)
- Black-eyed Susan (*Rudbeckia* spp.)
- Sage (*Salvia* spp.)
- Skullcap (*Scutellaria* spp.)
- Goldenrod (*Solidago* spp.)
- Stokes' aster (*Stokesia laevis*)
- Germander (*Teucrium canadense*)
- Frostweed (*Verbesina virginica*)

2026 Homestead Exemption

All qualified Florida residents are eligible to receive a Homestead Exemption on their homes, condominiums, co-op apartments, and certain mobile home lots. To qualify for Homestead Exemption, you must own and make the property your permanent residence on January 1 of the year for which you are applying for this valuable exemption. Pursuant to Florida law, all assessments and exemptions are based upon the status of the property on January 1. If you acquired the property as your permanent residence in 2025 and have not applied for Homestead Exemption, you can apply for 2026 exemptions at any time there is no need to wait until 2026 to file your exemption application. You can easily apply online at https://web_bcpa_net/bcpaclient/#/HomesteadExemption

The timely deadline to file for all 2026 exemptions is March 2, 2026. You must make the property your permanent residence by January 1, 2026 to qualify; however, you have until March 2 to timely file your application with our office. The late filing deadline for all 2026 exemptions is September 18, 2026.

Once approved, your Homestead Exemption automatically renews each year provided there is no change in the ownership or use of the property. **If you have already applied and been approved for Homestead Exemption at your current property, you do not need to reapply for this exemption.** You will receive a Homestead Exemption renewal card next month to keep for your records.

While Homestead Exemption is the most common exemption, there are additional exemptions available to qualified applicants. Here is the link to all the additional exemptions for your review: https://web_bcpa_net/bcpaclient/#fHomestead

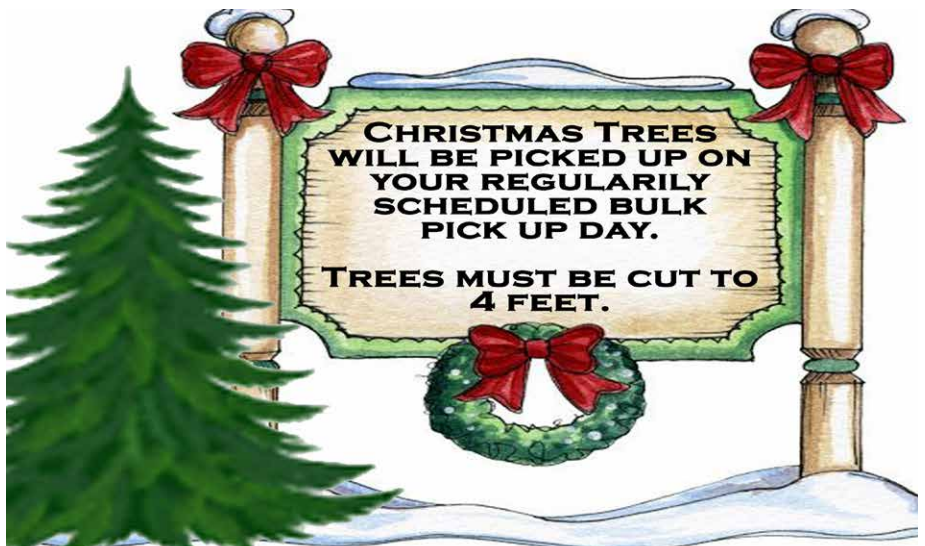

Fill for horse stalls does not require a fill permit. In addition, a permit may not be required if a small amount of sand is required to replenish a horse arena. However the Town recommends that a property owner or leasee contact our office to assure that the type of work being performed falls under this criteria prior to performing the work. A phone call to us will help prevent a possible warning from Code Enforcement and double fees when it comes to acquiring the required permit.

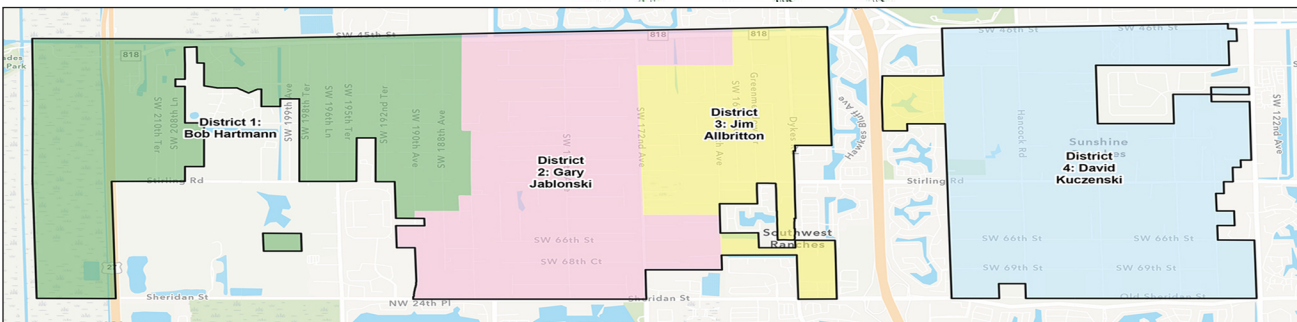
