In consideration of allowing me/my child to participate in this event, and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, I hereby remise, release, acquit, satisfy and forever discharge the Town of Southwest Ranches, including any of its officers, employees, agents, or volunteers, of and from any and all manner of action and actions, cause and causes of action arising out of any occurrence wherein I/my child, or my property is harmed, proximately or otherwise, from or in connection with my/my child's participation in this event.

I agree that any liability of Town for personal injury that I/my child may afflict by my gross negligence or intentional action onto others, or others' property, shall be borne solely by me. I also agree that I shall be solely responsible for all liability for injury or damage to the Town property or any other property when such injury or damage shall result from, arise out of, or be attributable to my/my child's gross negligence, or intentional action.

I have read this release and wavier of liability form and fully understand its terms. I further understand that I have signed this form freely and without any inducement or assurance of any nature, and intend it to be a release of liability to the greatest extent permitted by law and agree that if any portion of this release and waiver is held to be invalid, the balance shall continue in full legal force and effect.

This release and wavier of liability shall extend to any rider of any horse participating of which I am the Owner/Exhibitor and to any person injured by such horse or rider. All activities will be conducted in a safe manner; and any animal or rider deemed to be unsafe, in the sole opinion of the event management, may be barred from participation in any class or from the show.
