

RESOLUTION NO. 2026-041

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, DECLARING THE TOWN-OWNED 1989 FORD FIRE TRUCK AS SURPLUS INVENTORY; AUTHORIZING THE TOWN ADMINISTRATOR TO FACILITATE THE SALE OF THE SURPLUS INVENTORY IN ACCORDANCE WITH THE TOWN'S PROCUREMENT AND SURPLUS DISPOSAL PROCEDURES, INCLUDING THROUGH PUBLIC AUCTION; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR, AND TOWN ATTORNEY TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town has identified its 1989 Ford Fire Truck that is assigned to the Town's Volunteer Fire Department as no longer suitable for use by the department; and

WHEREAS, it has been determined that this vehicle is no longer practical to maintain for service; and

WHEREAS, the Town Administrator desires to declare this vehicle as surplus inventory and facilitate its sale through appropriate surplus and procurement processes; and

WHEREAS, this Resolution serves to authorize the Town Administrator to declare this vehicle as surplus inventory and to proceed with its sale in accordance with applicable Town procedures.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA:

Section 1. The above-referenced recitals are true and correct and are incorporated herein by reference.

Section 2. The Town Council hereby declares the 1989 Ford Fire Truck as surplus inventory.

Section 3. The Town Council hereby authorizes the Town Administrator to proceed with the sale of this surplus inventory, including through public auction, in accordance with the Town's procurement and surplus disposal procedures, and to explore all available options to maximize value to the Town.

Section 4. The Mayor, Town Administrator, and Town Attorney are hereby authorized to execute any and all documents necessary and proper to effectuate the intent of this Resolution.

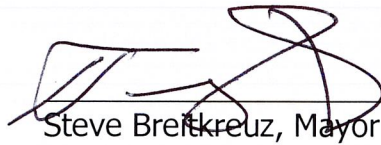
Section 5. This Resolution shall become effective immediately upon its adoption.

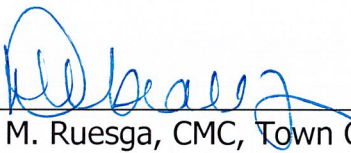

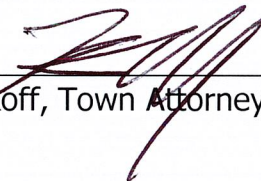
