Discussion Items:

- We updated our efforts on gaining participation for the pageant. We are advertised in the Waggler and DRW. We did very well last year with the participation of the high school students. Last year's pageant raised \$15, 830.
- Kids can help at all Town events to qualify for hours.
- Madison created an eight minute Veterans Day video for the SWR Day of Honor. There was a great turnout of veterans and guests.

- We are expecting some monies to come in: \$3,000, \$1,000, \$1000, and \$200...we still have a way to go in our fundraising. Last year's dance raised \$6, 773. The Sikh Society has been a tremendous help and presence, donating \$10,000. They feel this year will see more! Food truck monies were double that of last year!
- We are looking for fun, filler-items for this year's auction at the dance. We plan on some "Chinese-auction" items as well.
- Board members are helping homeless students, but are not receiving proper information/guidance. Chris
 has volunteered to make calls and get a speaker for one of our upcoming meetings.
- Kathy brought-up the safety issue of the south-bound turn from Griffin onto U.S. 27. Rosina motioned, and Leah seconded, the Town Council petition the FDOT to push-forward requiring a green-arrow light at the second signal of the Griffin Road/South-bound turn onto U.S. 27, in order to ensure a safe turn for the kids driving to West Broward High School.
