## **REGULAR MEETING MINUTES OF THE TOWN COUNCIL** Southwest Ranches, Florida

Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Nelson at 7:11 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

George Morris displayed videos he provided from the Town Birthday Party and the Ride for the Ranches Classic Car Show.

**3. Public Comment** – The following members of the public addressed the Town Council: Newell Hollingsworth, Bob Hartmann, Vince Falletta, and Dee Schroeder.

## 5. Council Member Comments

Council Member Jablonski announced the upcoming Chili Cook Off on March 5<sup>th</sup>. He also indicated the Town Wide Garage Sale would be occurring on February 20<sup>th</sup> at the Sunshine Ranches Equestrian Park and announced that registration forms could be found in the Town newsletter. He also mentioned the Country Estates Hog Roast would be held on January 30<sup>th</sup> and the Schools and Education Advisory Board Scholarship Fund Food Truck Fundraiser would be held on January 29<sup>th</sup>. Lastly, he also spoke about the newly created Yellow Dot Program which allows first responders to know about a motorists medical history should they become unresponsive.

Council Member Breitkreuz also urged residents to attend the events mentioned by Council Member Jablonski. He spoke about students who attend Silver Trail Middle School who reside primarily along SW 185<sup>th</sup>, SW 186<sup>th</sup>, and SW 188<sup>th</sup>, and the difficulty they encounter in getting to school. He indicated Town staff was working with the Broward County School Board to get bus stops in this area which will make it safer for these students. Lastly, he spoke about the progress of the TSDOR program. He expressed some concern about the survey and engineering costs were significantly higher than originally anticipated. He asked that the Drainage and Infrastructure Advisory Board (DIAB) review the program and possibly extend it 2-3 years and place a yearly cap so that there is a limitation of approximately \$500,000.

Vice Mayor McKay expressed support for a proposal that will be considered by the Schools Education Advisory Board (SEAB) to amend the process of scholarship issuance. He favored issuing the scholarship award as long as they meet the criteria, and eliminate the requirement to submit receipts for educational expenses.

Council Member Fisikelli spoke about issues faced by a resident seeking to install a shed on her property. He felt that the process needs to be revaluated as it appears that some of the costs and hurdles she encountered may be unnecessary. Vice Mayor McKay felt that a worksop on this issue needed to be scheduled.

Mayor Nelson announced the passing of Monsignor Edmund White of Saint Mark's Church and offered his condolences to the family and his extended Saint Mark's family.

#### 7. Administration Comments

Town Administrator Berns acknowledged members of the Sikh Temple located at Stirling Road and Dykes Road who were having some traffic and parking related issues. He indicated that he had met with members of Council and Robert Solera of Code, and would be meeting with representatives of the Sikh Temple to discuss these issues further. He spoke about two recent meetings he attended at the Broward MPO. The first meeting concerned the Long Range Transportation Plan and the desire to remove the south end of SW 188<sup>th</sup> Avenue from the plan and the Town's request to make SW 184<sup>th</sup> Avenue a two lane road rather than a four lane roadway. The evening meeting was the Community Involvement Roundtable that contained the same agenda items. There were no questions for Town staff at this meeting and the Town's items were approved. He spoke about the New Resident Package which contained frequently asked questions (FAQs) to provide information to our residents on where they could turn for services. Lastly, in response to concerns about trash collection in the western portion of Town, he directed Code to closely monitor this issue.

**MOTION:** TO INCREASE THE ANNUAL SALARY FOR ASSISTANT TOWN ADMINISTRATOR/TOWN CLERK RUSSELL MUÑIZ TO \$100,000 ANNUALLY, INCREASE THE NUMBER OF PTO DAYS TO 25 DAYS WITH A TEN DAY ROLLOVER, SHOULD HE RESIGN THE PTO PAYOUT WOULD BE BASED ON 20 DAYS, AND PLACE A TERM ON THE CONTRACT THROUGH DECEMBER 31, 2018 AND SHOULD HE RESIGN PRIOR TO THE CONTRACT TERM HE WOULD PAYBACK TO THE TOWN THE PRORATED AMOUNT OF \$5,000.

**MOTION:** TO INCREASE THE ANNUAL SALARY FOR TOWN ADMINISTRATOR ANDREW BERNS TO \$160,000 ANNUALLY, PROVIDE A 5% BONUS, INCREASE THE NUMBER OF PTO DAYS TO 25 DAYS WITH A TEN DAY ROLLOVER, SHOULD HE RESIGN THE PTO PAYOUT WOULD BE BASED ON 20 DAYS, 12 WEEK SEVERANCE PLUS ONE ADDITIONAL WEEK EVERY YEAR TO A MAXIMUM OF 16 WEEKS IF TERMINATED WITHOUT CAUSE, AND EXTEND TERM ON THE CONTRACT THROUGH DECEMBER 31, 2020.
