Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Nelson at 7:15 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

- **3. Presentation** Mayor Nelson provided a brief introduction to the Arbor Day contest results. He introduced December Lauretano-Haines, Parks and Recreation Coordinator, who proceeded to give details on the contest and the participants.
- **4. Presentation** Levent Sucuoglu, Director of Information Technology for the City of Tamarac, provided a presentation on the possibility of Tamarac servicing the Town for IT and VOIP services.
- **5. Public Comment** The following members of the public addressed the Town Council: Ruth Wolf, Dee Schroeder, and JoAnn Mitchell.
- **6. Board Reports** There were none at this time.

7. Council Member Comments

Council Member Jablonski thanked Mr. and Mrs. Green for donating the trees that were recently installed on Hancock Road. He congratulated the School and Education Advisory Board for a successful Food Truck Event at the Equestrian Park. He reminded the public on the upcoming Chili Cook Off event on May 18th.

Council Member Fisikelli provided an update on Fishing Hole Park project. He recommended that the landscaping on the west-side on Griffin Road be removed due to its current condition.

Vice Mayor Breitkreuz agreed with removing the landscaping on a portion of Griffin Road. He recommended that the application for election signs should be revised and requested that Town staff come up with a better solution.

Mayor Nelson updated the Council on the reversal of the proposed MSTU by the County for E-911 consolidation.

Council Member McKay also updated the Council and public on results of the E-911 consolidation services at the County level.

The Town Administrator reported on the E-911 services.
