Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Nelson at 7:10 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

3. Presentation of Resolution to Flanagan High School SWAT Students – The Mayor and Town Council recognized SWAT students from Flanagan High School. The students thanked the Council for their support in their efforts to discourage the sale of flavored tobacco.

The Town Attorney inquired if the applicant understood the quasi-judicial procedures or needed the quasi-judicial hearing procedures and rules read. The applicant agreed to the procedures and declined to have the procedures read and there were no members of the public that requested the quasi-judicial procedures be read. The Town Clerk swore-in the Petitioners and members in the audience giving testimony on the following matters. Members of the Town Council disclosed all *ex parte* communication with the petitioners.

4. PLAT – Consideration of plat application PL-052-13, Terra Ranches, a re-plat of Tracts 31 and 32, in Section 5, Township 51 South, Range 40 East, of the Florida Fruit Lands Company's Subdivision No. 1, as recorded in Plat Book 2, Page 17, of the Public Records of Dade County, lands situated in Broward County, Florida, comprising 19.49 acres within the Rural Estates Zoning District, which allows one dwelling unit per one net acre, creating 11 lots with a road, and a lake tract. HSQ Group, petitioner; MMA Tamarac, LLC, owner; Terra World Investments, LLC, contract purchaser. Property generally located on the SE corner of SW 172nd Avenue and unimproved Stirling Road.

SITE PLAN – Consideration of site plan application SP-052-13, Terra Ranches, Greenspoon Marder, P.A., petitioner; MMA Tamarac, LLC, owner; Terra World Investments, LLC, contract purchaser. The applicant is seeking site plan approval for the development of 19.49 acres into 11 lots, one road, and a lake, within the Rural Estates Zoning District, which allows one dwelling unit per one net acre. The subject property is generally located on the SE corner of SW 172nd Avenue and unimproved Stirling Road.
