Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Nelson at 7:05 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

- **3. Presentation** Mayor and Town Council recognized Archbishop McCarthy High School Mayoricks Baseball Team for winning the State Championship for four consecutive years.
- **4. Presentation** Sheriff Scott Israel provided an update on law enforcement services.
- **5. Presentation** Mayor and Town Council recognized summer student volunteers for their service to the Town.
- **6. Presentation** Sgt. Daniel Marks provided a presentation on Equine Animal Abuse Awareness.
- **7. Public Comment** The following members of the public addressed the Town Council: Newell Hollingsworth, Bob Hartmann, John Eastman and Mike Hanley.
- **8. Board Reports** There were none at this time.

9. Council Member Comments

Council Member Jablonski reminded the public that there will be a hazardous waste drop-off event at Rolling Oaks Park in October. He expressed concern with the charter school development out west he thought that maybe the gates in Town should remain permanently locked.

Council Member Fisikelli requested information on the delivery of recycling carts. He briefly updated the public on Fishing Hole Park progress.

Vice Mayor Breitkreuz requested that a traffic community meeting be scheduled to discuss the traffic issues in the west side of Town. He also stated that the commercial use item developed by the Comprehensive Plan Advisory Board needs to come back to Council for a vote to proceed.

Council Member McKay stated that the new light on Griffin Road and I-75 ramps are causing unneeded traffic congestion. He also reminded Council that they need to continue their solidarity against the proposed park and ride planned for Griffin Road.

Mayor Nelson recognized December Haines for her efforts with the garden project at Town Hall called "Project Primal". He also designated the garden as "December's Garden."

10. Legal Comments

The Town Attorney provided a report on the New Testament lawsuit. He provided an update on the negotiations with BSO for law enforcement services and advised Council that there may be other options to look into. He also clarified that Code Enforcement complaints can be anonymous.

11. Administration Comments

The Town Administrator reported on the upcoming negotiations with BSO for law enforcement services. He also provided updated information on the recycling carts that will be delivered in the first week of September. He advised Council that he will follow-up with Code Enforcement on the anonymity issue. He also provided an update on Rolling Oaks Barn.
