Steve Brietkreuz, Chair of the Comprehensive Planning Board, indicated that the Board was supposed to be discussing the potential uses for the US 27 Employment Center but since the resignation of Council Member Fisikelli the Town Council cant review the item and he would be out of Town for the next meeting. He asked that the Town Council allow for the item to be deferred once again for an additional month.

#### 6. Council Member Comments

Council Member Hartmann recognized the past service of Council Member Fisikelli. He spoke of the damage being done to properties by the clam shell buckets used by Waste Pro. He advised that there is a way to report these issues directly to Waste Pro via the

She informed that adoptable dogs and cats will be available for adoption. She invited everyone to come out and adopt a pet.

Mayor McKay thanked everyone for coming.

### 7. Legal Comments

Town Attorney Poliakoff informed that at the end of this year, driver's licenses will no longer be accepted as a form of identification, if it does not contain a yellow star affixed on the upper right-hand corner. He attended the Flow Mobile DMV this morning, and renewed his driver's license to include the yellow star. He praised the Flow Mobile DMV staff for being very courteous.

#### 8. Administration Comments

Town Administrator Berns asked Assistant Town Administrator/Town Clerk Muñiz to explain in more detail about the upcoming Senator Marco Rubio's office Outreach Service. Mr. Muñiz informed that the office of Marco Rubio contacted the Town in the hopes of extending their presence in Broward County. He informed that Gina Alonso and her staff will be at Town Hall on Thursday, August 8<sup>th</sup>, to provide federal services to residents on issues such as immigration, social security, and many other topics.

Town Attorney Poliakoff added that the Act of Congress Law is named "The Real ID Act" which modifies U.S. federal laws pertaining to security, authentication, and issuance procedures standards for state driver's licenses and other identity documents. He informed that the law will go into effect next year, 2020.
