Regular Meeting of the Town Council of Southwest Ranches was held 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Breitkreuz at 7:06 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

3. **Proclamation for Arbor Day**

Assistant Town Administrator/Town Clerk Muñiz read the proclamation into the record.

4. Presentation on Coyotes by Kristen Hoss

A presentation was provided by wildlife biologist Kristen Hoss on coyotes to educate residents due to the growing coyote problem in the Town.

5. Public Comment

The following members of the public addressed the Town Council: Catalina Stubbe and Terri Fernandez.

6. Board Reports

There were no Board reports.

7. Council Member Comments

Vice Mayor Hartmann spoke about the coyote problems that have happened in the past and present and thanked Parks, Recreation and Open Space Manager December Lauretano-Haines for arranging the coyote presentation. He then spoke about the historical building located at the Southwest Meadows Sanctuary and presented drone footage to show the deteriorated condition of the building as well as the infestation of bees. He suggested to the Town Council to have Davie Detective Jeff Hobales, who is also a beekeeper, come up with a plan to lure the bees out of the building so it can then be inspected, and a decision can be made about it's future. Last he spoke about the Charter Review Committee and how pleased he is with their commitment to coming up with ideas to help protect the Town's rural lifestyle.

Council Member Jablonski spoke on upcoming events in the Town such as the Country Estates Park Entrance Contest, the Rural Arts Committee Holiday Lights Contest, the Broward County Property Appraiser outreach event and the SWR Parks Foundation Chili Fest and Car Show. He advised the public the Town has partnered with UrgentMed for COVID-19 testing and vaccinations

administered on Town Hall property. Council Member Jablonski spoke about attending the trial proceedings between the City of Pembroke Pines and the Town of Southwest Ranches and stated how interesting it was.

Council Member Kuczenski designated Catalina Stubbe to the Parks, Recreation, Forestry and Natural Resources Advisory Board as his appointee. He thanked the individual that cleared off the overgrowth that was covering the Southwest Ranches sign. He stated he was going to attend the trial the following day and expressed how important it is for our Town. Council Member Kuczenski reminded the public to take their key fobs out of their cars and lock them. He advised FPL is replacing a lot of light poles on Stirling Road between Volunteer Road and Flamingo Road and since the swales and asphalt are getting torn up, he wanted to follow up and make sure whatever was destroyed will be repaired or replaced. He thanked a resident for showing up and expressing her concerns and asked Mayor Breitkreuz to drive down Stirling Road from Holatee Trail toward Hancock Road to see a property's lawn that was very overgrown. Last, Council Member Kuczenski reminded the public to bring in their animals at night. Council Member Jablonski asked Town Administrator Berns if the Town can hire its contractor to cut the overgrown lawn and charge the owner to which Town Administrator Berns answered yes, due to the possible threat of coyotes congregating within the high grass.

Council Member Allbritton spoke about how interesting the ongoing trial between the City of Pembroke Pines and the Town of Southwest Ranches, he spoke about the Vice Mayor Hartmann's drone footage and working with Parks, Recreation and Open Space Manager December Lauretano-Haines on moving the historical building and restoring it. Last, he announced the Public Safety Committee will start meeting in January 2022 and thanked the Davie Police for their diligence in slowing down the speeding drivers within the Town.

Mayor Breitkreuz thanked the Town Council for speaking on the topics he had planned to speak on.

Assistant Town Attorney Dewitt had no comments.

9. Administration Comments

Town Administrator Berns stated there has been good progress made with the license plate readers and he will update the Town Council at the October 28th council meeting. He mentioned the Town Council meeting was being livestreamed on the Town's YouTube channel. Town Administrator Berns advised the results from the town survey will be presented at the October 28th Council meeting as well. He spoke about the stolen car issues in the Town and advised the residents to remove their key fobs and lock their cars. Lastly, Town Administrator Berns called upon Public Works Director/Town Engineer Rod Ley to speak about the rating received by the Town from FEMA.
