ORDINANCE NO. 2009 - 04

AN ORDINANCE OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, AMENDING THE FUTURE LAND USE PLAN MAP OF THE TOWN OF SOUTHWEST RANCHES COMPREHENSIVE PLAN TO CHANGE THE DESIGNATION OF FIVE ACRES OF LAND FROM RECREATION AND OPEN SPACE TO COMMUNITY FACILITIES, SAID LAND LYING WITHIN THE WEST HALF OF TRACTS 52 AND 53 OF THE FLORIDA FRUIT LANDS CO. SUBDIVISION NO 1, SECTION 29, TOWNSHIP 50 SOUTH, RANGE 40 EAST, AS RECORDED IN PLAT BOOK 2, PAGE 17 OF THE DADE COUNTY PUBLIC RECORDS: PROVIDING FOR TRANSMITTAL TO THE BROWARD COUNTY PLANNING COUNCIL AS A REQUEST FOR APPROVAL OF AN IDENTICAL AMENDMENT TO THE BCLUP; AUTHORIZING THE TOWN ADMINISTRATOR TO APPLY FOR RECERTIFICATION OF THE AMENDMENT; AUTHORIZING THE TOWN ADMINISTRATOR TO AMEND THE TOWN'S FUTURE LAND USE PLAN MAP TO REFLECT THE AMENDMENT; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the subject property, described in Exhibit "A" attached hereto, is part of a larger property that the Town of Southwest Ranches purchased for use as a park and municipal government complex ("Park Property"); and

WHEREAS, the Town proposed to locate the municipal government complex on 5 acres of land within the Park Property, but southeast of the subject property; and

WHEREAS, the Town intended to utilize the subject property for recreation and open space purposes; and

WHEREAS, the Town of Southwest Ranches Town Council and Broward County Board of County Commissioners modified the land use plan map designation of the Park Property, less the site originally intended to house the municipal government complex, from Residential Estate to Recreation and Open Space; and

WHEREAS, the Town Council has determined that it is in the best interests of its residents to move the location of the proposed municipal government complex to the subject site; and

WHEREAS, the Recreation and Open Space land use plan designation does not permit governmental office or public safety facilities; and

WHEREAS, the Town Council wishes to change the designation of the subject property on the land use plans of the Town of Southwest Ranches and Broward County Land Use Plan from Recreation and Open Space to Community Facilities to facilitate the siting and construction of a municipal government administration and public safety complex at this location.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA:

- **Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance.
- **Section 2:** That the land use plan map designation of the property described in Exhibit "A", attached hereto and made a part hereof, is hereby amended and changed from Recreation and Open Space to Community Facilities.
- **Section 3:** That the Town Administrator or designee is hereby authorized to transmit an application for amendment to the Broward County Land Use Plan to the Executive Director of the Broward County Planning Council.
- **Section 4:** That the Town Administrator or designee is hereby authorized to apply to the Broward County Planning Council for recertification of the subject (small scale) land use plan amendment.
- **Section 5:** That the Town Administrator or designee shall, immediately following the effective date of this Ordinance, cause the Town of Southwest Ranches Future Land Use Plan Map to be updated to reflect this amendment.
- **Section 6:** Conflicts. All Ordinances or parts of Ordinances, Resolutions or parts of Resolutions in conflict herewith, be and the same are hereby repealed to the extent of such conflict.
- **Section 7: Severability.** If any word, phrase, clause, sentence or section of this Ordinance is, for any reason, held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this Ordinance.
- **Section 8: Effective Date.** The effective date of this plan amendment shall be the date a final order is issued by the Department of Community Affairs, finding the amendment to be in compliance in accordance with Chapter 163.3184, Florida Statutes; or the date a final order is issued by the Administrative Commission finding the amendment to be in compliance in accordance with Section 163.3184, Florida Statutes.
