Another year is almost over and it is time to look back and see what we have accomplished in our Town. I believe the most important thing that is going to happen, is by the time you get this newsletter we will be without our present Town Engineer Willie Nabong. He has accepted a position which was a great opportunity and is closer to his home. When he started working for our Town he lived in a city in northern Florida with the intention of moving to Southwest Ranches as soon as possible. But his family decided not to make the transition down south. His last day was December 13th, so I wished him good luck and expressed to him that he has done a good job for our Town while he has been here, so let's wish him good luck on his new position.

Now for some good news! We have been moving right along with the building of Fishing Hole Park located on Griffin Road and 190th Avenue. We have completed the playground, parking lot, and part of the horse trail. We hope to start laying the grass this week, the bid has been done for the construction of the bathroom and we hope to award it soon, the pavilion is scheduled to be installed soon. We have a company working on the south end of the park removing most of the trees in the area. Future plans call for a small lake, building equestrian facilities, and a horse trail. There are two acres of land in the middle of the park that have been set-aside as wetlands and must remain undisturbed. On the remaining land on the north end of the park there are plans to build some type of ball fields

for future use.

Also, we have been able to make a lot of improvements to the land around Town Hall. Staff has planted new foliage around the premises, built a horse stall, installed new flag poles, laid all the dedicatory bricks around the flag pole, installed benches in memory of Charlie Lynn and Johnny Dollar, and planted a vegetable garden behind Town Hall. We also were able to have our emergency generator installed.

Our new Financial Administrator Martin Sherwood has made many improvements to our financial system and has received awards for the good work. I know there are other good things that have taken place, but those are just some that I can remember. Let's give thanks for what we have accomplished and continue to improve in the future. I want to wish everyone a Happy Holiday and a Happy New Year.

VOLUNTEER FIRE RESCUE HOSTING ANIMAL AWARENESS CLASS



EAGLE SCOUT PROJECT PROVIDES A NEEDED ELEMENT TO SATISFY GRANTS IN ROLLING OAKS PARK

Among the Town's goals for our parks and recreational spaces are two very important objectives: celebrating and sharing the rich history of our area and creating partnerships with other organizations for park development, maintenance and use.

One such partnership has been extremely successful: thanks to the scouts and leaders of our local Boy Scout Troop #224, Rolling Oaks Passive Open Space Park, Sunshine Ranches Equestrian Park, and Trailside Park, have all been improved through projects performed by the members as part of their Eagle Scout candidacies.

Most recently, the project completed by David Stamm installed educational signage

and a trash receptacle in the Rolling Oaks Park. These improvements make a wonderful focal point for the park – even better, the sign supplies a needed element in the Town's grant commitments for this park, providing acknowledgement and education regarding the area's archaeological history. Original artwork for the sign was drawn by Ashley Diehl of the Troop 224 family.

An Eagle Scout project takes many months of planning. Scouts navigate Southwest Ranches' civic pro-

cess by reporting to Advisory Boards and the Town Council for support and approval. Through their projects, they demonstrate skills in research, design, communication, construction, financial planning, fundraising, leadership, and professionalism.

It is a pleasure to watch our children grow into fine young adults who understand the importance of giving back to their community, demonstrating skills that will serve them well in future endeavors. The

end results of such partnerships are the assets they provide for our parks.

We are truly grateful to David Stamm and the members and leaders of Troop #224 for dedicating this project to the benefit of Southwest Ranches!







HAPPY TRAILS ... TO SUNSHINE RANCHES EQUESTRIAN PARK : ANNOUNCING COMPLETION OF THE THOROUGHBRED LANE TRAIL ACCESS!

Completion of the Sunshine Ranches Equestrian Park in 2005 was the result of years of dedication, with many individuals and multiple agencies working together. Well received by residents and visitors, this undeniably lovely park has been our “go-to” location for Town events and has received much recognition and praise – even garnering an Emerald Award from Broward County in 2012.

Since the earliest planning stages, however, one elusive element has remained incomplete: trail access from Thoroughbred Lane.

As a link connecting the park with neighborhoods in the northeastern area of Town, a trail access at the south end of Thoroughbred Lane was intended to provide walkers and riders with a safer, more convenient route to the park than what exists on Stirling Road. (As one of only two connections to the Volunteer Road trail—West Palomino being the other—from the north, Stirling Road represented a far less desirable route due to busy intersections, deep canal, and little rideable area. Thus, riders have been

forced to use alternate routes to connect to the Volunteer Trail for access into the park.

Through years of planning and effort, staff has worked to provide trail access into the park from Thoroughbred Lane. Grant funding from the Florida Recreation Development Assistance Program provided a beautiful gate in 2008, but because the park abuts private property, adjacent parcel owners' permission was necessary. Through the years, permission has been sought but never granted by various owners of the property.


In 2013, Mr. and Mrs. Vern and Marie Nix agreed to provide the privilege of access over their private land under a special Agreement. We now proudly and gratefully announce that the park's Northeast Entrance is open for use by pedestrians and equestrians!

We owe a debt of gratitude to these neighbors and friends for supporting the Town's needs and providing access through their property. It is important to note that the land is still privately-owned. Therefore, as trail users, it is in our best interests to use the access re-

sponsibly. Please follow these tips to ensure continued use of the trail access:

- Trail access is for equestrians/ pedestrian use only.
- No parking or vehicular access of any sort from Thoroughbred Lane. (Vehicles must access the park via the main entrance at 5840 Volunteer Road—violators may be towed.)
- Animals must be under control at all times.
- Be considerate: do not litter.
- Please use the trail responsibly. Ride in at a walk.
- No animals may be tied to trail access fencing or left unattended on the trail access for any reason.
- Daily opening / closing is the responsibility of the Town. If the gate is closed, please do not disturb the residents!

Citizens Police Academy Class

The Davie Police Department will be hosting its 40th Civilian Police Academy starting February 18, 2014. The Citizens' Police Academy (CPA) is an informative learning process that provides an opportunity for citizens to receive 11 weeks of both classroom and field instruction regarding the various responsibilities facing our officers. CPA attendees are also made aware of the procedures and techniques used by officers when handling different situations.

Class attendees receive information and instruction on topics such as use of force, defensive tactics, narcotics enforcement, special operations, criminal investigations, crime lab and evidence gathering techniques, and much more. The CPA also incorporates scenario-based demonstrations from the Special Response Team, Dive Team, K-9 Unit, and Traffic Unit. All of this is enhanced by the CPA attendee's opportunity to ride along with a Patrol Services officer in the field.

Class size is limited to no more than 25 attendees and the class fills up quickly. Classes begin on Tuesday, February 18, 2013 and ends Tuesday, April 29, 2013. Class hours are from 7pm to 10pm (TUESDAYS ONLY). All classes will be held at the Davie Police Department located at 1230 South Nob Hill Road. The Civilian Police Academy is open to anyone who lives or works in Davie or Southwest Ranches. There will be a \$25.00 fee for attending this class. Refreshments will be provided.
