Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor McKay at 7:02 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

The following motion was made by Council Member Schroeder, seconded by Council Member Breitkreuz, and passed by a 4-0 roll call vote. The vote was as follows: Council Members Breitkreuz, Schroeder, Vice Mayor Fisikelli, and Mayor McKay voting Yes.

5. Council Member Comments

Responding to comments made during Public Comments, Council Member Schroeder thanked Newell Hollingsworth for his service on the Comprehensive Planning Advisory Board and felt taking responsibility for his actions and stepping down as Chair were admirable.

Council Member Breitkreuz advised that he did hear back from Broward County regarding the request made during a previous Council Meeting regarding the synchronization of traffic signals on Griffin Road. Broward County Traffic advised that it was difficult to do as some of the traffic is north south traffic which they do not want to negatively impact. He addressed resident input that was made during the Sunshine Ranches HOA meeting the night before regarding the service provided by WastePro. He advised that he wished to have Council discussion on this matter at a future meeting. Lastly, he indicated that mosquito dunks were available for residents here at Town Hall.

Mayor McKay thanked residents in attendance for coming to the meeting.

6. Legal Comments

Town Attorney Poliakoff advised that he had been in court several times recently regarding Waste Management and Bergeron's lawsuit. He advised that even though the Town was not a party to this lawsuit both parties are trying to determine why the Town made provisions to change its service provider to WastePro. Mayor McKay asked when the Town might be headed to trial with CCA. Town Attorney Poliakoff indicated the earliest would be sometime during the first quarter next year.

7. Administration Comments

Town Administrator Berns referred to a memo he distributed to the Town Council that documented swale damage throughout the Town. He felt that Council input was needed and wondered discussion during a meeting or a workshop was warranted. Council direction was to have a discussion item on this matter at a regular meeting in July. Lastly, he indicated that Toll Brothers, the developers of Rolling Oaks Estates was requesting a modification of their landscaping plan to enhance the development. He pledged to provide the Town Council a summary of what the changes requested were.
