RESOLUTION NO. 2019-046

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, APPROVING A PURCHASE ORDER IN THE AMOUNT OF NINE THOUSAND THREE HUNDRED AND FIFTY DOLLARS AND ZERO CENTS (\$9,350.00) WITH DYKES CUSTOM BARNS AND FENCING TO REMOVE AND REPLACE THE EXISTING FENCE AT THE COUNTRY ESTATES FISHING HOLE PARK; AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR, AND TOWN ATTORNEY TO ENTER INTO A PURCHASE ORDER; APPROVING A BUDGET AMENDMENT TO THE FISCAL YEAR 2018/2019 BUDGET FOR THE COUNTRY ESTATES PARK PERIMETER FENCING IMPROVEMENT PROJECT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the existing high-security fence at Country Estates Fishing Hole Park was installed prior to the Town's acquisition of the property; and

WHEREAS, the Town has developed park improvements including a picnic area, open space field, and playground at this park; and

WHEREAS, improvement of the park's appearance along Griffin Road by removal of the damaged existing security fence and replacement with fencing more suitable to recreational purposes is appropriate at this time; and

WHEREAS, the Town budgeted Ten Thousand, Seven Hundred Dollars and Zero Cents (\$10,700.00) for the Country Estates Park Perimeter Fencing Improvement Project in Fiscal Year 2017/2018 and was retained within the Capital Projects Fund Assigned Fund Balance; and

WHEREAS, proposals received in response to the Town's request significantly exceeded the budgeted amount in Fiscal Year 2017/2018 and the funding was retained in the Capital Projects Fund; and

WHEREAS, in Fiscal Year 2018/2019; the Town reviewed and revised the project specifications, modifying the type of fencing to achieve greater affordability as well as safety for users of the playground adjacent to the fence location; and

WHEREAS, the Town received four (4) proposals for this project, from Ace Fence Co. in the amount of Fourteen Thousand, Two Hundred and Seventy-Two Dollars and Zero Cents (\$14,272.00), All Pro Fence Builders in the amount of Thirteen Thousand, Seven Hundred Dollars and Zero Cents (\$13,700.00), Samada Fence, Inc. in the amount of Eleven Thousand, One Hundred and Thirty Dollars and Zero Cents (\$11,130.00), and Dykes Custom Barns and Fencing in the amount of Ten Thousand, Five Hundred and Fifty Dollars and Zero Cents (\$10,550.00); and

WHEREAS, after reviewing the proposals, it was determined that Dykes Custom Barns and Fencing submitted the lowest responsive and responsible proposal meeting the specifications for the project; and

WHEREAS, at the July 25, 2019 Town Council Meeting, the Town Council was provided several options to complete the fencing project; and

WHEREAS, the Town Council selected Option, which authorized the purchase and installation of 620 lineal feet of 6-foot, 9-gauge fencing from Dykes Custom Barns with the utilization of volunteers to remove the existing fencing; and

WHEREAS, the Town of Southwest Ranches desires to enter into a purchase order with Dykes Custom Barns and Fencing under the terms and conditions set forth hereinafter.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA:

Section 1. The above-referenced recitals are true and correct and are incorporated herein by reference.

Section 2. The Town Council hereby approves a purchase order in the amount of Nine Thousand, Three Hundred and Fifty Dollars and Zero Cents (\$9,350.00) with Dykes Custom Barns and Fencing to complete the Country Estates Fishing Hole Park Griffin Road fence removal and replacement project, in accordance with their proposal attached hereto as Exhibit "A", which is incorporated herein by reference.

Section 3. The Town Council hereby authorizes the Mayor, Town Administrator and Town Attorney, to enter into a purchase order with Dykes Custom Barns and Fencing in substantially the same form as that attached hereto as Exhibit "A" and to make such modification, additions and or deletions which they deem necessary and proper to effectuate the intent of this Resolution.

Section 4. The Town Council hereby approves the necessary budget amendment for the Country Estates Park Perimeter Fencing Improvement project as follows: increasing Capital Projects Fund – Infrastructure – Country Estates Fishing Hole Park expenditure account (301-5300-572-63200) in the amount of Nine Thousand, Three Hundred and Fifty Dollars and Zero Cents (\$9,350.00).

Section 5. This Resolution shall take effect immediately upon its adoption.

COUNTRY ESTATES PARK

Fencing Options
July 25, 2019

All options within this presentation refer only to the portion of the park fronting Griffin Road.

Option 1

- Award contract as originally proposed at the June 27, 2019 Council meeting.
- This was procured in accordance with the Town's Procurement Code.
- Specifications include 5' black vinyl coated fencing, 9-gauge wire and commercial hardware.
- Quoted cost of \$10,500. for removal of existing fence, disposal, and installation of new material.

Option 2

- Utilize 310' of Town-owned 6' 11.5-gauge galvanized fencing (previous cost \$3,200.)
- This will allow approximately one half of the Griffin Road frontage to be replaced.
- Removal of existing barbed wire, 310' of Town-owned fencing and new installation to be performed by volunteers.
- Not vinyl coated
- Additional material cost would be minimal, disposal costs TBD.

Option 3

- Purchase all new 620' of vinyl coated fencing.
- Cost of 6' 9-gauge fencing +/- \$3,700*.
- This does not include labor to remove existing fencing and disposal costs.
- Costs used are NTE, subject to proper procurement procedures.
- Volunteers to remove old fencing.
- Professional installation of new fencing \$5,650 (+ \$3,700* = \$9,350)
